



## 2024 Breeding Contract

This certifies \_\_\_\_\_, hereafter referred to as mare owner, has engaged in one service to **Just Good Vibes**, APHA # 1087415/AQHA #6053903. The Wright and Schmidt Partnership, herein referred to as breeder, for the following mare(s) for the 2024 breeding season at **\$1,250(USD)**. The breeding season shall begin on February 15th and close on June 5th of the year covered by this contract.

1. A booking fee of \$500.00 is payable with this contract and the balance of \$750 plus all unpaid expenses (**including collection/shipping fee of \$375**) will be payable prior to the shipment of semen. The booking fee is non-refundable.
2. The Mare Owner shall agree that the mare offered for breeding shall be in sound breeding condition and free from infection or disease. Any mare certified by the attending veterinarian not to be, in his opinion, in sound breeding condition, shall not be bred. It is the Mare Owner's responsibility to verify the health and breeding soundness of the mare. It is further agreed that should the above named mare dies prior to foaling, the Mare Owner may substitute another mare to be used in the following breeding season only, if it is agreed to by both the Mare Owner and Breeder.
3. *Live Foal Guarantee:* Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a rebreed will be guaranteed the following year only, providing the proper notification is given. Proper notification shall be defined as follows: written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. The Mare Owner certifies that such abortion or death did not result from any act or omission of the Mare Owner. The **rebreed in this case is free** but a **collection/shipping fee of \$375** is due prior to rebreeding for LFG or if said mare did not get in foal from the previous years breeding efforts.
4. *APHA Regular Registry Guarantee:* This means the resulting foal will receive APHA regular registry papers. A rebreed in this case will be guaranteed the following year only, providing proper notification is given by December 15th of the breeding year this contract covers. If the foal does not receive regular registry papers per the APHA rule book, then a **rebreed in this case is free** but a **collection/shipping fee of \$375** is due prior to rebreeding.

5. When the above named Mare Owner signs and returns one copy of this contract to the Breeder it will then be a binding contract on both parties subject to the terms and conditions. **This contract is not valid unless completed in full and accompanied by a copy of the mare's registration papers.**
