This certifies _____, hereafter referred to as mare owner, has engaged in one service to **Just Good Vibes**, APHA # 1087415/AQHA #6053903. Dare To Dream Performance Horses, herein referred to as breeder, for the following mare(s) for the 2025 breeding season at **\$1,250(USD)**. The breeding season shall begin on February 3rd and close on June 30th of the year covered by this contract.

1. A booking fee of \$500.00 is payable with this contract and the balance of \$750 plus all unpaid expenses (**including collection - \$275/shipping fee - \$actual**) will be payable prior to the shipment of semen. The booking fee is non-refundable.
2. The Mare Owner agrees that the mare offered for breeding shall be in sound breeding condition and free from infection or disease. Any mare certified by the attending veterinarian not to be, in his opinion, in sound breeding condition, shall not be bred. It is the Mare Owner's responsibility to verify the health and breeding soundness of the mare. It is further agreed that should the above named mare dies prior to foaling, the Mare Owner may substitute another mare to be used in the following breeding season only, if it is agreed to by both the Mare Owner and Breeder.
3. *Live Foal Guarantee:* Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a rebreed will be guaranteed the following year only, providing the proper notification is given. Proper notification shall be defined as follows: written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. The Mare Owner certifies that such abortion or death did not result from any act or omission of the Mare Owner. The **rebreed in this case is free** but a **collection - \$275/shipping fee - \$actual** is due prior to rebreeding for LFG or if said mare did not get in foal from the previous years breeding efforts. If a live foal is **not produced the following year of the original contract, the mare owner may breed again but will be required to pay the \$500 booking fee** as well as the collection - \$275/shipping fee - \$actual.
4. When the above named Mare Owner signs and returns one copy of this contract to the Breeder it will then be a binding contract on both parties subject to the terms

and conditions. **This contract is not valid unless completed in full and accompanied by a copy of the mare's registration papers.**

5. ***Changes/Corrections/Late adds to the AQHA and APHA Breeding Reports will result in a \$50.*** If you do not provide the correct information or do not get your mares information to us at the time the Breeding Reports are filed and require them to be updated with your information, this will result in a \$50 fee. This is the fee that the associations charge to update/change any breeding reports.
