### OPEN DOOR CLINIC FUTURE REMAINS IN LIMBO

(Editor's Note: Technically the Open Door Clinic isn't part of First Presbyterian church despite having occupied the lower level of our church for many years but they are very much a part of our lives and we care deeply about them.)

Most of the people who work at the Open Door Clinic are volunteers. That includes doctors, nurses and technicians who come from all around the Chippewa Valley and donate their time.

The one exception is the clinic coordinator, Kim Renaud. She is actually an employee of HSHS and as such runs the chance of losing her job at the end of April. Kim has been in contact with HSHS following their announcement to move up their closing date to March 22 and they have assured her that she will continued to be employed until the end of April.

Kim schedules the volunteers for their shift at the clinic as well as ordering supplies and equipment. Without her and what she does, there would be no clinic.

While Kim is technically an employee of HSHS, they handle all the employee-related paperwork and bill the clinic board for her salary.

The clinic board has contacted both Chippewa County and Mayo about employing Kim. The county said it would take them several months to process the clinic proposal but Mayo is moving much faster and things look hopeful for them to take Kim on as an employee. At this point, the clinic proposal is in the hands of the Mayo HR and legal departments for review and Kim receives weekly updates on their progress.

In addition to employing Kim, the local hospitals have been performing blood tests for the clinic as necessary. Although the clinic has technicians to take the blood samples, they lack the facilities to perform the needed tests. In the past that testing has been done on a rotating basis by Mayo, St. Joseph's Hospital and Marshfield Clinic in Chippewa Falls. That work will now be alternatingly by Mayo and Marshfield Clinic.

The clinic purchases supplies and medications from various outside suppliers so that isn't an issue.

Six months ago the clinic averaged three to four patients a week. Their workload has increased to between five and six patients with more people coming in every week.

Kim expresses her gratitude to the congregations and friends of FPC for their continued support and prayers.

## CARR LOOKS TO RETURN TO CHIPPEWA FALLS

Several years ago First Presbyterian Church was approached by the Lutheran Social Services of Wisconsin and Upper Michigan (which operated as Chippewa Area Recovery Resource – CARR) about providing space in our basement for them to hold meetings for their clients.

CARR does substance abuse and mental health counseling and with the closure of L. E. Phillips Libertas, there is no other resource in the Chippewa Falls area to do that type of work.

At that time Session approved the use of space in our church but we were unable to reach an agreement with CARR due to scheduling and facilities conflicts, however, CARR has once again reached out to us about providing space for their work.

Discussions are in the very early stages but we have the space and they have the need. Watch your Bell for more information.

#### **BEWARE APRIL 1**

Some historians speculate that April Fools' Day dates back to 1582, when France switched from the Julian calendar to the Gregorian calendar, as called for by the Council of Trent in 1563. In the Julian Calendar the new year began with the spring equinox around April 1.

People who were slow to get the news or failed to recognize that the start of the new year had moved to January 1 and continued to celebrate it during the last week of March through April 1 became the butt of jokes and hoaxes and were called "April fools."

There's also speculation that April Fools' Day was tied to the vernal equinox, or first day of spring in the Northern Hemisphere, when Mother Nature fooled people with changing, unpredictable weather. (Editor's Note: They must have lived in Wisconsin.)

In modern times, people have gone to great lengths to create elaborate April Fools' Day hoaxes. Newspapers, radio and TV stations and websites have participated in the April 1 tradition of reporting outrageous fictional claims that have fooled their audiences.

In 1992, National Public Radio ran a spot with former President Richard Nixon saying he was running for president again... only it was an actor, not Nixon, and the segment was all an April Fools' Day prank that caught the country by surprise.

In 1996, Taco Bell, the fast-food restaurant chain, duped people when it announced it had agreed to purchase Philadelphia's Liberty Bell\_and intended to rename it the Taco Liberty Bell.

In 1998, after Burger King advertised a "Left-Handed Whopper," scores of clueless customers requested the fake sandwich.

Google notoriously hosts an annual April Fools' Day prank that has included everything from "telepathic search" to the ability to play Pac Man on Google Maps.

In March 2020, during the COVID-19 pandemic, various organizations and people cancelled their April Fools' Day celebrations, or advocated against observing April Fools' Day, as a mark of respect due to the large amount of tragic deaths that COVID-19 had caused up to that point, the wish to provide truthful information to counter the misinformation about the virus, and to pre-empt any attempts to incorporate the virus into any potential pranks. For example, Google decided not to continue "its infamous April Fools' jokes" tradition for that year. Because the pandemic was still ongoing a year later in 2021, they also decided not to do pranks that year.

The question is - will you be fooled this year?
