Responsibilities:

- Provides daily care and supervision of Faithful Hearts Homecare LLC clients primarily in their home environment.

- Plans and participates in activities with the clients as outlined in their care plan.
- Completes in-service hours annually as required by state regulations.

- Adheres to Nebraska State Regulations/Administrative Rules relating to in-home care.
- Completes and/or assures completion of necessary documentation and reports by the end of the client visit.

**Training:**

Education and Experience:

- High School Diploma or equivalent
- Must be 19 years of age or older
- Applicable Home care or related experience
- Ability to communicate via e-mail
- A passion for caring for others!

Physical Requirements:

Ability to perform duties as outlined below

- lifting 25-50 lbs.
- Ability to stand and walk during shift
- Ability to crouch or bend down for a short period of time during shift
- Will occasionally encounter toxic chemicals or biohazards during your shift; follow OSHA and local regulations when cleaning an area and carefully removing clients from unsafe environments
- Must pass pre-employment physical and physical ability test prior to employment at an approved on-site location chosen and paid for by FHH LLC. This includes drug testing.

Other Requirements:

- Your own smart phone capable of downloading caregiver and payroll apps, texting, and making and receiving calls
- Your own car: some clients require transportation (Mileage will be reimbursed)
- All applicants must have a current Nebraska driver's license
- proof of current car insurance
- pass all background checks
- Be authorized to work in the United States
