**PAYMENT SCHEDULE**

Program fees are payable in two installments.

1. The first 50% of a swimmer’s program fee plus the full registration fee (\$25) are due at time of registration.
2. The balance of the swimmer’s program fee is due by October 30, 2018.

Alternative payment arrangements require board approval. Installment fees may apply.

Accounts with unpaid balances after the October 30, 2018 due date are subject to late fees.

**REFUND POLICY**

Program fees may be refundable if a swimmer withdraws from the program prior to October 31, 2018.

Withdrawal from the program requires a written request submitted to the Board prior to October 31, 2018.

**NO REFUNDS WILL BE GIVEN AFTER OCTOBER 31, 2018**

Refundable participation fees will be refunded based on written withdrawal on a pro-rata basis.

Participants will be automatically withdrawn if payments are not made within 2 weeks of due date.

**TIMING POLICY**

The Yankee League in which Wildcat Swim Club competes requires each team to provide six timers plus a backup timer at each and every meet. Swim families are expected to learn how to time and to provide timers at a minimum of two events. Exceptions must be requested in writing and approved by the Board. Wildcat Swim Club may impose a penalty for failure to provide the requisite timing support.

**SWIMMERS**

Swimmers must come to practice in a one piece bathing suit.

All swimmers should wear a swimming cap, unless they have very short hair.

Swimmers are NOT allowed on the pool deck until a certified life guard coach arrives and instructs the swimmers to enter the water.

**ACCEPTENCE OF TERMS AND CONDITIONS AND RELEASE**

By signing this form, I acknowledge and accept the following:

1. I agree to pay all fees by the published due date.
2. I understand that any concerns I have regarding my child’s training should be first brought to the attention of the head coach. When necessary, issues are then to be escalated to the Board of Directors.
3. I understand that email is the main avenue of communication between the Wildcat Swim Club and its swimmers. I have provided an email address with the understanding that I will check the email often for updates regarding the club. In the event that I am unable to provide an email address, I understand it is my responsibility to check the team website, team bulletin board, and with other team members for updated information.
4. I agree to purchase a team suit and I understand and agree that my child is required to wear his/her team suit during all swim meets. Required team caps are included with Program Fees.
5. I understand that I will be required to time at any Yankee meets and at dual meets in which my child participates.
