- Responding to all hazard emergency incidents as a crew leader.
- Assuming command of some incidents. Ordering and managing resources.
- Responsible for the general efficiency of all assigned personnel.
- Assures adherence to established safety standards for daily operations.
- Participates with the Officer Group in the coordination and implementation of training.
- Responds to emergency incidents following agency policies.
- Prepares a variety of reports and records.
- Supervise and perform daily checks of apparatus, equipment, and facilities.
- Monitor activities to ensure conduct conforms to department standards.
- Assist with Fire Prevention programs.
- In-service training of personnel.
- Carry out orders and assignments from supervisors.
- Manage the decontamination program.
- Lead Firefighters and EMS personnel on incidents effectively while maintaining discipline.
- Develop fire pre-plans.
- Educates the public in fire prevention and life safety methods.
