ORDINANCE NO. 2026-03

AN ORDINANCE OF THE TOWNSHIP OF POINT, COUNTY OF NORTHUMBERLAND, COMMONWEALTH OF PENNSYLVANIA AMENDING THE TOWNSHIP'S DRIVEWAY ORDINANCE (ORDINANCE 2017-01) TO ALLOW THE USE OF CONCRETE PAVEMENT FOR CERTAIN DRIVEWAYS IN THE TOWNSHIP.

BE IT ENACTED AND ORDAINED by the Board of Supervisors in and for the Township of Point, Northumberland County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

1. Section 7, Subsection F of Point Township Ordinance 2017-01 is hereby replaced, in its entirety, with the following:

F. Paving

All Driveways that have access onto a Public Road with an asphalt or bituminous seal coat surface shall be paved with asphalt or concrete from the edge of the Roadway a minimum distance of fifteen (15) feet toward the lot. All materials used for the construction of a Driveway shall comply with PennDOT Publication 408 (as amended from time to time), and its successor(s). The Owner shall submit the Driveway pavement design to the Township for review by the Board of Supervisors, and/or their duly authorized representative(s).

2. SEVERABILITY

If any sentence, clause, phrase, or section of this Ordinance is, for any reason, found to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, phrases, sections, or parts of this Ordinance. It is hereby declared as the intention of the Board of Supervisors that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, phrase, section, or part thereof not been included therein.

3. REPEALER

Any other Ordinance or parts thereof inconsistent with this Ordinance shall be and are hereby expressly repealed.

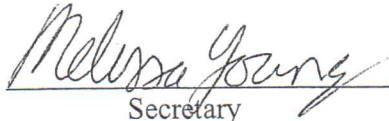
4. EFFECTIVE DATE

This Ordinance shall become effective immediately upon its enactment.

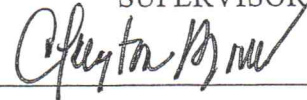

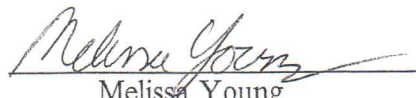
