POINT TOWNSHIP SUPERVISORS REGULAR SUPERVISORS MEETING TUESDAY, JUNE 11, 2024

The Point Township Board of Supervisors held their regularly scheduled meeting on the above date at the Point Township Municipal Building, 759 Ridge Road, Northumberland, PA. Present were: Chairman Randall W. Yoxheimer, Vice-Chairman Thomas Strouse, Jr., Supervisor Montie Peters, Supervisor Joseph Stender, Jr. and Supervisor Clay Rowe. Chairman Yoxheimer welcomed everyone to the Supervisors meeting and all present repeated the Pledge of Allegiance. Approval of Minutes:

MOTION made by Peters to approve the minutes of the Regular Supervisors Meeting held on Tuesday, May 14, 2024. Seconded by Stender, Jr. and passed unanimously.

REPORTS: (Old & New Business included):

Solicitor:

- <u>Reapproval of ASA (Agricultural Security Area)</u>: this was a requirement for the 7-year review. Letters were sent out to all of those that had already been included in ASA, and we went a step further and sent letters to those that may be eligible and interested in being added. This was established by the state back in the late 80's.

Yoxheimer this hearing was open to the public, but no one is here for this.

Strouse, **Jr.** this protects the landowner/farmer without repercussions from dust, smell, working late and from nuisance lawsuits.

MOTION made by Peters to approve Resolution 2024-03 for the Agricultural Security Area with the additional of the 8 parcels as discussed during the hearing. Seconded by Rowe and passed unanimously.

- <u>Opening the Asphalt Road Project Bids</u>: we got 2 bids in. One from Russell Standard for a total of \$109,798.60 and the other one from Midland for a total of \$135,929.44.

Wehry this is for Libeck, Valley View, Sycamore and Neitz Road.

MOTION made by Peters to accept the low bid from Russell Standard in the amount of \$109,798.60. Seconded by Rowe and passed unanimously.

- <u>Hiring a Road Crewman</u>: interviewed 3 candidates, after checking references we are going to hold off on offering a position to any of those 3 candidates. Just got a resume from someone, will check out and let the Supervisors know if they are a good candidate. Another possibility is looking for someone just for the summer if we can't find someone full-time.
- <u>Chevy Brakes</u>: the chevy needs new brakes and rotors, after checking with NorthPoint and Yocum's and getting prices between \$1,200 to \$1,500, Linvestigated purchasing the materials needed and doing it myself at a cost of approximately \$500 for what is needed.

MOTION made by Yoxheimer to allow the Roadmaster to purchase the necessary items to change the brakes and rotors on the Chevy truck. Seconded by Peters and passed unanimously.

Wehry PennDOT is doing bore samples to look into reconstructing Ridge Road, and I was just notified yesterday that PennDOT will working on Ridge Road, they are going to mill from the Township building down to almost Mirkwood, and then seal coat all of Ridge Road this year. When I was at the PennDOT municipal outreach, there goal is to get 3-foot shoulders. They are not looking at widening the travel lanes, just the shoulders.

Discussion ensued about revisiting PennDOT taking the house on Ridge Road near Spruce Hollow. **Yoxheimer** get back in touch with Todd about fixing the pipe at Cannery and Gibbons since we had another truck damage the guard rail there.

Unidentified Resident asked about plans for Ridge Road.

Yoxheimer long standing plans for Ridge Road due to the CSVT to widen the road. (explained process) (Discussion ensued)

Yoxheimer talk to John Derr and see how he wants to handle the situation.

Wehry we would be able to go out first thing in the morning, at 6AM, since we cannot start running equipment until 7AM.

Yoxheimer NNB to do a \$500,000 loan for Route 11 force main from about Viking Energy into the Borough. Sewer has the money and could probably afford it, but we don't want to draw the reserve down too far.
