#### Meeting 25-18

Ms. Pae come in regarding a ticket she received. She is a resident who has been parking for 8 years. She scratched her fee and when she closed the door she didn't realize the fee fell over. This is the first time she has ever received a ticket. The Board reviewed and since she did have the fee and never received a ticket, they will void the ticket.

#### 4. Jon Sclazo

Mr. Scalzo come in regarding a ticket he received. He is a resident who has been paying to park using the Flowbird app. He was running for the train and used the app but didn't realize the transaction didn't complete. This is the first time he has ever received a ticket. The Board reviewed and since he has never received a ticket, they will void the ticket as a onetime grace.

#### 5. Merchant Stickers Files

We will need to purchase Merchant stickers for the next 2 years. Although we are going digital for resident permit, the merchant permit structure is more complex, and will take more time to develop. In the meantime, we will continue to use stickers. The following was proposed:

WHEREAS, Rydin Decal, came in with the lowest price,

THEN THEREFORE, it is resolved we will purchase the merchant stickers, not to exceed \$1,500.

There are a few bare branches and he asked the MPD if we would be willing to trim the tree. At this time, the Board does not see the tree as any danger to our lot, and will not trim the tree.

#### 8. New World Associates

Robert Green from New World Associates provided an alternate Medical Insurance Policy. The Board is not willing to consider getting rid of NYSHIP.
