Meeting 21-14 Special Budget

A special budget meeting of the Board of Commissioners of the Manhasset Park District (MPD) convened at the Manhasset Park District Office at 62 Manhasset Avenue in Manhasset, New York at 5:00 P.M. Thursday, September 9, 2021. Present were Commissioners Mark S. Sauvigne, David Paterson and Kenneth Weigand. In addition, Robert Morici & Paul Pepper, MPD Legal Consul, Sharon Glassman, Town of North Hempstead Employee to oversee budget hearing, and Amanda Niewender, Secretary to the Board were also present.

Motion was made by David Paterson, Chairman, to open the Public Hearing, motion seconded by Commissioner Sauvigne and all voted "aye."

Commissioner Paterson asked if any members of the Board wished to be heard.

Commissioner Sauvigne stated the Commissioners have reviewed and discussed the budget and have no more questions

Commissioner Weigand asked if any members of the public wished to be heard. There were no questions.

There was a discussion about how COVID impacted the current last years and the current year's budget and how the proposed budget is done conservatory based on the unknown commuter revenue. The MPD anticipate an increase in revenue, due to NYC opening, and people going back to work, but since a lot of companies are still having employees work from home rather than commuting into NYC, it is unknown how much revenue will increase.

It was further discussed the MPD did not go over the tax cap, but did use the carry over for taxes, which helps budget the revenue.

With no further questions, Commissioner Sauvigne, Treasurer made a motion to approve the proposed budget.

The following resolution was proposed: WHEREAS, the Manhasset Park District has prepared a proposed budget for the fiscal year January 1, 2022 through December 31, 2022 and,

WHEREAS, the Board of Commissioners have published a Public Notice of this hearing in the Manhasset Press and received acknowledgment of the notice, and,

WHEREAS, the Board of Commissioners have answered any public comment concerning the proposed budget, at the Public Hearing which was closed on September 9, 2021,

THEN THEREFORE, it is resolved, that the Board of Commissioners hereby approve the proposed budget as submitted and directs that the budget be forwarded to the Town of North Hempstead for appropriate action.

On a voice vote, this resolution was unanimously approved.

Motion was made by Kenneth Weigand, Secretary, to close the meeting, seconded by Commissioner Mark Sauvigne, and all voted "aye."
