REGULAR MEETING MARCH 22, 2021

Meeting 21-06

The bi-monthly regular meeting of the Board of Commissioners of the Manhasset Park District (MPD) convened at the Manhasset Park District Office at 62 Manhasset Avenue in Manhasset, New York at 5:00 P.M. Monday, March 22, 2021. Present were Commissioners Mark S. Sauvigne, David Paterson, and Kenneth Weigand. In addition, Robert Morici & Paul Pepper, MPD Legal Counsel, and Amanda Niewender, Secretary to the Board of Commissioners. The dial in information to call in was listed on the website.

Numerous communications addressed to the MPD pertaining to a wide array of matters were reviewed and discussed and eventually disposition was made to those, which warrant action.

2. Payment and Receipts

The following resolution was proposed:

BE IT RESOLVED, that the Board of Commissioners for the Manhasset Park District approved payments as follows:

22 checks numbered 9963 to 9984 totaling \$ \$57,301.51 to be reviewed, approved and signed, Payroll Amounts of \$22,236.61 & \$18,497.16 for Payrolls 3/11/2021 & 3/25/2021 and all totaling \$98,035.28.

On a voice vote, this resolution was unanimously approved.

3. Raindew

The owner of Raindew, Kevin, had reached out to the MPD regarding the tickets being written in Lot #4. The Commissioners discussed the regulations and the signage. If Raindew wants to put up additional signage for their patron, they can do so.

4. Elite Auto

The owner or Elite Auto, David, reached out regarding Merchant Parking to be used for his customer's vehicles on a rotation in Lot 3. The Commissioners are willing to allow a temporary permit issued to be used for multiple vehicles use in a leased Merchant Spot. David also inquired about renting out the lot on a weekend for a car show.

5. Work Hours

The Commissioners had decided to extend the work hours of operation, temporarily for the month of March. They discussed, and will continue this schedule for April.

6. Updates

Amanda updated the Commissioners on various items, including how the temporary schedule is working, how many tickets have been written, the financial status, the maintenance done, etc.
