REGULAR MEETING MARCH 26, 2024

Meeting 24-06

The bi-monthly regular meeting of the Board of Commissioners of the Manhasset Park District (MPD) convened at the Manhasset Park District Office at 62 Manhasset Avenue in Manhasset, New York at 6:15 P.M. Monday, March 26, 2024. Present were Commissioners Mark S. Sauvigne, David Paterson and Ken Weigand. In addition, Robert Morici & Paul Pepper, MPD Legal Counsel, Barbara, Joe & Aston LaPadula, MPD Residents, and Amanda Niewender, Secretary to the Board of Commissioner were also present.

Numerous communications addressed to the MPD pertaining to a wide array of matters were reviewed and discussed and eventually disposition was made to those, which warrant action.

1. Approval of Minutes from Previous Meeting

2. Payment and Receipts

The following resolution was proposed:

BE IT RESOLVED, that the Board of Commissioners for the Manhasset Park District approved payments as follows:

3. Incident in Lot

On March 5 an employee had an altercation with a HS student, resident. The student moved the barricades in the lot, and when he was told by our employee that they cannot move the barricades, the student yelled, cursed and berated our employee. The LaPadula's came to discuss the incident. Aston stated his side of the story. The Board will further discuss the incident.

4. 61 Locust

Amanda is almost completed with the FOIL request, Paul Pepper will review all docs before they are sent out. The hearing for the sale is April 9th at 10am at the TONH.

5. Parking Lot Use

The Manhasset Boys Lacrosse and Girls Lacrosse have submitted applications and insurance for a few dates to use the lot. The dates were approved by the Board.

The Manhasset Jr. Tower is requesting space in the lot to have food trucks at their Movie night, the Board approved the row of spaces along Memorial.

6. Truck #6 Tires

The following resolution is proposed:

WHEREAS, truck #6 needs 6 new tires

WHEREAS, Port Tire is on state bid, and a reasonable quote was obtained

THEN THEREFORE, it is resolved that the tires be purchased and installed by Port Tire but not to exceed \$1,750.

On a voice vote, this resolution was unanimously approved.

7. LIRR

Commissioner Paterson inquired about the LIRR workers parking in commuter spots. Code Enforcement will be advised to ticket any vehicle without the proper fees in commuter spaces.

8. 61 Locust

The sale of the property is up for approval by the TONH Board. The public hearing will be on April 9th.

9. Truck #6 Front Bumper Repair

The following resolution is proposed:

WHEREAS, truck #6 front bumper needs to be repaired

WHEREAS, 3 quotes were sought, and 2 companies came back with quotes

WHEREAS, Manhasset Collision came in with the lowest quote,

THEN THEREFORE, it is resolved that the repair be made by Manhasset Collision but not to exceed \$2,000.

On a voice vote, this resolution was unanimously approved.

10. Nonresident Extension

The Board reviewed the data from this month. Wednesdays are definitely the busiest day. There was only 1 day the lot filled up. They will extend the nonresidents through April.

11. Manhasset Collision

The Board has decided to continue to extend their agreement through April. A new agreement will be signed.

12. Patriots Park

Ralph notified the Board the flagpole is broken. He will make the necessary repairs to avoid replacing it. The Board discussed the pond area. They would like to come up with some ideas for redesigning it since the map has disintegrated and it is no longer a functional memorial pond.

13. Holiday

The Board has approved to extend the Independence Day holiday. The office will be closed July 5
