

**BOARD OF COMMISSIONERS**  
**MANHASSET PARK DISTRICT**  
**REGULAR MEETING SEPTEMBER 8, 2022**

Meeting 22-15

The bi-monthly regular meeting of the Board of Commissioners of the Manhasset Park District (MPD) convened at the Manhasset Park District Office at 62 Manhasset Avenue in Manhasset, New York at 5:30 P.M. Thursday, September 8, 2022. Present were Commissioners Mark S. Sauvigne, David Paterson and Kenneth Weigand. In addition, Gianni Scaduto, Manhasset resident, Robert Morici and Paul Pepper, MPD Legal Counsel and Amanda Niewender, Secretary to the Board of Commissioner were also present.

Numerous communications addressed to the MPD pertaining to a wide array of matters were reviewed and discussed and eventually disposition was made to those, which warrant action.

1. Approval of Minutes from Previous Meeting

2. Payment and Receipts

The following resolution was proposed:

BE IT RESOLVED, that the Board of Commissioners for the Manhasset Park District approved payments as follows:

On a voice vote, this resolution was unanimously approved.

3. 61 Locust Street

The proposed sale of the property will go before the TONH Board for approval at the Town Board meeting September 22, 2022.

Motion was made to enter into Executive Session by Mark Sauvigne, Motion seconded by Ken Weigand and all voted "aye" Executive Session started at 5:35 P.M. Motion was made to close Executive Session by Kenneth Weigand, motion seconded by Mark Sauvigne, all voted "aye" at 5:40 P.M.

4. FOIL Request

The Commissioners discussed the foil of tickets issued on Plandome Road from the TONH.

5. Incident in Lot #3

Commissioner Paterson was patrolling lot #3 and doing traffic control. There was a disagreement with a resident who would not move out of the roadway. The resident sent an email complaint. The Board reviewed the camera footage and will respond to the email.

6. Lot status

Amanda updated the Board that this past Wednesday Lot #1 and #3 filled up by 1045am. With the rain, school open, Wall Street back to work, and the US Open, it was

the busiest day. A resident came in at 11am to complain that there were no spots, and was directed to 61 Locust but made an argument. The Commissioners request next week Code Enforcement to count the cars, resident vs. nonresident to see that status after the US Open has finished.

7. Truck Updates

Ralph is looking for prices for a new truck. He obtained one estimate. A lot of dealers do not have trucks, and do not know when they will be back in stock. The Board will review.

He provided the Board with his monthly and the receipt showing he purchased it before the ticket was issued. The Board reviewed. The ticket was not sent into NCTPVA yet, and this was Mr. Scaduto's first offense. The Board approved to VOID the ticket before being sent to NCTPVA.

Having no other items on the agenda, Motion was made by Kenneth Weigand to adjourn the meeting. Motion seconded by David Paterson and all voted "aye".
