

**BOARD OF COMMISSIONERS**  
**MANHASSET PARK DISTRICT**  
**REGULAR MEETING OCTOBER 28, 2025**

Meeting 25-19

The bi-monthly regular meeting of the Board of Commissioners of the Manhasset Park District (MPD) convened at the Manhasset Park District Office at 62 Manhasset Avenue in Manhasset, New York at 6:00 P.M. Monday, October 28, 2025. Present were Commissioners Mark Sauvigne, David Paterson and Kenneth Weigand. In addition, Winnie Lee, MPD resident, Robert Morici and John Ryan, MPD Legal Counsel and Amanda Niewender, Secretary to the Board of Commissioner were also present.

Numerous communications addressed to the MPD pertaining to a wide array of matters were reviewed and discussed and eventually disposition was made to those, which warrant action.

1. Approval of Minutes from Previous Meeting

2. Payment and Receipts

The following resolution was proposed:

BE IT RESOLVED, that the Board of Commissioners for the Manhasset Park District approved payments as follows:

Checks numbered 11766-11775 approved and signed.

On a voice vote, this resolution was unanimously approved.

3. Parking Update

We have been counting the cars in lot #3 for September and October. Tuesday, Wednesday and Thursday are considerable full. But Monday is light, and Friday continues to be relatively empty. The Board discussed allowing the students to park on Fridays. The following was proposed:

WHEREAS, the MPD Ordinance, Section 4.02b, states *No Person shall park in the commuter parking field for the sole or exclusive purpose of using the commuter parking field as a substitute for parking at the Manhasset High School*

WHEREAS, due to the emergency measures taken in response to the pandemic in 2020, the MPD commuter parking lots have vastly changed in usage,

WHEREAS, Manhasset High School's limited parking remains unable to accommodate students driving to school and the discouragement of close contact between students of differing households has limited the availability of 'carpools', exacerbating the situation;

WHEREAS, the MPD had suspended enforcement of Section 4.02b from September 2020, thru May 2025, but ended due to the return of commuter parking,

WHEREAS, Monday and Friday continues to remain light for commuter parking,

THEN THEREFORE BE IT RESOLVED, that enforcement of Section 4.02b of

the MPD Ordinance shall be temporarily suspended on MONDAYS & FRIDAYS only, thereby allowing vehicles to use MPD Lot #3 for substitute parking for Manhasset High School, subject to all other rules and regulations of the MPD and its Ordinance, including payment of the daily parking fee.

BE IT FURTHER RESOLVED that such vehicles that wish to use MPD Lot #3 as substitute Parking for Manhasset High School, which are eligible to receive a "resident permit", will be required to obtain said permit and pay the daily \$4 parking fee.

BE IT FURTHER RESOLVED, the temporary suspension of enforcement described herein, will remain in effect through October 2025, when it will be reevaluated again.

On a voice vote, this resolution was unanimously approved.

4. Digital Scanning

The company contacted us that the original estimate didn't cover the total amount of boxes they picked up. To complete the project, there are still 20 boxes left and would cost \$12,500. The Board discussed, but decided they do not want to spend any more funds towards this project. We will pick up the remaining boxes and keep them stored. Maybe at a future date, we will scan them ourselves.

5. EV Chargers Agreement

The agreement has been back and forth, and the Board will review the changes. At this time, they are reconsidering whether they will proceed forward.

6. Winnie Lee

Ms. Lee came because she received a ticket for no fee. She has an annual, and didn't realize it fell off of her rearview mirror. She presented the annual, and has never received a ticket before. The Board discussed and decided to void her ticket.

7. Next month's meetings

The meetings for next month will be November 10 and November 24.

8. Holidays

The upcoming holidays were discussed. The following was proposed:

WHEREAS, employees have paid holidays off for December 25 and January 1,

WHEREAS, this year, those holidays land on a Thursday,

WHEREAS, the Board discussed closing the office on the following Fridays,

THEN THEREFORE, BE IT RESOLVED, for this year only, the office will be closed for December 26, and January 2.

On a voice vote, this resolution was unanimously approved.

9. Updates

The Board will attend the Budget hearing tonight at Town Hall at 7pm. Amanda updated the Board regarding the Patriots Park project, the Park Avenue Sprinkler estimates, and various employee vacations. The Board also discussed updating the Christmas tree at 4 Acres, and potentially adding electric there.

Having no other items on the agenda, Motion was made by Kenneth Weigand to adjourn the meeting. Motion seconded by Mark Sauvigne and all voted "aye".
