MANHASSET PARK DISTRICT
REGULAR MEETING FEBRUARY 24, 2025

Meeting 25-04

The bi-monthly regular meeting of the Board of Commissioners of the Manhasset Park District (MPD) convened at the Manhasset Park District Office at 62 Manhasset Avenue in Manhasset, New York at 6:15 P.M. Monday, February 24, 2025. Present were Commissioners Mark Sauvigne, David Paterson and Kenneth Weigand. In addition, Chris Wang, Ya Wang, Wesley Setu, ByungYong Kim MPD residents, Robert Morici MPD Legal Counsel and Amanda Niewender, Secretary to the Board of Commissioner were also present.

Numerous communications addressed to the MPD pertaining to a wide array of matters were reviewed and discussed and eventually disposition was made to those, which warrant action.

1. Approval of Minutes from Previous Meeting

2. Payment and Receipts

The following resolution was proposed:

3. Chris Wang

Ms. Wang came in regarding 2 tickets she received. She is a new resident to Manhasset. The tickets are for parking without a permit, and for parking without a fee. She lives very close and typically walks. She drove one day due to the weather and didn't know the regulations. She looked for a meter but didn't see it. The Board discussed and reviewed and agreed to void one of her tickets, as a one time grace and requested she obtain a permit since she is eligible to avoid any further issues/tickets in the future.

4. Ya Wang

Ms. Wang came in regarding a ticket she received. She is a new resident to Manhasset. She obtained a permit already, but usually only parks on the weekend (for free). With the school break, she took her kids into the city on a weekday and didn't pay the fee. The Board discussed and reviewed and agreed to void her ticket, as a one time grace and made sure she understands the regulations for weekdays.

5. Wesley Sefu

Mr. Sefu came in regarding a ticket he received. He is a nonresident, and parks frequently in the lot. He parked in a nonresident spot and paid via Flowbird. He has proof of payment and this was verified by our office. The Board discussed and reviewed and agreed to void his ticket, as it seems to be an error made by code enforcement.

6. ByungYong Kim

Mr. Kim came in regarding a ticket he received. He is a resident of Manhasset but does not have a permit. He was picking up his son from the train on the weekend. He parked his car and walked down to help his son. He was parked for 5 minutes, but got a ticket for not paying the daily fee. The Board discussed and reviewed and agreed to void his ticket, as a one time grace and requested he obtain a permit since he is eligible to avoid any further issues/tickets in the future.

7. Coin Cart

Amanda updated that Board that the new key to the coin cart came in and we were able to repair the cart and do a collection.

8. TONH

The TONH offered their employees a retirement incentive. The Board will review and discuss whether the MPD might offer the same.

9. Snow Removal

Amanda discussed with the Board the issue we are facing with snow removal. Since Snow OT is not mandatory, we sometimes do not have the manpower to complete all the lots in a timely fashion. The Board will discuss options for the future.

Motion was made to enter into Executive Session by David Paterson, Motion seconded by Ken Weigand and all voted "aye" Executive Session started at 6:48 P.M. to discuss employee matters

Motion was made to close Executive Session by Kenneth Weigand, motion seconded by David Paterson, all voted "aye" at 7:15 P.M.

We received an email from the disability insurance offering a rider insurance for paid family leave. The Board will look into it.

11. PERMA Convention

Amanda notified the Board that Ralph and Amanda are looking into attending the Convention in May.

12. Electrical quotes

Amanda updated the Board that we are still waiting for a third quote.

13. Adam Mann

Commissioner Sauvigne spoke to Adam Mann to invite him to our next meeting to discuss his property at 272 Plandome Road.

14. Matt Donno- Chamber of Commerce

Mr. Donno asked Mr. Sauvigne if the MPD had any space for a storage bin for the Chambers use. The Board discussed, but do not see any viable options for something long-term. They came up with some other locations to suggest.

15. Jimmy's Run

Jimmy's Run has requested to use the lot May 18th. The Board agreed to approve.

16. Next Month's Meetings

The meetings for March will be Tuesday March 11, and Monday, March 24 at 6:30pm.

Having no other items on the agenda, Motion was made by David Paterson to adjourn the meeting. Motion seconded by Kenneth Weigand and all voted "aye".
