REGULAR MEETING MARCH 24, 2025

Meeting 25-06

The bi-monthly regular meeting of the Board of Commissioners of the Manhasset Park District (MPD) convened at the Manhasset Park District Office at 62 Manhasset Avenue in Manhasset, New York at 6:15 P.M. Monday March 25, 2025. Present were Commissioners David Paterson and Kenneth Weigand, with Mark Sauvigne joining via telephone. In addition, Robert Morici & Paul Pepper, MPD Legal Counsel were in attendance.

Commissioner Paterson called the meeting to order at 6:30 p.m.

1. Approval of Minutes from Previous Meeting: With the minutes of the previous meeting having been reviewed by the Commissioners, a Motion to approve the Minutes of the March 11th, 2025, Meeting of the Board of Commissioners was made by Comm. Paterson and unanimously approved.

2. Payment and Receipts
The following resolution was proposed:

On a voice vote, this resolution was unanimously approved.

3. Parking Lot Update
Non-resident and Student Parking was discussed: Commissioner Weigand provided the Board with an update regarding Trevor Wells, a non-resident Junior at Manhasset High School, who had previously appeared before the Board to request a temporary permit. Comm. Weigand spoke with the Vice Principal of the School and believes that the School will accommodate the student. No action to be taken by the District.

Further, the Board discussed the status of the commuter lots, specifically with regard to the current configuration of non-resident and student parking. A Resolution was proposed to extend the current configuration through April 2025, at which time it will be re-evaluated; on a voice vote the Resolution was unanimously approved.

4. Reissuance of Resident Permit:
A Resolution was proposed to re-issue a Resident Permit to replace a permit that was affixed to the vehicle in a manner not readily visible to the Code Enforcement Officers. A Resolution to remove the old permit and issue a new permit, was proposed and unanimously approved on a voice vote.
5. Next Meeting
April's Meetings shall be held on April 7th and April 21st at 6:15 p.m.

6. Manhasset High School Varsity Lacrosse:

The Board considered a request by supporters of the Manhasset High School Boys Varsity Lacrosse Team to use the west end of Lot #3 before and after the home varsity lacrosse games. The games are currently scheduled for 3/25, 3/31, 4/4, 4/8, 4/10, 4/12, 4/15, 4/19, 4/22, 4/24, 4/29, 5/3, 5/5, 5/10, 5/13 and 5/16. Appropriate insurance was provided by the applicant and verified by the Board. Use of the Lot #3 was approved for the 3/25 game and the decision on future games was reserved.

Having no other items on the agenda, Motion was made by David Paterson to adjourn the meeting. Motion seconded by Kenneth Weigand and unanimously approved.
