_____ The hours of operation for Morning Care are 7:15am. to 8:00am.

_____ Breakfast is not part of the Morning Care program.

_____ The hours for After School Care are 3:30pm. to 4:45pm.

_____ Registration fee of \$15.00 is due upon enrollment for each child. I understand this fee is NON-REFUNDABLE should my child withdraw from After/Before Care.

_____ After School Care is \$ 27.00 per week. Payment is due in advance, on the first school day of each week.

_____ Before School Care is \$17.00 per week. Payment is due in advance on the first school day of each week.

_____ Before & After Care combined is \$44.00 per week. Payment is due in advance on the first school day of each week.

_____ Before/After care will not be prorated for student attendance or school holidays. It is a set weekly price.

_____ There is a \$10.00 late fee for students that remain after 4:45pm payable at the time of pick up.

_____ I understand that a late fee of \$10.00 will be assessed FOR EACH WEEK that the payment is late.

Paloma Academy reserves the right to exclude a child from participation if payments are more than two weeks late, or if payments are late more than 4 times during the year.
