ADULT LIABILITY WAIVER**

BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. I am aware that there may be additional hazards in addition to the usual dangers and risks inherent in classes, sports, undertakings, events and other activities. By signing this waiver, the participant freely accepts and fully assumes responsibility for all such dangers and risks and the possibility of personal injury, death, property damage or loss resulting there from. I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS for personal injury including death, illness, and/or property damage that I may have against VELOS and Eastside Worship Center, their shareholders, partners, principals, directors, officers, sponsors, affiliates, agents, employees, contractors, representatives and any volunteers in any way associated with, VELOS/EWC all of whom are hereinafter collectively referred to as "the Releasees."
2. TO RELEASE THE RELEASEES FROM ANY AND ALL LIABILITY for any loss, damage, injury, death, medical or other expense that I may suffer or that any other party may suffer as a result of my participation and any other activities, due to any cause whatsoever.
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage or personal injury to any third party, resulting from my/classmates/teammates participation in classes, sports, undertakings, events and other activities
4. THIS RELEASE OF LIABILITY SHALL BE EFFECTIVE AND BINDING upon my heirs, next of kin, executors, administrators, successors, and assigns in the event of my personal injury including death, illness, and/or property damage.
5. I ADDITIONALLY AGREE not to take unreasonable risks while participating in VELOS/EWC activities including but not limited to attempting skills or activities that I am not qualified to perform safely or causing any other participants/spectators unreasonable risk of harm.
6. I UNDERSTAND participation in classes, sports, undertakings, events and other activities is voluntary and not a requirement in any way. I HEREBY CERTIFY THAT the as a participant I am covered by my own Medical Insurance, and that I have read and understand this Release of Liability prior to signing it, and I am aware that by signing this Release of Liability I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators, successors, and assigns may have against the Releasees. VELOS/EWC shall have the right to impose any additional conditions which, in the opinion of the Releasees, will further the intent and legal rights and waivers provided herein.

This Liability Waiver was made and executed in the State of South Carolina and shall be governed by, enforced in and construed in accordance with the laws of the State of South Carolina .I/we acknowledge that in executing this Waiver, I am not relying on any inducements, promises, or representations made by the Releasees. I am acting on behalf of myself in signing this contract and I am bound to the terms and conditions of this contract.

BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE Participation in classes, sports, undertakings, events and other activities assumes acceptance of this document and all policies of VELOS/EWC. I, the undersigned, hereby voluntarily release, discharge, waive and relinquish any and all claims or causes of action for personal injury, property damage, or wrongful death which may arise out of or in connection with my participation in VELOS/EWC programs or any other location where activity occurs, regardless of how such injuries or damages may occur. I UNDERSTAND AND ACKNOWLEDGE THAT ALL ACTIVITIES HAVE KNOWN AND UNANTICIPATED RISKS WHICH COULD RESULT IN PHYSICAL OR EMOTIONAL INJURY, PARALYSIS, DEATH, OR DAMAGE TO MYSELF, TO PROPERTY OR TO THIRD PARTIES WHICH NO AMOUNT OF CARE, CAUTION, INSTRUCTION, OR EXPERTISE CAN ELIMINATE. IN CONSIDERATION OF MY BEING ALLOWED TO PARTICIPATE IN ANY AND ALL ACTIVITIES,, I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF INJURY OR DEATH, WHETHER FORESEEABLE OR NOT, SUSTAINED IN CONNECTION WITH MY PARTICIPATION ON OR AROUND THIS ACTIVITY. Accordingly, under no circumstances will I, nor any of my heirs, distributees, guardians, legal representatives or assigns present or bring any claim for personal injury, property damage or wrongful death against VELOS/EWC or any officer, director, member, agent, servant or employee or volunteer. FURTHER, I AGREE TO INDEMNIFY AND HOLD VELOS/EWC HARMLESS FROM LIABILITY FOR INJURY TO PERSONS OR PROPERTY WHICH MAY ARISE FROM MY PARTICIPATION ON OR AROUND THESE CLASSES, SPORTS, UNDERTAKINGS, EVENTS AND OTHER ACTIVITIES. REGISTRATION FEE IS NON-REFUNDABLE.
