Letter from the MCBA President - Ten Minutes with The Bees

2018 has been an interesting year in the bee yard. First it was so cold so long. Then it exploded. Add a record hot summer and the bees can keep you guessing. Many of you have seen your bees hanging out on the porch since way back in mid-June. High traffic days have been far and few between. So, what is happening now?

Goldenrod – This Friday, Aug 31, I smelled GR "aroma" from the hives! Yes, it kinda stinks (that's normal). It has the makings of a good fall flow. That means keeping an eye on your hives to make sure they store a lot in the deeps, but don't swarm. During a quick check on Monday, September 4th, two of my hives had filled 4-5 frames in the super in the past 3 days. I added a 2nd super to one to give them a place to bring in more nectar.

Swarms – I'm hearing of lots of fall swarms. And BIG swarms. One of mine swarmed Friday, August 31 - huge, up 45 feet. When I checked the hive, I found new swarm cells. But I also found 6 frames of capped brood, larva, milkbrood, and 2 frames of eggs. Queens are not supposed to be able to fly if they are still large and laying!? Always more to learn.

SHB – The small hive beetles have been fairly heavy this year. I find some on the IC (inner cover) of every hive. I now go out and pop the OC (outer cover), carefully lift the IC (don't shake the bees), and watch for a minute. Soon I see the SHBs start to run. They do not hurt the hives, if strong, but are a nuisance. Monitor the frames you are storing! This quick check takes about 10 minutes per hive.

On Monday, September 4, three of my strong hives had 22-24 SHB on the IC. On one, about 15 SBH were hiding between the end of the frames and the box. I've never had more than a couple of SHB in the past. I put a trap in two

hives. I like to think about all the SHB that WON'T be making babies! Two other hives had 0 and 2 SHB.

Varroa – Always varroa, right? No matter what your samples have told you, now is the time to check diligently. Don't let up! Those 6 frames of capped brood hold over 25,000 new bees. If there are varroa in the cells, they won't have anywhere to go as the bees will raise less brood now. The numbers can surprise you since all exposed.

Good luck, have fun, and don't forget to share what you find!

Club Bee Yard

Dwain and Nick, our bee yard stewards, gave us an update about the club bee yard, which is located at Feeding Medina County. All hives and their brood frames were visually inspected, specifically at the brood cappings for pin holes that would indicate varroa. None were detected so an alcohol wash wasn't performed. Hive 2, which was requeened earlier in the summer, had ok good brood patterns and numbers, and a normal amount of honey on the brood frames.

Hive 1, located by the food bank building, and Hive 3, located near the garden, are doing very

well. The honey super in Hive 1 will be ready to harvest when three more honey frames are filled. All of the honey frames in Hive 3 are full and a second honey super was put on September 1st.

Watch for information about September bee yard day for club members. The bee yard honey will be harvested, bottled, and donated to Feeding Medina. Members will be invited to participate.

The Northeast Ohio Bee Yard - September

We had a request from a reader for a short to-do list for this section, so we will try this format.

- Take off honey supers. When the honey flow is over, take off honey supers, extract the honey, put the wet frames back on the hive for the bees to clean, take the cleaned frames off, and store them for winter.
- Check for diseases! If you see evidence of brood disease or mites, treat when honey supers are off.
- Check honey and pollen stores. Each hive will need 60-90 pounds of honey, between 10 and 15 full frames of honey, more if you are using medium hive bodies.
- If needed, start feeding. After goldenrod and aster blooms, there won't be much nectar available for bees to gather. Feed a syrup made from 2 parts sugar to 1-part water using an internal feeder. - Check to see whether the bees are bringing in pollen. The hive will need several frames of pollen for the winter. If needed, you can use pollen patties, but keep an eye out for small hive beetles.

Editors' Corner

2018 North American Mite-a-Thon

The Mite-A-Thon is a tri-national effort that asks beekeepers in Canada, the United States, and Mexico to collect mite infestation data one week annually to better understand varroa infestations in honey bee colonies across North America.

Please consider participating – it's easy and you need to measure your varroa loads anyway. During the week of September 8, measure the level of mites (number of mites per 100 bees) in your hives using a standardized protocol of powdered sugar roll or alcohol wash. Enter the information, including location, total number of hives, number of hives tested, local habitat, and the number of varroa mites counted from each hive to www.mitecheck.com.

You can see summary data about mite count, management methods, and a map of highest mite count reported per county. The information does not identify individual participants. You can take a look at the site to see historic data, instructions for participating, and the data reporting survey.

OSBA 4-H Partnership Program – Application Deadline November 2nd

The OSBA 4-H Partnership Program will bring the support of OSBA, Extension 4-H staff, and local beekeeping organizations to support five selected 4-H members in beekeeping projects. Selected 4-H members will receive basic woodenware and toolkits to establish two complete hives, and practical support and encouragement from experienced beekeepers. Local beekeeping associations who participate gain visibility to a new and vital audience of the "next generation" of beekeepers and increase positive community involvement.

Applicants must be aged 12-18 by January 1st, 2019; be a member of 4-H; and enrolled in public, private or home school. The completed <u>application</u> must be returned by **November 2nd, 2018.** The program guidelines are described in detail here: http:\\www.ohiostatebeekeepers.com\4h
