MISSION AND VALUES

The Holly Grove Volunteer Rescue Squad and its Junior Membership Program work in cooperation to Educate, Protect and Serve the citizens of Louisa County and the communities within our district.

MISSION STATEMENT

To learn about many aspects of Emergency Medical Services and to learn the value of volunteerism within our communities.

VISION

HGVRS will be a model for EMS agencies with Junior EMS youth programs. We will introduce the community to Emergency Medical Services and provide a safe environment for social activities for youth within our communities.

INTRODUCTION

REQUIREMENTS

- Junior EMS members must be at least 14 years old but not older than 18 years old. At 18, A Junior member would essentially
 transition into a senior member.
- They must be able to follow directions under stressful conditions.
- They should be in good physical condition to perform essential EMS tasks to assist EMT's or Paramedics on emergency and non-emergency calls.
- Juniors should be willing and able to attend at least 50% of scheduled meetings and required trainings.
- Juniors must maintain 75% average or higher in their schoolwork to remain active.
- Junior members must adhere to these guidelines but will also be trained and become knowledgeable in HGVRS' Standard Operating Procedures (SOP's).
- Junior members need to be self-starters and willing to learn.
- Juniors who regularly strive to learn more and be involved will be rewarded with increasing levels of responsibility and
 opportunities.
- Junior members who do not contribute to the agency will be removed from active status to allow other juniors the opportunity to participate.

MEETINGS AND TRAIINING

Junior Membership meetings are generally conducted by the Junior Advisors. The meetings times and dates are set by the Junior Advisor. They are generally informational, and Junior Program business is discussed. Junior members are also encouraged to come to HGVRS monthly business meetings.

The training for the Junior Program is structured to introduce Junior members to Emergency Medical Services and medical careers. Junior members that transition into senior membership are at an advantage since the junior program introduces them to the tools and skills that are used in EMS. During orientation and training, you will learn how to work as a team and HAVE FUN! Quite often the training will include some physical or hands-on activity or lesson. At times, an educational field trip may be substituted for the regularly scheduled training.

Junior training dates and times will also be scheduled by the Junior Advisors. The calendar in the meeting room will have the monthly dates of upcoming training sessions. Upon learning and completing CPR and HGVRS's orientation programs, Juniors will be issued a uniform. All training, T-shirts, and personal protective equipment are provided at no cost. Basic trainings include:

- CPR
- Stop the Bleed®
- Moving and lifting
- Taking vitals

Rescue College, Blacksburg Virginia: The Virginia Association of Volunteer Rescue Squads (VAVRS) holds an annual rescue college event in June. This training event encompasses a wide variety of courses built to improve on first responder education, hands on experience, and overall preparedness of those dedicated individuals serving the public, and safeguarding their communities.

COMMUNITY EVENTS AND FUNDRAISING

Throughout the year, the HGVRS Junior squad participates in several community events. Other local agencies will invite the junior squad for career and volunteer trainings or even parade participation. Community outreach opportunities include trash pick-up and festival participation as well as the annual membership banquet in July. Advanced notice is provided as possible.

Fundraising provides juniors the opportunity to get to know our community and learn the fiscal responsibility involved in a volunteer organization. Fundraising events are held throughout the year but typically include:

- Spaghetti dinner
- Carwash





ADVISORS AND OFFICERS

JUNIOR ADVISORS

The Junior Advisors oversee the entire Junior Membership Program and carry out as needed the responsibilities of the program in close conjunction with the VP of Operations. Junior Advisors will champion recruiting and recognition of Juniors, be responsible for records of attendance, training, and provide a summary report of Junior Squad activities at monthly business meetings. Junior Advisors will coordinate orientation for new members and see they are following through with duties.

JUNIOR OFFICERS

The Junior Advisors will appoint Junior officers from within the Junior Membership Program who possesses leadership and training capabilities to lead other Junior members. Officer positions include President, Vice President, Secretary, and Treasurer. This is a great opportunity to learn rules of conduct and structure of an organization.

CODE OF CONDUCT

As a member of the HGVRS Junior Membership program, you are expected and required to:

- Abide by all of the Standard Operating Procedures and all other rules and regulations of HGVRS, as well as those of the Junior membership program.
- Conduct yourself in a professional and courteous manner that will reflect well on you and the entire department, especially
 when you are in uniform.
- Demonstrate honesty, fairness, and integrity.
- Recognize the value and worth of each member.
- Refrain from using profanity while in uniform, at the station, on duty, and while participating in department functions.
- · Work as a team with others.
- Participate in training, meetings, community activities, and fundraisers.
- Obey the chain of command.
- Wear your uniform when "on duty" at the station and any agency functions you attend.
- Notify an advisor or person in charge upon arrival and departure from the station and department functions.
- Immediately report any problems or injuries to an advisor or person in charge.

PROHIBITED ACTIVITIES BY LAW OR BY HGVRS

HGVRS or state laws specifically prohibits Junior members from participating in the following activities:

- Operating organizational vehicles.
- Entering a burning structure or entering a crashed motor vehicle.
- Participate in emergencies involving WMD, explosives, or hazardous materials.
- An emergency operation in or around mines, strip-mines, quarries or gravel-pits.
- Participate in operations involving radioactive substances.
- Participate in operations involving weapons or suicides.

PERMITTED ACTIVITIES

- Participate in organized training activities in which a senior member of the organization is present and supervising the
 junior member.
- All aspects of EMS patient care within the operational scope of practice.
- All aspects of EMS Training.
- Hazardous material training at agency level as required by OSHA.
- Wilderness Search and Rescue training. 6. Provide Rehabilitation and canteen services.
- Hypothermia and Ice Rescue.
- Fundraising activities.
- Agency activities that are related to Junior Membership Program.
- All other activities, training, or EMS operation sanctioned by HGVRS.





RULES AND REGULATIONS

- The regular "on duty" Paramedics, EMTs and drivers will directly supervise the Juniors. During certain emergencies or agency activities an EMT advisor will supervise Junior members. Within the ranks of the Junior membership, leadership roles can be assigned by the EMS Junior Advisors for officer positions.
- The Junior member shall abide by all federal, state, departmental rules and regulations.
- All members shall meet the minimum standards and must provide at least 2 references which will be checked prior to initial
 interview.
- Junior membership applications are screened by the Junior Advisors, and after the initial interview, the Junior applicant will
 enter the orientation phase. When orientation by the Junior is complete, the Junior will be introduced at a HGVRS Monthly
 Business meeting as a Junior member in good standing.
- Junior members should attend Junior Membership meetings as scheduled but may also attend the monthly business meetings.
- HGVRS has established a limit of 20 Junior membership positions at one time. All Juniors must complete the HGVRS
 Orientation Program. This orientation includes adherence to Standard Operating Procedures, facility policies, vehicle
 orientation, command structure, and OSHA or OEMS regulations.
- All HGVRS members recognize rules and regulations that govern minors and their safety. Junior members are not permitted
 to participate in activities that are prohibited.
- Junior members are not allowed at the station unsupervised.
- All junior members must sign in and out of the Junior Operations Log Book each time that they are "on duty", are involved with agency training, or activities.
- Junior members and their immediate family may use the station meeting room by request and approval of the VP of
 Operations. DO NOT bring your friends to hang around the station. On occasion, a small group is permitted with the approval
 of your Junior Advisor.
- Any injuries occurring during training or at a scene are covered by Louisa County. Any injury, no matter how insignificant, must be reported to a crew member and then to an executive officer within 24 hours.
- Alcoholic beverages are NOT allowed on HGVRS property or functions at any time.
- Do NOT come to the station if you are sick, or under the influence of medication, drugs or alcohol.
- There will be no smoking on the premises by Junior members.

HOURS OF OPERATIONS FOR JUNIOR MEMBERS (ON DUTY HOURS)

All hours for "on duty" time as a Junior may vary based on parental or guardian approval but must follow the following guidelines.

- Any activity time or "on duty" time can only occur from 0800 until 2200 any day of the week
- There is no activity time or "on duty" time while school is in session. NO EXCEPTIONS.
- Maximum of 18 hours per school week (Monday through Friday)
- Maximum of 6 hours on school days
- Maximum of 16 hours total for Saturday and Sunday
- Maximum of 8 hours on school holidays
- No activity, "on duty time" or "bunking over" 10 PM to 8 AM
- Maximum of 40 hours per week or during school breaks.





RESPONDING TO CALLS ON AN AMBULANCE

Junior members must complete the HGVRS orientation process, have completed CPR course and must be 16 years of age prior to being able to respond with the ambulance. Only members that are at least 16 years old and have a valid VA driver's license may drive personal vehicles to the station.

It is never the intention to place any junior in harm's way, but EMS calls or operations can be a dangerous job. Senior HGVRS volunteers are also trained to supervise juniors and have them "step aside" in stressful situations or difficult patient care activities.

HGVRS takes safety very seriously and will not tolerate horseplay during training or real emergencies. During emergency conditions, a junior might be asked to complete a task but only after they have been trained. A Junior member must also take personal responsibility to alert the crew when they feel they are overwhelmed.

MOTOR VEHICLE ACCIDENTS

Juniors are prohibited from entering any vehicle to assist victims. Juniors must; however, wear an ANSI vest. Participation at these scenes is restricted to helping with carrying or getting equipment from the ambulances when requested. Juniors are not permitted to perform any traffic control duties.

- 1. UNDER NO CIRCUMSTANCES ARE JUNIORS TO GO DIRECTLY TO THE SCENE! Junior members are not allowed to drive "to" a call in any circumstance. If multiple EMS calls are coming in, drive to the station to assist with an incoming crew accordingly.
- 2. UNDER NO CIRCUMSTANCES is a Junior member permitted to use colored lights, hazard lights, honk the horn or use any other warning devices while enroute to the station.
- 3. If all ambulances have responded prior to your arrival, you must stand-by at the station and wait until the vehicles return from the call to assist in clean-up or restocking. Juniors are NOT permitted to respond with any backup mutual aid EMS agency.
- 4. All speed limits and traffic laws are to be strictly followed while responding to the station.
- 5. HGVRS is in no way responsible or liable for any moving violations or accidents while enroute to or from the station for a call or training.
- 6. Failure to abide by these rules will result in a suspension of at least 30 days and possible expulsion from the junior program.
