General Access & Egress (Vehicle)	Member(s)	Muscular Skeletal Injuries (Vehicle Collision/Tip-Over)	<ul style="list-style-type: none"> - Always check the stability and suitability (eg. hidden undulations) of any terrain intended to be driven on. - Wear seatbelts in vehicles at all times. - Do not traverse any slopes. - Ensure any gates opened are suitably fixed open whilst passing through. General Access & Egress (Vehicle)	Member(s)	Drowning (Vehicle Run-Away/Tip-Over)	<ul style="list-style-type: none"> - Do not drive within 10M of the waters edge. - Park/drive in designated areas only. - Ensure the parking brake is always applied on vehicles when not in use. 	N/A
General Access & Egress (On Foot)	Member(s)	Muscular Skeletal Injuries. Slips, Trips and Falls.	<ul style="list-style-type: none"> - Always visually check the stability and suitability (eg. hidden undulations) of any terrain you intend to cross. - Follow any designated paths & walkways. - Ensure any gates opened are suitably fixed open whilst passing through. 	N/A
Angling Activities	Member(s)	Drowning	<ul style="list-style-type: none"> - Wading, either with or without waders is not advised. If it is essential a second person should be present, and a 'prodding' stick should be used to ascertain the suitability of the lakebed. 	N/A
Angling Activities	Member(s)	Drowning	<ul style="list-style-type: none"> - Members are advised to never fish alone, if they do, regular 'lone-worker' style checks should be established with a suitable contact. 	N/A
Angling Activities	Member(s)	Medical Emergency	<ul style="list-style-type: none"> - Members are advised to never fish alone, if they do, regular 'lone-worker' style checks should be established with a suitable contact. - Club Emergency instructions are on all notice boards. In all cases the emergency services should be contacted prior to the club emergency contact number. 	N/A
Angling Activities	Member(s)	Slips, Trips and Falls	<ul style="list-style-type: none"> - Members are advised to ensure they take suitable lighting equipment when night fishing to ensure they have a clear view of the terrain even during darkness. - Paths are maintained as best possible, given the terrain and large number of variables, members are advised to wear strong footwear with ankle support to reduce the likelihood of strains and sprains from uneven ground.
