with children. It was a beautiful time of united prayer and praise to the Lord our God.



There she will continue to participate, serve and remain in a network of recovery and spiritual support as she grows in meeting responsibilities of having her children with her in her own place. Back on the Recovery Road



Kelli Crawford, who commenced The Healing House and New Beginnings Program in July 2017, is 4 months clean and sober as of the end of September following an approximate year-long relapse. She openly shares her experience and what she has learned in hopes that it may help others. When Kelli

completed the program, many things had come together for her – her faith in the Lord was strong and she was working full-time at Scholastic. She had regained custody of her two young sons and rented a small house just a few short blocks from The Healing House where she and her boys, Noah, 10, and Mason, 8, still live. According to Kelli, her sobriety went well the first year following her commencement despite many challenges. The Lord provided for every need she had as she relied on Him. Early work hours made it difficult to arrange day care, but the Lord provided.

She had returned to a relationship she had put on hold while going through the Healing House program. Though her boyfriend did not struggle with addiction, she knew in her heart that differences in their faiths presented problems that would not be overcome. When Kelli became pregnant and then suffered a miscarriage, doubts about her own walk with the Lord entered as she experienced a multitude of emotions. “Maybe this faith was not my own, but Heather’s,” she revealed her thoughts referring to Heather Gieck, Healing House Executive Director and Founder. These thoughts she now attributes to coming from our spiritual enemy. “Instead of going to God and seeking Him for myself, I was held captive to this lie. Instead of sharing what was going on in me with people, I isolated myself.”



Following her painful miscarriage and break-up of this relationship, Kelli became involved in another relationship that was difficult. Gradually departing from the practices that had built up her faith and recovery, Kelli went further on the path of relapse by first smoking pot and then drinking. This, she says, led to spending time with people with whom she previously used drugs and eventually she returned to drug use.

When asked how she made her way back to sobriety, Kelli shared, “I knew that God was my only way. I went to rehab for a brief stay. I went to 30 recovery meetings in 30 days. I have a sponsor and work with her. I’m back to reading my Bible, spending time with the Lord and writing in my journal. Being the mom my boys need is also my main focus.”

Sharing some of the things she has learned from relapse and recovery, Kelli stated, “I understand that we have to use our program. Heather can’t use it for us. I know I need to focus on my recovery and can’t be in a healthy relationship unless I’m healthy. Being in relationships with men enabled me to avoid what was going on in me. It was a way to not hold myself accountable. We can pick up where we left off in our addiction or we can pick up where we left off in our recovery.”

What does Kelli consider most important to avoid relapse?

Put God and recovery first

Work your program – no one is going to work it for you

Never forget who you are in Christ

Kelli works for general contractor McCormack Family Enterprises providing office support. She also works part-time at Sonic and volunteers twice a week at the Prenger Family Center. Her long-term goal is to return to school to become a trauma counselor for children. May God’s grace and power preserve you, Kelli, as you give yourself to follow Him.

In addition to working at Scholastic full-time, she now has her own business and is cutting hair on a scheduled basis for residents of an assisted living facility. Carly earned her cosmetology license while incarcerated and put a lot of effort into what was needed after her release to put her license to use.

The ASPIRE MO program awarded Carly a grant to help obtain equipment she needs and she registered her business with the state. Selecting equipment, familiarizing herself with it and planning how best to provide a mobile service required some preparation. Carly gave haircuts to lots of happy customers her first visit and they look forward to her returning soon.
