* Non-refundable after **Date (usually 2-3 weeks before Performance Date)** unless agreed to by the Artist in her sole discretion. If the Artist cancels the performance, she will use her best efforts to find a substitute acceptable to the Presenter; otherwise, the Artist must refund the Deposit within five business days.

Overtime will be at a rate of **\$XXX/hr.**, but **must be agreed to by the Artist and Presenter prior to the overtime**, and **immediately payable by cash or the same means as the Final Payment.**

3. The Artist is responsible for her transportation, meals, and other incidental expenses.
4. The Presenter agrees to provide for the Artist's use:
One table and two chairs outdoors, in an area that's relatively quiet and has adequate light for palm reading as well as sufficient space for social distancing.
5. The Artist may display her own business cards at the performance.
6. **COVID Precautions (May be modified by mutual consent depending on requirements at the time of the event)**
 - **The Artist shall wear mask and gloves. Guests will be required to wear masks, maintain a prudent distance, and use hand sanitizer. Only the artist will handle tarot cards per directions by guests. Palm readings will be done without physical contact. Guests will be encouraged to record their readings and Artist will provide takeaway sheets for later reference.**
 - **The Artist reserves the right to prevent anyone coughing, sneezing, or otherwise showing symptoms of potential illness from approaching.**
7. The terms of this Agreement contains the complete understanding of the parties regarding the Performance, and have precedence over any attachment to it.
8. The Artist and Presenter affirm their insured status (self-insured and otherwise) for their potential liabilities. **(May include name of performer's insurance company, if required, and Presenter insurance info).**
9. This Agreement, including any attachments and payments hereunder, cannot be assigned or transferred without the written consent of both parties. The Presenter makes no representations or agreements, outside the terms of this Agreement, which add to, vary, or conflict with its provisions. Any purported outside representations or agreements have no force or effect upon the rights or duties of the Presenter hereunder. Any alterations or additions to this Agreement must be by written agreement by the parties to it, and any notices under it shall be in writing and provided to the Artist and/or Presenter at the addresses listed above.
