Saunders Tours reserves the right to cancel said tour up to 60 days prior to departure with full refund of all monies received.

**Cancellation:** Your money will be refunded, **excluding initial deposit**, if you cancel your reservation up to 90 DAYS prior to departure. After that date a 25% penalty applies, plus any non-refundable or cancellation charges imposed by hotels, suppliers, or transportation companies involved. No refunds will be made for cancellation occurring within 30 DAYS of departure.
