Should cancellation occur, Saunders Tours' liability is limited to the monies received subject to our stated cancellation policy and is neither responsible nor liable for defaults of those not directly under our control. Saunders Tours reserves the right to cancel said tour up to 60 days prior to departure with full refund of all monies received.

Cancellation: Your money will be refunded, **excluding initial deposit**, if you cancel your reservation up to 90 DAYS prior to departure. After that date a 25% penalty applies, plus any non-refundable or cancellation charges imposed by hotels, suppliers, or transportation companies involved. No refunds will be made for cancellation occurring within 30 DAYS of departure. No refunds will be made for any attraction, sightseeing excursions and/or meals the participant misses or decides not to take. Though it rarely happens, prices are subject to change.

IMPORTANT NOTE: Due to the nature of this tour, you should be able to climb stairs and walk unassisted at a moderate pace of 1-2 miles per day.
