Your tap water meets or exceeds all state and federal regulations and is safe to drink. Our 2024 Annual Drinking Water Quality Report for public water system ID 64000E is included. Remember do not pour anything on the ground you would not want to drink. Use the Transfer Station to dispose of any toxic chemicals.

The annual water meter reading begins the first week of August. Please be sure access to your meter is free of large vegetation, vehicles and dogs. If you have a basement meter, you are required to submit your reading by phone or email.

Are you a Sprinkler System Owner?

Per Washington State Law (246-292 WAC)

ALL systems need to be tested annually by a certified tester to avoid a potential \$250.00 fine.

Thank you to 98% of Sprinkler system owners who had their systems tested or had communication with our District. That was the best record yet! Let's see if we can reach 100%!

ALL Backflow aka Sprinkler systems working or non-working need to be tested by a certified tester no later than **JUNE 30th**.

Sprinkler Systems must be installed with an approved device that keeps hazardous herbicides and pesticides from back-siphoning into our water supply. Our website www.orchardaveirrigation.com has a tab dedicated to Backflow and Cross-Connection information.
