TREASURER'S REPORT The Spokane County Treasurer's Report as of the end of January 2025 shows Spokane County Investment Pool [SCIP] funds for the Expense Fund \$1,222,613.28 Interest received \$3,431.15 at 3.232%; and for the Loan Fund \$19.42, Interest rate 3.403%. Delinquent Assessments owing: 2024 \$12,813.65; 2023 \$4,700; 2022 \$2,070.90; 2021 \$323.75.

CHECKS & VOUCHERS Invoices for materials purchased and services rendered to the District were examined and thereupon it was moved by Jesse Swenson, seconded by Aaron Hall and carried to approve payment of Spokane County Voucher No. 0702 and 0703, inclusive, an electronic withdrawal by the State of Washington for Excise tax and Retirement reports from U.S. Bank of Washington. Total \$50,746.99, including Payroll, Federal Withholding, Social Security and Medicare, approved by the 2025 budget. The Voucher page was signed and has been sent to the Spokane County Auditor for payment to reimburse the Revolving and Payroll Funds.
