Boarding Agreement

This agreement enters into thisday of2025 between Northwind Dog Boarding and the dog owner.				
Northwind Dog Boarding will be closed the month of September.				
Northwind Dog Boarding agrees to board the owners dog at a daily/nightly rate of \$40.00. A second dog will be charged \$35 per night. A 3% tax will be assigned.				
Owner agrees that Northwind Dog Boarding shall not be liable for damages of any kind or nature accruing from any cause whatsoever, including but not limited to loss by fire, theft, running away, loss, or injury to the dog/dogs.				
Owner agrees that they shall be solely responsible for any and all injuries and/or damages occurring to themselves or any parties and by any and all acts of the dog and agrees to indemnify and hold Northwind Dog Boarding and owner, Lucy Ritter, harmless thereof.				
Owner agrees that if a veterinarian is needed in the care of injury or sickness, Northwind Dog Boarding may call the dog owners vet at the owners' expense. Or if the owners vet is not available Northwind Dog Boarding may call any other vet to assist in the care of your dog.				
All dogs, boarding at Northwind Dog Boarding, must be healthy and vaccinated on a regular basis and a statement in that effect must be submitted to this office for the filing in the system.				
Daily boarding fee must be paid, upfront when the dog/dogs is/are dropped off or monthly if the dog is kept on a long term basis. Northwind Dog Boarding has the right to place a lien on the owners dog and equipment in lieu of payment. If this right is exercised owner will be notified, in writing, and will have 10 days to make payment, or relinquish dog, registration papers, and equipment to Northwind Dog boarding.
