Topic: How people engage in governance.

What do we do? \What do we do well? How do we better?

It's about the culture, communications with respect to BC Societies Act, Bylaws and Constitution

2016 BC societies act changed for the first time in 40 years.

If it's not in the constitution it is not our purpose and is illegal to pursue.

Societies are forever.

Board members of non-profits and chairities can not be paid

You can have paid staff or paid contractors.

"Don't want to be listed as a membership with an organization that I don't know exists" le., it is necessary for application.

Your bylaws, the act and the board's behaviour determine how well it is running.

OCA is its own legal entity.

Wages are the thing Board members are responsible for should the society fold.

A board member's primary responsibility is to the society's mission.

Board members have a duty to recuse themselves and disclose the conflict of interest to be written into the minutes or presented to the Board Chair. The idea is full transparency.

A board member has a duty to resign or recusal if they are in a conflict. But if the conflict is significant or ongoing it is better to resign.

Must resign if corporate or personal bankruptcy. It is the duty to resign. You can not serve if you are not self responsible in terms of your own affairs.

Board recruitment is a challenge because you should have qualified people in positions of responsibility. How to create a space of engagement. Leave each board meeting with a sense of accomplishment.

How to create a space of community. Respectful and kind.

Discussion, information, decision making.

How much time does the board spend on future thinking? How much time spent on past?

How to find solutions to the problems looking forward instead of focussing on the past.

Tell me more about that. Possible experiment about problem solving.

How to get people to remember the content instead of just the feeling.

A meeting is a meeting if the board determined it such. le Virtual meetings are acceptable as long as they can be verified. le How do we know.

Societies act overrules the bylaws. Bylaws over policies and procedures and practices.

How do we determine policies based on moral leaning of members.

50% of claims against board are wrongful dismissal of both staff and volunteers
