Discussion:

- Each of the previous year's board members present gave a "lessons learned" about their position.
- Toni Fisher moved that Debbie Coolidge remain in her position as Reservations chair; Ruth Wright seconded the motion. All members voted in favor.
- Discussed including Vicki Batten, spouse of ACC/CCC, as an advisor to the Spouses Club, but her participation will be driven by her availability.

- Due to name change of the club, following vote to include enlisted spouses, all paperwork with the IRS will need to be changed. Club, as a nonprofit organization, has an employee ID number, currently under the name of Langley Officers Spouses Club; this will have to be changed.
- Cost of membership was discussed, particularly how to make dues more affordable for spouses of junior personnel. The club's general membership will have to vote on any changes to membership dues in the club's by-laws, such as paying dues per month, versus all at one time. If this is something to pursue, it would need to be proposed at the initial meeting and voted on by members who have paid dues for the year. There is a possibility First Command might be willing to offset membership dues for spouses of junior enlisted. The issue of dues might require a separate board meeting, due to the length of time needed to explore all possibilities.
