- Scotland's Population Health Framework 2025-2035 The Framework is based on five key interconnected prevention drivers of health and wellbeing: Prevention Focused System; Social and Economic Factors; Places and Communities; Enabling Healthy Living; and Equitable Access to Health and Care. It is built around two elements: a universal core provision of 15 hours a week, free for all children from nine months to four years old, and for working families, a cap on childcare costs as a percentage of family earnings to enable them to work. - WHO: From Loneliness to Social Connection charting a path to healthier societies This landmark report from the WHO Commission on Social Connection highlights that social isolation and loneliness are widespread, with serious but underrecognized impacts on health, well-being, and society. Drawing on the latest evidence, the report makes a compelling case for urgent action. Read More
- King's Fund: Shifting to prevention how integrated care systems can tackle cardiovascular disease States "without significant improvement in CVD prevention, the UK risks worsening health inequalities, increased economic burden, and continued underperformance relative to other G7 nations". - Geographic inequalities in premature mortality: Exploring the role of socioeconomic factors and ethnicity The analysis also looks at four of the leading causes of death cancer, cardiovascular disease, diabetes and respiratory conditions. The gap in premature mortality rates is widest for deaths associated with diabetes and deaths due to respiratory conditions. Read More

- Lancet: Bioethics for the planet The conventional fields of bioethics and biomedical ethics are poorly equipped to offer health professionals and policy makers the action-based guidance necessary to confront these planetary-scale drivers of ill health. Bioethics would prioritise the "bios" component of bioethics, thereby



encompassing the biosphere and offering a compelling ethical framework to support people working at the intersection of medical and environmental practices. Read More

- JAHA: Screen Time Is Associated with Cardiometabolic and Cardiovascular Disease Risk in Childhood and Adolescence Each additional hour of screen time was associated with higher cardiometabolic risk in both children with these associations being stronger among children and adolescents with shorter sleep duration. - NSPCC: Child deaths due to abuse or neglect: statistics briefing This briefing looks at what data and statistics are available about child deaths due to abuse or neglect since at least one child is killed a week in the UK. Read More
