- > Mary provided current account balance:

# ➤ Adjustment to Balance

- Mary advised the committee of an invoice that we received for the Mexico Silent Auction Trip on 8/3/2023, which was an additional \$9,000 expenditure. This was totally missed; therefore causing the discrepancy in the balance difference from our last meeting.
- Mary has already created a list of items to be paid in an effort to avoid this type of situation next year.
- ➤ Donation to St. Jude Children's Research Hospital \$66,500



#### VI. OLD BUSINESS

- ➤ Vote to Approve Race for Research Articles of Incorporation / Bylaws previously sent to committee
  - Committee Vote APPROVED UNANIMOUSLY (14 YES)
- > 501c3 Update
  - Application for 501c3 has been submitted; paperwork has been processed and \$600 payment made. Approval process can take up to 4 months. We're hoping to get approval by end of year.
  - Thanks to Shelaine for helping us review/complete the forms.
- ➤ Reviewed Auction Sales List from 2023 and discussed 2024 Auction and possible items that would be best.
  - Suggested that donations for Mother's Day Baskets for Silent Auction be put out there sooner with a mandatory deadline for submission; prior to the event.
