**REGULATION REGARDING THE OPERATION  
OF THE PROFESSIONAL SERVICE PROGRAM  
OF STUDY AND RESEARCH CALLED  
IIJAC INTELLECTUAL COMMUNITY**

**CHAPTER I  
OF THE OBJECTIVE AND PRINCIPLES  
OF THE PROFESSIONAL SERVICE PROGRAM  
OF STUDY AND RESEARCH CALLED  
IIJAC INTELLECTUAL COMMUNITY**

**Article 1.** This regulation is of particular interest because it is applicable only to those people who participate in the professional Study and Research service called the IIJAC Intellectual Community.

**Article 2.** The purpose of these regulations is to establish the operating bases of the professional Study and Research service called the IIJAC Intellectual Community, which will be governed based on the principles and foundations, internal regulations and statutes of the Institución de Investigaciones Jurídicas, A. C., in order for said service to fully comply with its mission, always offering the existence of respect among its members and limiting participation strictly to study and

documentary research to further increase legal knowledge and constant updating regarding to the evolution of legal norms, national and international judicial criteria and evolution of the doctrine of Law, in favor of the members of the IJAC Intellectual Community.

The IJAC Intellectual Community is a permanent professional program of study, updating and research service in favor of law scholars. And because the service is permanent, the members of the Community acquire the quality of Institutional Members within the Institucion de Investigaciones Jurídicas, A. C., in accordance with these regulations and the internal regulations of the Institution.

**Article 3.** Members of the IJAC Intellectual Community are those people who register to participate in said professional program, to take advantage of the benefits offered by this service in favor of legal intellectuals.

The members of the IJAC Intellectual Community will be registered in the book established for this purpose by the Secretary of the Board of Directors, in order to endorse the participation of each member of the IJAC Intellectual Community, and thus have value to curriculum certificates or recognitions issued by the Legal Research Institution, AC for each member of this community.

**Article 4.** This institutional activity is called a "Program" because it is a service of a professional nature, aimed at developing duly planned activities in semi-annual and annual stages, aimed at obtaining results based on the objective of said service.

**Article 5.** As established in Article 1 of the Internal Regulations of the Legal Research Institution, Civil Association, known by its acronym as IJAC, its purpose is to update, assist, revive, train, promote and promote the study of legal science. with a humanistic aspect, attending to the needs derived from the socio-legal reality of the population, all attached to social morality.

Likewise, the same article establishes that said activity will be aimed at applicant lawyers and justice providers, professors, legal scholars and researchers.

**Article 6.** According to the statutes of the Institución de Investigaciones Jurídicas, A. C., it also has the following objectives:

I. Update, assist, encourage and promote the study of legal science to all applicant lawyers, professors at a higher and postgraduate level, law scholars at a higher or postgraduate level, as well as researchers in legal science.

II. Update on the reforms that are made to the law, whether it is of state or federal jurisdiction, as well as make known about jurisprudential theses, jurisprudence, and contradictory theses issued by the competent Federal Courts.

III. Auxiliary in the Legal hermeneutics of the law based on the doctrine and general principles of law, so that said knowledge can be used either in legal practice or in the teaching of law.

IV. Foster and promote the study on the substantiation of jurisdictional trials from a pragmatic-legal point of view.

V. Encourage and promote professional ethics, to motivate respect for social morality in the practice of law.

**Article 7.** Likewise, in accordance with article 3 of the Internal Regulations of the Institución de Investigaciones Jurídicas, A. C., which establishes in its section VII the scope of activities that are agreed by the Board of Directors to achieve the purposes pursued by said legal institution. . And on the other hand, in its second paragraph of section VII of the same regulation it establishes in its literality: "... These activities are regulated under the heading of the incomplete legal proposition for being of an exemplary nature, since all those activities that are essential to comply with the teleology of said institution,

without letting go of the implicit powers that derive from the express ones in this regulation...”

**Article 8.** Pursuant to article 4 of the Internal Regulations of Institución de Investigaciones Jurídicas, A. C., its principles and foundations are the following values in this order: 1.- Sensitivity; 2.- Honesty; 3.- Straightness; 4.- Loyalty; 5.- Perseverance; 6.- Professionalism; 7.- Commitment; 8.- Service; 9.- Audacity; 10.- Perfection; 11.- Wisdom; 12.- Justice. Likewise, said article establishes that the first seven values are aimed at the formation of the lawyer; and the subsequent ones in pragmatics during the performance of the jurist as such.

Likewise, in accordance with the second paragraph of article 4 of the Internal Regulations of the Institución de Investigaciones Jurídicas, A. C., the activities of the IJAC Intellectual Community must be aimed at complying with the values supported by the Institution, this being its philosophy of life and ontological foundation.

**Article 9.** The Professional Service Program called IJAC Intellectual Community, is created based on the principles and values mentioned in the previous articles. All applicants to participate as a member of the IJAC Intellectual Community must know these regulations. For this purpose, these regulations will be published on the web page where this service is offered for your due knowledge; and before the applicant is accepted, they must be asked if they are aware of the regulations so that they can be admitted to the IJAC Intellectual Community.

## **CHAPTER II OF THE ORGANIZATION OF THE IJAC INTELLECTUAL COMMUNITY**

**Article 10.** Because it is a permanent professional service program, the IJAC Intellectual Community will be governed by the provisions set forth in Chapter VI called Institutional Members, of the Internal

Regulations of the Institución de Investigaciones Jurídicas, A. C.; Therefore, the members of the IJAC Intellectual Community are considered as Institutional Members, being an honorary participation, not binding to a labor or professional relationship.

**Article 11.** For this reason, the IJAC Intellectual Community is a service free of charge, in favor of legal intellectuals. Your rights and obligations are detailed in accordance with Chapter VI mentioned in the immediately preceding paragraph and which are strictly limited to enjoying the quality of the service offered and your obligation will be strictly limited to observing this regulation.

**Article 12.** The direction and coordination of activities of the IJAC Intellectual Community is the responsibility of the President of the Board of Directors of the Institución de Investigaciones Jurídicas, A. C.

**Article 13.** The supervision of the development of the activities of this intellectual community, as well as the observation of these regulations, is the responsibility of the General Coordination of Investigations, in accordance with article 24 of the Internal Regulations of the Institución de Investigaciones Jurídicas, A. C.

**Article 14.** The organization of the IJAC Intellectual Community is governed by the following organization chart:

I.- Coordinator of the IJAC Intellectual Community who will be in charge of the President of the Board of Directors of the Institución de Investigaciones Jurídicas, A. C.; who is responsible for the direction and development of study, research and updating activities.

II.- Members of the IJAC Intellectual Community. They are the Lawyers and legal scholars who register to participate in the IJAC Intellectual Community, in order to obtain the benefits offered by this professional service program.

III.- General Research Coordination, which is the body in charge of monitoring compliance with the professional service program, as well as the observation of the regulations by the members of the community.

### **CHAPTER III OF THE RIGHTS AND OBLIGATIONS OF THE MEMBERS OF THE IIJAC INTELLECTUAL COMMUNITY**

**Article 15.** They are rights of the Members of the IIJAC Intellectual Community

I.- Participate in all the information provided by the Coordinator of the IIJAC Intellectual Community.

II.- Participate in events organized by the Institución de Investigaciones Jurídicas, A. C. in favor of the IIJAC Intellectual Community, both those that are free of charge, as well as those that have a preferential cost.

III.- Enjoy the events that are offered for the IIJAC Intellectual Community with the preference of cost, when so indicated in the promotion.

IV.- Obtain its Recognition as a Member of the IIJAC Intellectual Community, when it is accepted by the IIJAC Intellectual Community.

V.- Receive all the certificates, recognitions, diplomas that must be issued for participating in the corresponding events, when this is expressly offered by the Institución de Investigaciones Jurídicas, A. C.

VI.- Issue the certificate of validity as an Institutional Member of the IIJAC Intellectual Community, when requested by the interested party.

VII.- Participate in all offers and services offered by the Institución de Investigaciones Jurídicas, A. C., with benefits expressly indicated for the IJAC Intellectual Community.

VIII.- Receive guidance on issues of Legal Science, when requested by the Member of the IJAC Intellectual Community.

IX.- Request and receive specific information that is necessary for the Member of the IJAC Intellectual Community. As long as it is within the reach of the Institución de Investigaciones Jurídicas, A. C.

X.- The Member of the Community, may express his desire not to be part of this Community when he deems it appropriate, without any formality, at any time.

XI. The others that are determined by agreement of the Board of Directors of the Institución de Investigaciones Jurídicas, A. C. and that will be made known to the Members of the IJAC Intellectual Community.

**Article 16.** The following are obligations of the Members of the IJAC Intellectual Community:

I.- Respect and observe these regulations.

II .- Limit their participation only in study, research and updating activities in the Science of Law.

III.- It is forbidden to disrespect or bother any other member of the Community, as well as the Coordinator or Researchers. All participation must be done with seriousness and respect.

IV.- Debate with total respect, where appropriate, the opinions of the members of the community, when the activity being carried out so warrants.

V.- It is prohibited to carry out any type of activities of a political nature.

VI.- It is prohibited to carry out activities, or demonstrate before the Community, whether in favor of or against performances or activities of government bodies, whether at the federal, state or municipal level, as well as political bodies or international governments, since this Community Intellectual IJAC is International.

VII.- Listen to the various opinions expressed by the Members of the IJAC Intellectual Community, with total respect.

IX.- The others that are determined by agreement of the Board of Directors of the Institución de Investigaciones Jurídicas, A. C.. and that will be made known to the Members of the IJAC Intellectual Community.

#### **CHAPTER IV THE SERVICE OFFERED THE IJAC INTELLECTUAL COMMUNITY**

**Article 17.** The service offered by the professional program called IJAC Intellectual Community, is based on the objective set out in article 2 of this Regulation, which will be carried out virtually, digitally, in person or mixed.

**Article 18 .** The activity of the community will always be carried out Virtually, through the applications that the Board of Directors of the Institución de Investigaciones Jurídicas, A. C. determines by agreement.

**Article 19.** All information will be provided to the Members of the Community in digital form, be it in pdf, wav, mp4, mp3, jpg, etc. format, depending on the material to be shared, through the virtual channels that have been agreed by the Board of Directors, in accordance with article 18 of these regulations.



**Article 20.** Events such as conferences, workshops, courses, diplomas, dialogue table, etc., will be held in person, virtual or mixed. Everything will depend on each event.

A face-to-face event is understood as the direct participation of the public by physically going to the place of the event.

It is a virtual event, one that is developed through the video conference system or digital platform.

And it is a mixed event, one that has both face-to-face and virtual characteristics.

## **CHAPTER V FOREIGN MEMBERS OF THE IIJAC INTELLECTUAL COMMUNITY**

**Article 21.** Foreign Members before the IIJAC Intellectual Community are those people who study Law, Lawyers, Justice Providers, University Academics, who live abroad, and from their country of origin, receive the benefits offered for study, research and update on Mexican laws, International Treaties that bind Mexico, as well as the Jurisprudential Criteria that exist in Mexico and those international criteria that also bind Mexico, and any study related to the Mexican Legal System.

**Article 22.** Foreign Members before the IIJAC Intellectual Community may present their knowledge about the judicial system, procedures and criteria that are based on the *Case Law* in order to enrich the Intellectual Community with the diversity of knowledge.

**Article 23.** Any event developed by the Institución de Investigaciones Jurídicas, A. C. will be held virtually or mixed so that the Foreign Members of the IIJAC Intellectual Community can participate.

**Article 24.** The material that is shared will be provided in the language of the Foreign Member of the IJAC Intellectual Community, as well as in the Spanish language, to preserve the original source.

**Article 25.** Regarding the conferences, workshops, diploma courses, seminars, dialogue tables, etc., that take place either virtually or in person, there will always be a language interpreter, so that the event is fully understood by the Member Foreign.

If a foreigner wishes to participate personally in any of the events such as a conference, workshops, diplomas, courses, etc. organized by the Institución de Investigaciones Jurídicas, A. C., may do so, giving timely notice to the Community Coordinator so that he can be assisted with a translator.

**Article 26.** All the benefits, rights and obligations set forth in this regulation are applicable to the entire IJAC Intellectual Community, without any distinction.

## **CHAPTER VI OF THE DISCIPLINARY PROCEDURE AND THE SANCTIONS**

**Article 27.** In case of violation of these regulations, the Community Coordinator will proceed to contact, in private, the Member of the Community so that they are aware of their actions that go against the regulations, requesting that they not incur in said act again. conduct.

**Article 28.** For recidivism on the third occasion, the Community Coordinator will immediately turn the matter over to the General Coordination of Investigations in accordance with article 13 of these regulations, so that it can proceed to the suspension of the Community Member, permanently. , making the respective annotations in their file and deleting their name from the list of participants on the web.

**Article 29.** The Member of the Community that has been penalized in accordance with the previous article, will not have any means of defense, since the service is totally free; and on the other hand, the right of admission was exercised by the Institución de Investigaciones Jurídicas, A. C.;

**Article 30.** It is a reason to terminate the Member of the Community:

I.- For not complying with any of the obligations that are provided for in article 16 of this regulation.

II.- Being absent in terms of their virtual participation for more than two months. In this case, before proceeding with the withdrawal, the Community Member will be contacted to find out the reason for his absence and ask him if it is his wish to continue.

**Article 31.** Every person, when requesting their participation as a Member of the Community, is aware of these regulations and their scope of service and commitment that they acquired. Otherwise, you will not be admitted until you state that you are aware of these regulations.

## **CHAPTER VII OF THE MODIFICATIONS TO THE PRESENT REGULATION.**

**Article 32 .** These regulations may be modified in whole or in part, provided they are unanimously approved by the Board of Directors of the Institución de Investigaciones Jurídicas, A. C., after hearing the General Directorate of Investigations and the General Coordination of Investigations, establishing the bases of the exposition of reasons attached to the present during a period of 3 days counted from the moment the modification takes effect in the terms foreseen for its validity.

## TRANSIENT

**First article.** These regulations enter into force the day after their approval by the Board of Directors of the Institución de Investigaciones Jurídicas AC

**Second Article.** The Members and Members of the Institución de Investigaciones Jurídicas, A. C. are subject to these regulations.
