

# Seasonal Site Payment Plan Agreement

I, \_\_\_\_\_, am a seasonal camper at Fire Pit Campground and I have agreed to rent the site, \_\_\_\_\_, for the 2026 Camping Season.

- ✓ The 2026 site rent is **\$2200**, and by signing this form, I am electing to set up a payment plan instead of paying the full amount upfront.
- ✓ I understand that by choosing a payment plan instead of paying the site rent in full, I will be charged a non-refundable Payment Plan Fee (PPF) of **\$300**. This fee will be added to the site rent, bringing my total for the 2026 season to **\$2500**.
- ✓ A \$500 Deposit
- ✓ I understand that by electing to pay via payment plan, I will not be entitled to any discounts offered.
- ✓ If my seasonal site agreement is terminated early for any reason, I will not be refunded any money paid and I will remain responsible for the full site rent. Any remaining balance must be paid in full before removing any belongings from the rented site. If the outstanding balance is not paid by termination date, I acknowledge that my belongings may be placed in storage until payment is received, and I will be responsible for any associated storage fees as well as any cleanup costs required to restore the site to its original condition.

Listed below are the payment plan options: *(choose one)*

*All options below are based on a remaining balance of \$2000. The deposit of \$500 is required upfront to secure site.*

## **Option 1 – Weekly Payments**

→ I choose to pay (20) weekly payments of **\$100** each beginning May 1<sup>st</sup> and ending with the final payment paid on September 11<sup>th</sup>.

## **Option 2 – Biweekly Payments**

→ I choose to pay (10) biweekly payments of **\$200** each beginning May 1<sup>st</sup> and ending with the final payment paid on September 04<sup>th</sup>.

## **Option 3 – Monthly Payments**

→ I choose to pay (5) monthly payments of **\$400** on the 1<sup>st</sup> of every month, with the first payment due on May 1<sup>st</sup> and the final payment due on September 1<sup>st</sup>.

## **Option 4 – Custom Payments**
