CONSTITUTION OF THE SCHOOL MANAGEMENT COMMITTEE (AS PER THE RIGHT TO EDUCATION ACT, 2009 AND APPLICABLE LOCAL RULES)

1. Name of the Committee:

This committee shall be called the School Management Committee (SMC) of Holy Angel's Academy, New Impa, Tousem Sub- Division, Tamenglong District.

2. Objectives:

To ensure effective functioning of the school. To monitor school performance and support quality education. To involve parents and local community in school governance.

3. Composition:

The SMC consist of 10 members, constituted as follows: Parents/Guardians of children enrolled: 3 Elected Representatives of the Local Authority: 2 Head Teacher/Principal: Ex-officio member Teachers of the School: 2 Social Worker/Educationist: 2

3. Tenure:

The term of the SMC shall be 2 years from the date of constitution. Members may be re-elected/re-nominated.

4. Powers and Functions:

Monitor attendance and learning of children. Ensure enrolment and retention of all children. Advise and support school staff in academic and administrative matters.

5. Meetings:

The SMC shall meet at least once in two months.

Quorum: Minimum 50% members must be present.

Minutes shall be recorded and maintained by the Member Secretary (usually the head teacher).

6. Funds and Utilization:

The committee shall oversee the use of school grants transparently.

All expenditures must be approved and recorded.

7. Amendments:

Any amendment to this constitution must be approved by a two-thirds majority of the committee members and ratified by the appropriate authority.

8. Dissolution:

If the committee is found inactive or in violation of norms, it can be dissolved by the competent authority, and reconstituted.
