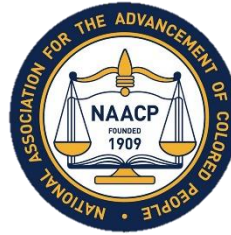

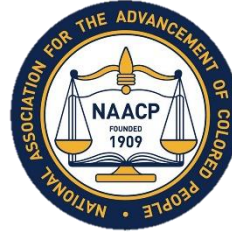

The mission of the National Association for the Advancement of Colored People (NAACP) is to secure the political, educational, social, and economic equality of rights in order to eliminate race-based discrimination and ensure the health and well-being of all persons.

Additional Vendor Information

Event Location and Parking: The Breakfast will be held at the North Greenwood Recreation Center 900 N. Martin Luther King Jr. Avenue, Clearwater, FL at 9 a.m. The March line-up will commence at 10:30 a.m. The Rally will take place at the Buccaneer/ Walter C. Campbell Sports Complex located at 905 N. MLK Jr. Ave., Clearwater, FL, immediately following the march. Vendor Booths will be set-up in the interior west side of the Buccaneer Football Field. Vendor Parking will be on the west side of the field in the North Greenwood Library Parking Lot.

Set-up/Break Down: Vendors may begin set-up as early 9:30 a.m. and should be ready to receive patrons no later than noon. Break Down should not commence until the conclusion of the event at 2 p.m.

Vendor Spaces will be allocated on a first come first serve basis for the following minimal fees. (A \$5.00 convenience fee will be assessed on all credit or debit card payment processing)

For-Profit Vendors - \$25.00 which includes one 6" table and 2 chairs.

Non-Profit Vendors - \$10.00 which includes one 6" table and 2 chairs.

10 x 10 tents will not be provided however we invite you to bring your own if you so desire. *(No stakes permitted)*

Vendor Types - All Vendors must be of a family-friendly nature. The event staff reserves the right to refuse any prospective business that does not comply with these guidelines.

Electricity: We are unable to guarantee access to electricity during the event.
