In The Beginning

Question: "Scott, what in the world possessed you to become an Exorcist?"

I was 42 years old, had been a Christian for 12 years, and was sitting in my usual seat at church. The Pastor asked the 3000 people in attendance a simple question: "How many of you have been sitting in church and studying the Bible for 10 years or more, and have never done anything with all that knowledge?" He then asked, "What are you planning to do with it?"

I was guilty, but the answer that definitely struck my head was, "Nothing!" I was 100% content to sit in church for one hour a week, and study the Bible daily. I had no plan to ever do anything more.

Let me back up a little...During a family move when I was two years old, some oven cleaner was inadvertently left unsupervised. I drank some of it, and severely burned and scarred my esophagus. I had to learn how to cope with what and how I could swallow from that point on.

At breakfast, the morning after the Pastor's question, my throat swelled completely shut. I couldn't even swallow water. A doctor scoped me, took nodule samples, and sent them out for biopsy. There was a 95% chance that the samples were cancerous. If the biopsy came back positive, life expectancy was less than two months. I was in shock.

On the way back from the doctor, I listened to a Christian radio program where a Pastor was ministering to a woman who professed to have demons. As I listened, the demon spoke out of her in a deep male voice. After a brief fight, the Pastor cast it out of her. She instantly felt better.

I was transfixed by the program. I thought, "No Way! This can't possibly be real!" The next day I called the Pastor's office in Denver. One of his assistants said he had a small deliverance team in Phoenix, and if I would call the team leader, he might allow me to attend a private session. I called and was granted permission.

A tiny, sixty year-old woman entered the small prayer room. She was head of the women's ministry at very large church. She still suffered greatly from the effects of a rape that happened when she was 17 years old.

The minister skillfully triggered a 17-year-old multiple personality that was created from the trauma of the rape. She was instantly being raped in her mind, and was crying hysterically. Jesus took the pain from that wound, and in a moment, the crying stopped. There was complete peace.

A demon angrily manifested and in a male voice declared, "My name is Rape and she's mine! I'll never let her go!" The minister asked the demon if it still had a "legal right" to stay in that wound. The demon softly

growled, "No". He was cast to the pit, and the woman joyfully raised her hands and praised God.

It was amazing to watch. No one could fake what I just saw with my own eyes! It was like the Book of Acts coming to life.

Prior to the deliverance, I was instructed by the minister to observe, keep my mouth shut, and pray. As I was watching and praying, the words of the minister, the multiple personalities, and the demons were flashing in my mind. I was hearing all the words, before they were actually spoken!

When it was all over, I realized that my prayers were really in the game, and part of the battle. I decided that I was going to do this for the next two months, and then most likely die. I was also sure that I could never do what that minister did (actually cast out demons). It was much too difficult for me.

Three weeks later, the biopsies came back negative. I didn't have cancer, and I didn't die. Here I am 18 years later, having performed over 10,000 deliverances, and trained over 5000 people to be exorcists.

To paraphrase Isaiah 61, The Lord told us to: Preach the Gospel, Heal the Brokenhearted, and Set the Captives Free. In the following chapters you'll learn the rules that Satan has to play by, how to heal the broken-heart at the deepest point, how to defeat every demon, and a simple way to lead your unsaved friends and loved ones to Christ.

Healing the Broken Heart..."Alters"

Question: What is an "Alter"

When we're talking about healing the broken heart, we are talking about what we call in the deliverance ministry, an "Alter". An Altar is a wounded part of our soul. We're a three part being: Body, Soul, and Spirit.

The Spirit is what's born again, your Body is your physical body, and your Soul (oversimplified) is your Mind, your Will, and your Emotions.

When we get hurt badly enough that we can't cope with something, we disassociate. When we disassociate, we just kind of go away in our mind, and that (going away) creates a tiny split (a wound) in our soul. If you get hurt many times, you can have many of these splits. When we get one of these wounds, instantly demons enter. This is where they torment us, and this is where they stay until the wound is 100% healed all the way down at the root.

The medical community has many names for these wounded parts of our soul: Bipolar, MPD (Multiple Personality Disorder), DID (Dissociative Identity Disorder), Alternate Personalities, PTSD (Post Traumatic Stress Disorder, BPD (Borderline Personality Disorder). They are all just wounds, but different manifestations of wounds. The slang term "Alter" comes from the term "alternate personalities". I hate the term "alter" because it causes confusion, so when I'm speaking to a client, I just call them "wounded parts". In this ministry we heal them and treat them all the same way.

We are focused on the wounds because **Healing the wounds is the key to defeating the enemy and achieving total freedom.**

Question: Scott, can all mental illness be attributed to these wounds and demons?

Answer: I've observed that a great majority of mental illness is from being wounded and the torment that the demons inflict on the wounds. Some mental illnesses are birth defects, some are damage that is done by drugs and alcohol, some are damage from physical accidents, and some are actual physical damage done by the demons themselves.

The Cause and Creation of Alters

Alters are created buy one word, <u>trauma</u>. Physical abuse, verbal abuse, or sexual abuse, resulting in an overwhelming emotion or pain that the core person can't handle, are obvious traumas. But children have almost no coping skills, so they get hurt badly enough to disassociate over very small things.

Below are a couple of examples of how easily children get hurt, and it can affect them for their entire life.

I was ministering to a 58-year-old woman who was tormented by inadequacy and never felt good enough. She was youngest of four children. All four were a year apart. When she was in kindergarten, their mother dropped them off at elementary school. She handed each child a quarter to pay for their lunch and milk, but when she got to the youngest child, all she had left was a nickel. It hurt the kindergartener so badly that she disassociated, and the pain continued even to the day we met for ministry.

I also ministered to a 48-year-old man who was tormented by rejection. When Bob was three years old, his father came home after a hard day at work and dropped into his easy chair. Bob was so excited to see his dad that he ran up to him squealing "Daddy! Daddy! Daddy!" His father needed just a moment of quiet after his difficult day, and he roughly pushed Bob aside. The little boy was crushed and disassociated from the rejection. It had tormented him his whole life.

The Alter's whole purpose is to hold the pain so the person can go on with their life, even after trauma. It's like a little file in the back of your mind. It's a wonderful little coping mechanism that God created.

Question: Does everyone have these type of wounds?

Answer: People can have no altars, they can have one, they can have 100, or they can even have tens of thousands. If you get into this ministry, you're going to find people who have been satanically ritually abused. Their parents were Satanists and intentionally created these wounds specifically for the purpose of demonizing them. Very few people get through life without being wounded. Altars can be created as early as in the womb, and also in people who are over 90 years old.

EXAMPLE:

You'll see a 14-year-old girl who turns up pregnant, and she's not ready to have a baby. She's talking about abortion, and the baby can feel that rejection. A serious disassociation takes place. Or maybe the girl's 50-

year-old boyfriend doesn't want to quit school to support this child. When the mom-to-be is seven months along, the boyfriend pushes her down some stairs, or punches her in the stomach in an attempt to create a miscarriage. What do you think happens to that baby? A dissociative part is created. That baby, now an adult, comes to me thirty years later saying that they felt rejected, and unwanted right from the womb.

As your coping skills increase, fewer and fewer altars are created. If I snuck up on a three-year-old little child in a grocery store, bent over and screamed at the child, that would probably be too much for the child handle. If I did that to a sixty-year-old adult, they'd probably just turn around and tell me to buzz off, because they're coping skills are better. I've done deliverances on over 10,000 people and only found a handful that didn't have any wounds. And I'm not sure they were entirely honest with me.

What are the characteristics in the effects of these wounds?

People who have disassociated from wounds are highly intelligent. When a deep wound is created, a tiny little personality is created that stays at the age that the person was when the trauma occurred. So if they have 5,10, or even 500 tiny personalities, then it takes a lot of mental horsepower to keep all that straight, so they are very intelligent! I've ministered to billionaires, bums, housewives and hookers. It seems like everyone has been hurt somewhere in their life.

Some of the effects of these deep wounds are <u>depression</u>, <u>cutting</u> and <u>emotional overreactions</u>, such as panic, anxiety, rage... very large emotions over relatively small incidents. We all know people who have buttons, people who explode with rage over insignificant things. If you'll

watch their eyes during this emotional explosion, at some point there will be one or two big heavy blinks and all of a sudden, the emotional outburst stops. You are witnessing an alter that has been triggered. Once the alter is healed (and the demon gone), they stop having emotional outbursts.

Depression is the number one effect of these deep wounds. It normally comes from a wound that's been triggered. It's full of emotion and there's nowhere for that emotion to go. What do you think happens to the person? Down they go with their emotions and they get depressed! So when you get the wound healed and the demon gone, the depression leaves.

I've ministered to over 800 cutters. People can cut in many ways. Some cut their flesh, bite the fingernails down till they bleed, pull hair, break bones, burn themselves, or even cover their bodies with tattoos and piercings. We seem to be able to hurt mostly in one place at a time. The cutters who I've ministered to are not trying to kill themselves, they just hurt badly on the inside, and they want the pain to stop. They cut on the outside, and the pain on the inside stops.

Many of the cutters I've ministered to are covered head to toe with tattoos and piercings. I inquire about the hours that the tattoo artist spends filling in color. I say to them, "That must really hurt, what do you do when they are filling in all that color? and they all say the same thing. "Oh, I just go to sleep." They are at absolute peace.

Question: Scott, is this Biblical? Does the Bible talk about Alters?

Answer: The Bible doesn't specifically use the term "Altars" to speak about wounds. It does speak about the broken heart, and how important broken hearted people are to the Lord. Psalm 34:18 tells us that: The Lord is near the brokenhearted, and saves those who are crushed in spirit. Isaiah 61:1 speaks of the Lord being sent to bind up the brokenhearted. Healing the broken heart is apparently <u>very</u> important to the Lord.

In the fifth chapter of Mark, Jesus deals with the man who is possessed by a demon named "Legion". The man is described as living in the tombs and able to tear chains and shackles to pieces. Constantly, night and day screaming and gashing himself with stones.

When we dissociate, demons instantly enter. They torment the wounds that are already at an extreme emotional level, and a huge amount of adrenaline can be released. This man was breaking chains, a sure sign of elevated adrenaline. The man was also gashing himself with stones, a classic example of a cutter. I've ministered to over 800 cutters, and this man was a cutter. He had Alters...and probably lots of them.

Another example of alters is the woman that Jesus met at the well. Jesus told her of her many husbands, and of the man she was currently

living with. What do we know for sure about this woman? We know for sure that she's not running around on all these husbands. How do we know that? Remember what they did to adulterers... they stoned them. We can also assume that she was attractive, she's been married to five men and is currently living with another.

This woman has been divorced by five men, rejected and abandoned. Just imagine the wounds she must have. With the wounds, she's going to have tons of emotional overreactions. She's very attractive but she's driving her husbands nuts with the emotional roller coaster. They've finally had enough and they dump her. This woman had Alters.

Another indicator that a person has deep wounds is that they have <u>lost</u> <u>time</u>. They may tell you they have no memory before the age of nine. Or that they have no memory from first to third grade.

When we dissociate, we just kind of go away in our mind. And we can go away for just a second, a day, or even years. You stay away in your mind until you are able to handle what happened to you. So if someone tells you they have no memory from first to third grade, when was the trauma that caused that to happen? It happened in the first grade! They just went away in their mind for two years, and then at some point snapped back.

You'll find it's very common for the core person to be amnesic, partially, or fully conscious of traumas. I suspect that the Holy Spirit holds back some of the memories so you can better function in your life.

Question: Isn't this just psychology?

Answer: Part of this is studied in psychology. Not everything in psychology is wrong. They just don't have the cure for these problems. They teach people coping skills, but the problem still exists. It's sheer exhaustion trying to stuff all this down and continually coping with all the internal pain.

Another good indicator that people have been hurt is having trouble reading the Bible or praying. Remember the altars have demons on them, who are lying to the altars. They may be telling the alter, "If God really loved you, he wouldn't have let this happen to you. He doesn't even care! I'm the one who loves you...Just go to sleep." People with wounds may have a piece of themselves that is fighting their efforts to get close to The Lord. Once you get the wound healed and the demons gone, their prayer life gets better, and their ability to read the word improves.

Okay, this is one of the most <u>important</u> things I'm going to tell you about altars. **Alters know why they were created!** They know their job is to hold a specific pain or emotion. So when you get these little personalities up and talking, the first and most important thing you're going to need to find out is the **emotion** that it holds.

There are three bits of information that you want to gather from the altar, and there are three things we are going to do with that information. You'll

need to find out **the emotion**. You'll need to find out **the age** of the alter. (Remember, the alter stays at the age the person was when the trauma occurred. So you don't want to be talking to a five-year-old alter like a 45-year-old or vice versa.) You'll also want to know **what happened**.

We'll then do three things with that information. First, we'll ask Jesus to come to this wounded part. The Lord says in His word that He is closest to the brokenhearted; so if you can trigger these parts, Jesus comes every time. I've done this thousands of times, and Jesus performs EVERY time... He is faithful!

Once the Lord has healed the wound, I have the alter declare, "I break the curse of (the emotion the alter holds)." I then ask the little personality if it can forgive the one who hurt them (and most of the time, it will forgive). I'll show you a little later what to do if the altar won't forgive.

When the altar has forgiven, I just tell it to "Go with Jesus." I don't know what the Lord does with them. He may merge them into the core person or He may just take them away. I have many say that they saw the child walking away or being carried by Jesus. Others say they just felt it lift. Either way, if you try to trigger the wound again, the alter does not come up. It's just gone, and there's no pain in the memory.

- 1. What's the feeling you hold for (person's name)?
- 2. How old are you?
- 3. What <u>happened</u> to you?
- A. Jesus, please come and take the (emotion).
- B. I <u>break</u> the <u>curse</u> of (emotion), and <u>forgive</u> (perpetrators).
- C. You just go with Jesus.

Healing the Woundedness: How the World does it, how the Church does it, and how We do it.

The world relies on counseling, self-help books, therapy, and psychiatrists. They're doing a great job talking to the soul, but they rarely get down to these multiple personalities. And if they do, they don't know what to do with it, and it's still there after working with it for many years.

If you go to **the church** and tell your pastor "I have anxiety, I have rage, I have this or that emotion", he's going to tell you to read your Bible more, pray or go to church, listen to praise and worship, and/or get some Christian counseling. He's doing a great job of feeding your spirit, but he's never getting down to the wounded parts of your soul.

If you go to your doctor and tell him you have anxiety, rage, or emotional problems, the doctor well just drug you. The drugs just mask the body. When the drugs wear off, the problem is still there.

So here's what we're going to do. First of all, there are multiple demons sitting on the wound, and they're going to try to interfere. So we need to

get the demon off the wound. We are going to use the Word of God in Hebrews 4:12 to get the demon off the wound. When you declare "I divide soul and spirit", instantly the demons come off the wound. And now you can work with the wound without interference. Then we are going to trigger the wound and ask the Lord to come. The Lord says He is closest to the brokenhearted. He comes and does one of two things: He just takes the emotion, or He brings truth to a lie. And instantly, the wound is permanently healed.

EXAMPLE:

I'd done about 250 deliverance's when I finally found the two main ways that Jesus heals wounds. I felt pretty accomplished and that I could handle just about anything. I'd run into many alters that caused me problems during the deliverances, and had somehow worked my way around them and through them.

One day a call came in from London, England. It was from a girl (we'll call her Julie) in her mid 30's who told me she'd gone catatonic four or five times in her life. She explained that when she went catatonic, it had been for a minimum of six weeks and for as long as four months. She couldn't even feed herself, had to be institutionalized each time, and it was very disruptive to her life. This woman was pretty, had been to Oxford, and was extremely bright. She asked if her problem was something that I could handle, and I said yes. So she flew over to the USA to have an in-person session.

Julie and I met at the home of a local pastor, and both he and his wife were in attendance. I asked Julie if she had any idea what triggered the catatonia. She said "I believe it has something to do with rejection." I asked what incident triggered the last catatonia. She said, "My last boyfriend dumped me." But she also told me that she believed the problem started much earlier in her life.

I told her that I wanted to take her back to the moment that her boyfriend dumped her. She was very hesitant because she was afraid that it might trigger the catatonia, and didn't want to end up in an institution in the US. It took some convincing but she finally agreed.

She was sitting on a couch and I was in a chair directly in front of her. I took Julie back to that terrible moment with her ex-boyfriend. She yanked her knees up under her chin, her lips pursed, and her eyes squinted almost shut, starring straightforward...they didn't even blink.

I divided soul and spirit according to Hebrews 4:12, and I began talking to what looked like a tiny little child. Her eyes and her body were frozen perfectly still. For over 20 minutes, I did everything I could to get this child to talk. I changed tactics, and and attacked as if it were a demon, still nothing! Now it's been almost forty minutes, and I'm getting absolutely nowhere. I finally worked and worked just to try to get Julie back, and still got nothing...she was catatonic! The thought flashed through my mind, "Oh no, this girl might have to stay in the US for four months or so!"

It suddenly dawned on me to ask Jesus to come to this little child. When I did, her squinting eyes popped wide open. I asked the child if Jesus had spoken to her, and she nodded yes. I asked if Jesus had taken away her pain, and she nodded yes. I asked her how old she was, and in a tiny voice squeaked "I'm 2 1/2." I asked her, "Who hurt you?" She said, "My Daddy pushed me down and told me I was in the way of the TV". I asked her alter how she helped Julie, and she said, 'I'm invisible, and I ignore!" I asked the 2 1/2-year-old what Jesus said to her and she said, "Jesus whispered, I can see you, and I'll never reject you."

The 2 1/2 -year-old personality was instantly healed, Julie snapped out of the catatonia, and we cast out the demons that were tormenting the wound. It's been 10 years since. Julie is now happily married and does not go catatonic anymore.

As a 2 1/2-year-old, Julie was blocking the TV, and her father rejected her. The child disassociated from the pain of <u>rejection</u>, and was getting even by <u>ignoring</u>. She didn't want to be in the way of the TV, so she became invisible. Apparently, the same little multiple personality came up and took the pain each time Julie got rejected. But just a few words from Jesus healed this problem permanently!

The Relationship between Demons and Alters

The trauma, or a resulting emotion from the trauma, is an entry point for demons. The emotion the the altar holds, or a lie that it believes is a legal right for the demons to stay, is also the name of one of the demons the on that wound. So when someone says to you "I am tormented by anxiety", what are they really telling you? They're telling you that they have a wound created by anxiety and have a demon on that wound with the name of Anxiety, and he is tormenting that wound. He is exaggerating the emotion that is already held in that wound.

As ministers, we never have to worry about a demon physically hurting us because God's Word says in Acts 10:19 that we are given **all** authority over the power of the enemy and nothing shall hurt us. But, the second most important thing that I'm going to tell you about alters is that **they can physically hurt you!** They are not bound by God's Word. They are just a part of the person. So if you've got an altar that holds rage, and a demon

of rage is tormenting it, that wounded part of the person can come up and hurt you.

EXAMPLE:

I've ministered to over 10,000 people, one by one. I've only been hit twice, and it was a woman both times! They'd both been raped. One was almost 70 years old, and she had been raped as a teenager. One second she was sitting quietly in front of me, and the next moment, she triggered and was being raped in her mind. She swung and clipped me across the top of the head before I could even duck.

The other girl was about 20 years old. She'd also been raped in her teens. She was sitting quietly, and when I triggered her, she lashed out quicker than a cat and clawed me. I had four perfect claw marks running across my neck.

But I've never had a single student get hit because of what I'm going to explain to you now. What we are going to do is what I call "**Self-Talk**", and if you do this, no one will ever lay a hand on you.

I have a person speak to the wounded parts of themselves. I have them repeat after me: "I want to be healed, and I want you to be healed. I'm safe now, and Pastor Scott is safe. I love Jesus and I want every part of me to know Him. I want you to come up and answer Pastor Scott's questions."

The most important thing that I do is to have the person open their eyes and look at me. I tell the wounded parts to look out of this person's eyes and see that I am safe. The Lord says He's closest to the brokenhearted, and the altars see Jesus in me. They feel safe, and they never lash out even in the middle of a trauma. If you do nothing more than have them look at you, you will never get hit!

How to Get Alters to Talk

There are a lot of things working against you when you're trying to get at the root of these wounds. First of all, the core person may be nervous, or scared, or not know what to expect. They may be distracted, never have heard of disassociation, and maybe even embarrassed that they have brokenness. And on top of that, they have demons on the wounds that don't want you getting down there.

So the first thing you have to do is to find a wound. The simplest way to do this is just to ask a question: "What's the worst thing that ever happened to you...especially as a kid?" Everyone will look up and say "Oh, as a kid", because most people think adult traumas are the worst things whatever happened to them. But remember, as children, we have no coping skills. So even the smallest thing can make us disassociate.

EXAMPLE:

So this man, (we'll call him Bob) says to me, "Oh, as a kid! When I was about four years old, my uncle beat me really badly." So I jot this down.

Now I'm going to get some details from the trauma. And I'm specifically looking for sensory items: sounds, smells, tastes, things that were said. Sensory things can trigger a wound instantly.

So I ask him "What happened?" and he says, "My folks were going on a second honeymoon for a couple days, and they dropped me off at my uncle's farm." And I ask him, "Then what happened?"

He tells me that sometime in the day his uncle approached and gruffly said, "I'm going to go outside and do some work, and don't you touch my stuff." And I asked Bob, "Then what happened?"

He said, "Well my uncle went outside to work, and I ran on upstairs to his bedroom and started 'touching his stuff'. Remember, he's a four-year-old kid. So I ask again, "Then what happened?"

"Well my uncle quietly slipped into the house, and snuck up the stairs. He burst through the door said 'I told you not to touch my stuff!!!'
"Then what happened?"

"Well he grabbed me by my hair and shirt and dragged me down the stairs, down to the basement steps and threw me down those stairs onto the cold cement floor!" I'm taking notes of all these details, noting Bob's exact words, especially the cold cement floor(it's a good sensory item).

"So then what happened?"

He reached back, grabbed a small board off the wall. And he whispered, "I'll teach you to never touch anybody's stuff."

I asked Bob, "What was the matter with this guy? Was he drunk? Was he high? Bob said, "I don't know, but I could smell cigarettes, and I hate the smell of Winston's even to this day."

I asked, "Then what happened?"

... "Well, he started hitting me with that board."

Were are you screaming; were you yelling?

... "Yes, I was screaming!"

What were you screaming?

... "I was screaming Stop, Stop, Stop!"

And I asked Bob at the worst of this, "What was the emotion?"

..."I don't know, I just kind of blanked out."

Well, what do you think the emotion was?

... "Well I suppose it was terror."

Okay, I now have tons of information to trigger Bob, probably 10 times what I actually need. Now I'm going to take him back to the trauma. So I tell him, "I'm going to take you back to your uncle's farm. I want you to see it, hear it, smell it, and taste it. I mean really go there!" And he says okay.

So at this point, I do some Self-Talk and make sure he looks at me right my eyes. Bob is a big guy, and the last thing I want is for him to hit me.

So now I declare "I divine soul and spirit, and I want the four year old who is back in Ohio, there at your uncle's farm;

- ..that four-year-old whose uncle says those words; whose uncle sneaks up the stairs and bursts through the door and declares, 'I told you not to touch my stuff!';
- ..that four year old who got grabbed by the hair and the shirt and drug down the stairs, all the way down to those basement steps;
- ..that four year old who heard, 'I'll teach you to never touch anybody's stuff!';
- ..that four year old who could smell cigarettes and who Bob says he hates the smell of Winstons even today;
- ..that four year old who's getting hit by that board;
- ..that four year old who's crying and screaming stop, stop stop!!
- ..that four-year-old who Bob said felt terror.
- ..that four year old. Can you hear me?

And Bob nods his head and says, Yes.

Okay, Bob has started out sitting here with his eyes closed, and he's right there with me, but as I regurgitate the details that he's given to me, and as I use the age prior to **each** detail, Bob is beginning to slip into the backseat as he is playing out the memory in his mind. Bob is triggering himself!

And I say to the four-year-old, "What's the emotion you hold for Bob?" And he says, "Guilt." Now that is interesting because Bob thought it was terror. It's very common for the original, assumed emotion to be different from the actual emotion described by the person who dissociated during the trauma.

So now if you think back to the scenario, where was it that Bob actually disassociated? It was upstairs in the bedroom when his uncle burst in the door and screamed, "I told you not touch my stuff!" He disassociated because of the guilt.

Now I'm into the Alter Script, and I know the emotion, and the age, and what happened, so now I just say, "Jesus come now." And the Lord does one of two things: He either just takes the motion, or he brings truth to a lie.

And this isn't on the script, but I always ask the altar, "What's Jesus saying about the emotion?" There's a slight delay and the four-year-old says, "There's no condemnation in Christ." And instantly the wound is healed!

Now I have the alter declare, "I break the curse of guilt." Then I ask that four-year-old if he can forgive his uncle, and he says, Yes. So now I tell that four year old, "You just go with Jesus; Bob can handle it now." And this wound is permanently healed.

So, you see what I'm doing? I'm gathering the details, I'm doing the self talk, I'm triggering the wound, and I'm asking Jesus to come.

He says he's closest to the brokenhearted, and He comes EVERY time.

Problem Alters

When we're doing inner healing and deliverance, the demons are simple. They either have a legal right to be there or they don't. Alters are not bound by the Word of God. They are just part of the person, and they can cause you problems when you're ministering to the person.

- 1) You're going to encounter angry alters that have been hurt. They have a right to be angry, and don't want to let go of the anger.
- 2) You're going to encounter protector alters wounded parts that have been hurt many times. They've gotten tough, and they pop up and stop you from getting down to the other alters.
- 3) You're going to encounter very self-destructive alters, alters that self-sabotage a person's life. They may quit jobs just to keep from getting fired. They may end relationships prematurely, just so they don't get rejected.
- 4) You're going to encounter hysterical alters, and I don't mean hysterically funny. I mean one minute the person seems calm, and the next minute you've triggered the wound, and they are screaming at the top of

their lungs, over and over and over. It's so loud you think the cops are coming any minute.

These are just a few of examples of <u>problem alters</u>. So what I'm going to teach you is how to handle every problem alter, simply. For instance, you have an alter that's been hurt, and it's mad and it's got a right to be mad, and won't let the anger go. So what should you do here? Ask the alter, "Would it be okay if I ask Jesus to come and speak to you about the anger?" And when it nods yes, ask Jesus to come, and the Lord just says something very simple, like "I'm the Prince of peace." And instantly, the wounded part is healed.

At times a Protector Alter pops up when I'm trying to get to other hurts and declares "No, no, no one gets down there. Everyone who gets close to her hurts her." So I ask that protector part if I can ask Jesus to come and talk to it about protecting. And it says "Yes, but make sure he stands far away, because He's a man and men hurt." (Maybe this woman's been hurt by every single man in her life.) Jesus is a gentleman, He stands back and says to her, "I'll be your hedge of protection." And instantly that wound is Healed.

Now that protector alter might even help you bring up other parts because it probably knows all the rest of them.

You may also have <u>hysterical alters</u>; ones that come up screaming, and you can't ask it questions like, "What's the emotion, or how old are you

and what happened?" It's screaming at the top of it's lungs. So I ask Jesus to come again.

What do you think Jesus does here? Remember there are two things that he does: brings truth to a lie or just takes the emotion. What's He going to do here? He just takes the emotion, and instantly the screaming stops.

There may still be some tears, but the explosive emotion stops. Now I'm able to ask the alter what the emotion was, and it says "Terror". So I have the alter break the curse of terror and forgive the person who hurt them, and then go with Jesus.

Generational Alters

Generational alters are a memory imprint of a trauma that has happened in previous generations. It's an imprint that is right in the DNA coming through the bloodline. This is how Satan brings curses from generation to generation. We've all heard of generational curses, and this is how we get them. Each generational demon has a generational alter.

You call a generational alter up by asking for "the one that cries out from the blood...the one that was there at the root of the curse."

Important Odds and Ends

- 1) Switching: This is what happens when the person changes from the core (original) person to an alter, or from an alter to a demon, or from a demon to another demon, or just back to the core person. You'll notice these switches by carefully watching the eyes. You'll see a very big, heavy blink or a couple of big, heavy blinks, and when you do, you'll probably be talking to something or someone else.
- 2) <u>Is it an Alter or Demon?</u> They're going to be times when you can't tell whether you are talking to an alter or a demon. Some alters act like demons and visa versa. So, if you're not sure, just ask one question, "Are you spirit or flesh?"

If it's an alter, you're going to get one of two answers: "I'm flesh" — or most commonly, it'll say, "I don't know." This is because it's probably just a five-year-old little child alter, and it doesn't know what you're even

talking about. But if it's a demon, you're going to see why Satan fell from heaven. Remember, he fell from pride, and when you ask that demon, "Are you spirit or flesh?" he'll rise up a little bit, and you'll see that pride. Then he'll tell you, "Oh I'm spirit!" He doesn't want to be some lowly, little piece of flesh.

You may have seen a deliverance in a church or on YouTube where the person may be rolling around the floor and the elders or the pastor's screaming, "Come out in the name of Jesus! Come out in the name of Jesus!" Or they may be hitting them with the Bible, holding them down, or pouring holy water on them. But, if you look down and see a tear, that's not a demon — because **demons never cry**. What has happened here is that the demon has just gone down and switched, pushing up an alter, and now these people are yelling and screaming at a alter, not a demon, commanding it to leave. So the moral to the story is, don't ever scream and yell.

If it's a demon, and it doesn't have a legal right to stay, you can just whisper, "Go, in the name of Jesus", and it will go instantly. If it does have legal right to be there, you can scream and yell until you're purple. It's not leaving, because it doesn't have to. There is never an excuse to yell and scream.

DEMONS

Question: What is a demon?

A demon is just a fallen angel, destined for the lake of fire. It's not a disembodied Spirit of one of your long-lost relatives. It's not one of the Nephilim; it's just a fallen angel. And Satan is their boss. One-third of the Angels followed Satan when he decided to try to make himself like the "Most High".

The Bible says their purpose it is threefold: to Kill, Steal, and Destroy.

They have absolutely no redeeming qualities They are pure evil!

And just a quick note here — Never cast demons out of non-Christians.

When the Bible talks about the demons coming back seven times worse, it's because the Holy Spirit can't fill the non-Christian, and the emptiness is then filled when the demons come back, seven times worse. Nobody taught me this, so I had to learn the hard way...

EXAMPLE:

I was a relatively new minister when a girl (we'll refer to her as Sarah), in her late twenties, accompanied by her boyfriend, came in for deliverance. The girl headed for the bathroom, and I asked her boyfriend if she was a Christian He said Yes. We proceeded to healed a bunch of wounds, and cast out a bunch of demons. The two of them left in their car and headed down the freeway to their home. As soon as they hit 75 MPH, Sarah (who was sitting in the passenger seat) tried to jump out of the car. Her boyfriend caught her by the hair as she went out the door, and drug her back in. They headed straight back to the church.

After hearing what happened, I called up one of the demons that I had cast out, and he immediately manifested. I asked him what he was doing

there. He told me he had returned with seven more. I asked him what right he had to return. And he told me, "She's not a Christian!"

Lasked Sarah if she was a Christian. And she told me, "Lused to be, but Christianity doesn't work!" I asked her to explain. She said that she'd only been to church one time in her life, and had no idea what message was preached. At the end of the service, the pastor asked everyone in attendance for a show of hands if they'd like to go to heaven, and of course, everyone's hands went up. She said the the pastor told the congregation that if they would just say, "Jesus, come into my heart," that they would have peace, love, joy, prosperity, and everlasting happiness!!! So she said those five words.

The next day, she found out her boyfriend was running around on her.

Two days later, her dog ran away, and soon after, she lost her job and her car. So she said, "Christianity doesn't work!!!"

She had zero understanding of the gospel message, and had no idea that sin, and Jesus's death, burial, and resurrection, were even involved.

I knew right then that I had to be much more careful before casting out demons.

KNOWING FOR SURE...

When I sit with someone now, I ask them if they have a Christian background. If they say Yes, I ask them if they ever get out and share their

faith with others. The vast majority say No. Research says that 95% of Christians never lead anybody to Christ.

So I ask them where the black and white line is that gets you into heaven. I take them off track as quickly as possible by telling them that I want to go to heaven. I'm a really good person. I've been to church. I've given money, and I've walked little old ladies across the street. And I ask them, "Am I going to heaven?"

They look at me strangely, and many will say "Yes. You're a good person, so you're going to heaven." I then tell them, "But I'm not really a good person. I sinned a lot", and I ask, "What about my sin?"

After a short pause, many will say, "Well you haven't killed anybody, have you?" I reply, "But the Bible says that if I'm angry without cause, I've committed murder in my heart." So I asked them again, "Am I going to heaven?" And most will say, "Well you seem like good person, so you're probably going to heaven."

I'm doing everything I can to help them get the word "Jesus" to come out of their mouth (without actually saying it). If the "J" word doesn't come out after all these hints, I believe we may have a salvation problem, and I'm not going to cast out demons until I know for sure, (or to the best of my ability.)

I use this method to test for salvation (to the best of my ability). I haven't had a single problem since. I'll get into how I actually lead them to Christ a little later in the book.

Question: When ministering, what keeps a demon from hurting us?

Well the **answer** is, the Word of God. Luke 10:19 explains that Jesus gives us all authority over the power the enemy and nothing shall hurt us. So when you're doing deliverance on someone else, you <u>never</u> have to worry about a demon hurting you! They can't jump off the other person into you. They can't enter you after you cast them out of another person. They can't enter you if you lay hands on someone else, or if they lay hands on you.

The demon has to have a "legal right" to enter you, and none of these are legal rights to enter! We"ll talk about "legal rights" a little later.

Little known Facts about Demons

- .. They have very different personalities, just like people.
- ..Some of them will threaten your life.
- ..Some are sarcastic.
- ..Some have a sense of humor (although a very dark and sick one).

..All of them will lie.

(But I'll show you how to spot the lies and stop them.)

- ..Some of them are very technical (and they won't go, unless you know how to beat them at their own game).
- ..Some of them will tattle on each other, like little children.
- ..Some of them are dumb.
- ..Some of them are devious.
- ..Some of them come up speaking other languages, but they ALL know English; they all know every language. So if the demons try to do this, just tell them to "Knock it off, speak English!" And they will speak English.

..Demons work in a hierarchy, kind of like an Army. There are very low-ranking demons like privates, all the way up to what you would consider a General.

.. You'll see divisions of demons.

..You'll find sex demons all grouped together on wounds that were caused from sexual trauma. So if there's been a molestation, you'll likely see the spirits of rape, molestation, perversion, homosexuality, pornography, masturbation, and many other demons of a sexual nature.

..lf someone has disassociated because of anger, you'll see a group of demons related to anger on that wound — unforgiveness, bitterness, resentment, retaliation, anger, hatred, violence, murder, and other demons associated with anger.

...If the wound was created by fear, you'll likely find demons of terror, panic, anxiety, worry, and stress.

..You almost never find only one demon on a wound. That's because the first demon to enter acts as a gatekeeper. He lets in many other demons that are like himself.

Here's a Special Note: There is a chief demon on each wound (that is over all the other demons on that wound). Also, there is **aways** a demon (of some kind) of **infirmity** on each wound.

This is important because many people will come for prayer looking for physical healing. When you get the wounds healed up, and the demons cast out, you will see many people physically healed. I've seen the blind see again, the deaf hear, countless cancers disappear. I've seen hundreds and hundreds of physical healings happen after the wound is healed, and the demons cast out.

Some of the healing happens instantly, some of it is partial, and sometimes it doesn't happen at all. I wish I knew why, but there's no magic formula that I have found.

Question: How do you know this stuff? This isn't all in the Bible!

That's a great question. The Pastor - in the first deliverance ministry that I was involved in - knew more about demons than anyone in the world. He'd been doing deliverance daily for over 35 years.

His method of deliverance involved interrogating every demon. So we had to find out five bits of information from each demon:

- 1) What's your name?
- 2) How did you get in?
- 3) Do you have a legal right to stay in a wound?

- 4) Are you generational?
- 5) And, who's the chief demon on that wound?

I ministered to over 3000 people in that church, and probably interrogated an average of three or four demons per person. I got the demon's answers to those five questions over 10,000 times.

So trust me, after doing this 10,000 times, I know how they enter, I know how they stay, and I know how to make them leave. It's all the same stuff...Satan has nothing new.

Question: Are Christians Oppressed or Possessed?

That's a great question. The people and pastors who declare that they are oppressed and not possessed don't want to think or say that the demon is **inside** them.

In the Bible, there was the demoniac who had "**Legion**". Was he possessed? And Mary who was possessed of seven demons (that Jesus cast out). Was she possessed?

Those are really trick questions. In Ezekiel 18:4 God states, "Behold, all souls are Mine; the soul of the father well as the soul of the son is Mine. The soul who sins will die."

So no one is actually possessed by a demon, but it IS inside them!

EXAMPLE:

Let's say you go to dinner and leave the back door open. A robber can enter. He can **steal** things, he can **destroy** things, and he can even set up a booby trap to **kill** you when you come home. He doesn't **possess** your home, but **he's in there!** And that's just how demons work.

Question: The Bible doesn't say anywhere that a Christian can have a demon, does it?

I get this question all the time. Remember, the apostle Paul had a thorn in the flesh, a messenger from Satan.

So before I answer, let me ask a question. What's a messenger from God? Most would say, "that's an angel." And **what's a messenger from Satan**? Most would say, "that's a demon."

So the Apostle Paul had a demon. He asked God to take it away, and God told him that His grace was sufficient. If Paul had a demon, then all of us can have demons.

Question: I've heard we should never talk to a demon!

I hear this all the time. And in a way, I agree. When I do deliverance, I don't talk to demons...I interrogating them. I'm not chitchatting with them. I'm not asking them what the lottery numbers are going to be. I'm interrogating them! If people press the point, I tell them they need to take it up with Jesus, because Jesus spoke to demons in the Bible.

Let's look at the time when Jesus confronted the demon of **Legion**. If we back up just a little bit... Jesus made all things, nothing was made that was not made by Him. He made the heavens, the earth, and He made all the angels, **even the angels that fell** and became demons... There was a

crowd present when he confronted and cast out the demon of Legion.

When Jesus asked that demon for his name, do you think He already new that demon's name? Of course he did...He made that demon!

So why (in front of this crowd) did He ask for its name? He did it to show us that we have the authority to interrogate demons! He has given us all authority over the power the enemy...Even the authority to interrogate it.

Question: Won't the demons just lie to you?

Yes, they will, unless you know how to stop them. I'm going to teach you how to get the truth, Every Time!

How do you get demons?

The simple **answer** is one word, **Sin**. After interrogating 10,000 demons, I've found that there are three specific kinds of sin that Satan uses to enter.

1) GENERATIONAL SIN

The Bible speaks of this in that the sins of the father are visited upon the third and fourth generation, but this really means perpetually.

2) SIN PERPETRATED AGAINST YOU

Someone hurt you bad enough that you disassociate.

3) VOLITIONAL SIN

Your own, voluntary sin.

Question: So every time we voluntarily sin, do we get demons?

Great question. The simple answer is No. I'd like to speak a little about volitional sin. God hates sin, and fortunately, we don't get demons every single time we sin. I have found that you have to do something <u>habitually</u> to get a demon <u>volitionally</u>.

Example:

If there is a group of guys sitting in a bar, and they're ogling some scantily clad young woman, and they're undressing her in their minds, they don't instantly get a demon of lust. Now if they sit and watch pornography for several hours a day for months on end, they're definitely going to get demons, and probably many!

One exception to this rule is having **sex outside of marriage.** When you sleep with someone (outside of marriage) you become one flesh, and instantly, you get all of their demons, and they get all of yours. The interesting thing about this is that if you wait until you're married to have sex, demons don't transfer. So if you honor God, and wait, He doesn't allow the demons to pass.

Many deliverance ministries will tell people that they are not free because **they still have sin in their life**. If this were true, none of us would ever get free. We will all sin in Word, Thought, and Deed, until the

Lord takes away our sin nature. So don't walk around all day fearing that you're going to get a demon if you do or think anything wrong! Our sin is covered by the blood of Jesus. So if you stumble, dust yourself off, and start again.

Ministers will also tell you that you have to be careful about praying with people because there can be a **transference of spirits**. They'll say that you have to be careful about who you lay hands upon, and who lays hands upon you...that spirits will transfer from them to you. I've interrogated a minimum of 50,000 demons. I haven't found **one** that entered by any of these methods. **These are not legal rights for demons to enter.**

Demons can enter from a sin of spiritual ignorance...such as participating in horoscopes and Ouija boards (this is witchcraft). The spiritual floodgates are opened when you do those things that the Bible calls **abominations**, witchcraft and homosexuality.

If you start practicing witchcraft, drinking blood, and casting spells, you are going to get a lot of demons. Or if you get into homosexuality, you are opening up the floodgates, and also will get a lot of demons.

Homosexuality and witchcraft are just sins, like any other sin, and they're all covered by the blood. But, some sin allows Satan a lot of access, and God forewarns us by calling those sins "abominations".

Demonic Legal Rights

- A) A demon's legal right to enter can be the sin that allowed it to enter.
- B) Legal rights can also come from wounds caused by the original sin.
- C.) A demon can have a legal right from an action that resulted from the original wound and sin. **Example: A** victim who has suffered a wound attempts to mask pain with alcohol or drugs. They get addicted, and a spirit of addiction instantly enters.
- D) A demon's legal right may be a lie that the core person or an altar believes. **Example:** Let's say a little girl has been molested as a child, and she disassociates from helplessness. Afterwards, the perpetrator tells that little girl, "This was your fault...if you hadn't dressed like this, I wouldn't have done this to you...you are dirty!"

Now the girl grows up, she's forty years old, and each time she has sex with her husband, she feels dirty and full of guilt. As a minister, you trigger this little girl and when she comes up, you find out that she holds guilt. You ask Jesus to come, and He tells her something like, "You're pure, and this wasn't your fault."

The woman comes back to her core person and exclaims, "Oh my gosh! This wasn't my fault. I can't believe it. It wasn't my fault!!" Her sex life is instantly changed, and the deep shame and guilt are gone forever.

You and I know, of course, that it wasn't her fault. She was only seven years old, and this guy was a sick pervert. But the alter believed the lie, and gave the demon a legal right to stay. Once Jesus brought truth to the lie, the legal right was gone, and the demons could be cast out.

Just a note: There is a demon on each wound with the same name as the emotion that caused the wound in the first place.

Question: What doesn't qualify as a legal right?

You'll have a demon tell you, "I've been here a long time, so I don't have to leave." Just being there long time is Not a legal right to stay. He may be generational, or have come in when a gatekeeper let him in. All

you have to do is declare "I break the curse of (his name)", and command him to leave, and he will go permanently.

You'll have demons tell you, "I'm not doing anything." And you'll have demons tell you that "He/She needs me." Those are Not legal rights either. Break the curse, and command them to go. They will depart permanently.

Now there is an exception to "He/she needs me." Some people like their stuff — they like their demons!

Example:

I was ministering to a very wealthy man, the owner a large business. A demon of "Greed" surfaced, and it told me, "He needs me!" I told the demon, "He does not!" Then demon said, "Yes he does!"

So I put the demon down and asked the man, "Do you really need this demon?" He said Yes. I asked him if he knew what this demon was here to do, and he said "Yes, he's here to kill, steel and destroy."

So I asked how he needs this demon. And he tells me...

"I'm selling my products before boards of directors. I feel the sale going sideways and know that I'm losing the whole sale. I can will this demon to come up, and all of a sudden, the perfect words come out of my mouth, and I get the sale. So yes, I need this demon!!

I told him right there that we were done. God is a gentleman, and **He will**not override your will. You can't make demons go if the person likes
them and voluntarily wants to keep them!

I had another similar situation with a woman who believed she wasn't attractive...

During her deliverance, a spirit of "Seduction" came up and said, "She needs me!" So I put the demon down and asked the core person if she really needed this demon, and she said Yes. She already knew that it was trying to kill, steal, and destroy. So I asked, "How do you need this demon?"

She said, "I'm single and have never been married. I go to parties or clubs, and no man will even look at me. So, I can will this demon to come up, and all of a sudden, two or three men will approach me."

So I asked her, "What are these men like?" And she told me, "Oh, they're terrible, but if I didn't have them, I wouldn't have anybody!!"

So right there, we ended her delivery session. Some people like their demons!!!

NOTE: How do you find out if it even has a legal right? Ask the demon!!! You are coming in the authority of Jesus, he has to tell you!

Inner-Healing and Deliverance Steps

(Quick View)

- 1. Chit chat (5 min).... Why do you need prayer
- 2. Pie chart
- 3. Find traumas, note Age, Brief Description, and Emotion.
- 4. Anoint and Pray
- 5. Explain curse breaking. Break curses.
- 6. Self-talk
- 7. Inner healing (2 or 3 alters), "Presence of the Lord"
- 8. Deliverance prayer and declarations.
- 9. Tell (client) Go to the "Presence of the Lord."
- 10. Take notes of all the responses of the demon.
- 11. When you ask for the number of alters, the demon will lie. Press him.
- 12. Continue on through the script, casting Demons out.
- 13. Break the curses in the demons' responses.
- 14. Anoint w/oil, lay hands on for physical healing.
- 15. Heal each alter, or in groups (by emotion).
- 16. Get the "Flip Side" converted to your side.
- 17. Command the demons to depart again.

- 18. Check with the "Finger of God", till all is quiet.
- 19. Anoint, and ask for the infilling of the Holy Spirit.
- 20. Teach client to do their own inner healing.
- 21. Teach client to use the self-deliverance script.
- 22. Place a follow-up call to client the next day.

MASTERING THE INNER HEALING AND DELIVERANCE STEPS

Let's start with **Step 1**. When most people first sit in front of you, they have no idea what is going to transpire. They are nervous, they are scared, and they don't know what to expect...they're about to go through an exorcism and that would make just about anyone nervous. So you want to alleviate as much of this fear as possible. I do so by asking one simple question, **"Why do you think you need prayer?"**

As soon as I've asked that question, I glance at my watch, and unbeknownst to them, I'm going to give them five minutes to talk because if I don't stop people after five minutes, they might talk without stopping or without taking a breath for many hours. We all know people like this! I gently interrupt and say, "I hate interrupt, but let me show you what we're going to do today so I can help you, help me."

Step 2. I then draw a pie chart with three pieces...Body, Soul and Spirit. I explain how our deepest wounds are created in the soul, and that this is where the demons reside that cause us the most torment. That is what I'm looking for...those worst wounds in their life. So I ask, "What's the worst thing that's ever happened to you...especially as a kid?"

Step 3. I'm finding traumas in their life and looking for three things. I'm looking for the **age** they were when the trauma occurred, a **brief description**, and the **emotion** at the worst moment of the trauma, the best that they can remember. I try to get the details of five or six traumas.

While gathering trauma details, I'm also making a list of the kinds of trauma. At some point we're going to break the curse of each of those traumas (curse-breaking).

Step 4: Next I'm going to anoint this person with oil and pray some kind of cursory prayer, just to get things started. It can be anything you feel like praying.

Step 5: I explain curse breaking, and then we verbally "Break the Curse" of those traumas that occurred in their life.

Step 6: We do **self-talk** (explained previously).

Step 7: I do inner healing on two or three of their traumas. Even if they have 1000 traumas, I still only do two or three, so I don't wear them out. At the end of each inner healing, I mention the peaceful feeling that comes when the wound is healed. I tell the person that we will just call this

peaceful feeling the "presence of the Lord." This "Presence of the Lord" feeling is where I want the person to be during the entire deliverance.

Step 8: I'm ready now to pray the Covenant Deliverance Prayer with its declarations. This prayer is included in the following "Covenant Deliverance" actions, which begin by referring to #8 of the "Inner Healing and Deliverance Steps".

<u>NOTE:</u> I heard much of this deliverance prayer while watching an actual deliverance by someone who'd been trained by a ministry called Freedom Encounters. I've altered it somewhat.

(There are additional numbers on the pages of the "Covenant Deliverance" which also correspond exactly with those referred to in the "Inner Healing and Deliverance Steps".)

When you've prayed the deliverance prayer, make sure the person you're praying with doesn't have any disagreement with what you've prayed. If they do, then you will have division, and nothing will happen. Satan loves division, and it will stop everything.

Covenant Deliverance

#8 Deliverance Prayer and declarations

Father, in the name of Jesus, I ask according to Matt 18:18, that the 1st & 2nd demons of highest authority in (<u>client</u>) be bound and escorted to the courts of heaven, and that the courts be convened. I ask that when they are brought back, that they be bound from leaving until told to leave.

Jesus, I ask you to prepare 3 judgments for these demons, to be executed if they fail in any of Your directives. Lord, I ask that the first 2 judgments be of Your choosing and the 3rd be consumption by fire. The 2nd demon of highest authority will then come to attention with the same judgments & directives. If he fails and is consumed, then every demon in this vessel will be consumed.

Jesus, I ask that you would order the following directives for these demons:

- > That these 2 would represent all the demons in this person, and that when they are told to go to the pit, <u>all</u> will go with them. Any that hide or leave the body will be destroyed by fire.
- > That they will not push up another demon or wounded part in its place.

- > That when they leave, all the spoils and healing that have been stolen or withheld will be released, seven-fold.
- > That any answer of "I don't know" isn't an acceptable answer.
- > Lord, I ask that you tell these demons that <u>every answer</u> is testimony in the courts of heaven.
- > I ask that you would tell these demons all the information they are <u>required</u> to tell me.
- > I ask that they be told that today is their day of departure.
- > And when these two are returned bound, that they would give me a greeting of their names. AMEN

#9 Tell (client) Go to the "Presence of the Lord"

Say to Client: Go to be in the "Presence of the Lord". After a minute or two, ask "Head demon, are you there? Say your name or function so (client) can hear it. "

When you get both demons' names, ask the head demon: "What % is (client) in the presence of the Lord?" If less than 100%, ask, "Are you or your horde hindering (client)?" Have the demon tell them (out loud) to "Stop Hindering"

#10 Take notes of all the responses of the demon

- A) What have you done <u>Spiritually</u> to the call on (client)'s life? I only want information you are <u>required</u> to tell me.
 - B) What have you done Emotionally to (client)?
 - C) What have you done Mentally to (client)?
- D) What have you done <u>Physically</u> to (client)? Ask "What infirmity is present?" Ask: How old was (he/she) when the wound was created (and the infirmity) slipped in...and what is the emotion that wounded part holds?
 - E) Where do you get most of your power in (his/her) life?
- F) What's the #1 lie you've told him/her that he/she believed? Are there any other lies you're required to tell me about?
 - G) What other spirits are you required to tell me about?
- H) Are there any spirits under your control that are outside the body? (Make the demon tell them to "Go to the pit," verbally out loud). Isaiah 27:8

#11 When you ask for the number of alters, the demon will lie. Press him.

A) How many wounded parts are there, that haven't been healed yet? Find out what age the (client) was when each part was created and what emotion each holds. If there are many parts, get a list of the emotions that caused parts.

- B) Did you crack (him/her) at conception and slip in a wedge so you can come and go as you wish?
- C) Does the Lord have a Word or a Scripture for (client)? (He may have several.)
 Use Balaam example.
- D) Has the Lord instructed you to give me any more information so that this person will have freedom today? Do you confess that you've given me all the required information? Do you confess that all the information you've given me is true?

#12 Continue on through the script, casting Demons out

In the name of Jesus Christ of Nazareth, who came in the flesh, I command every demon to loose (him/her) and go to the pit, without ripping or tearing.

#13 Break the curses in the demons' responses

Read the demons responses, breaking those curses. At <u>Physically</u>, heal the alter associated with the infirmity, and have it break the curse of the infirmity.

#14- Anoint with oil, lay hands on for physical healing

Pray James 5:14-15.

#15 Heal each alter or in groups (by emotion)

Heal all the rest of the alters that the demon has told you about, individually or in groups.

#16 Get the "Flip Side" converted to your side

Immediately after the last alter is healed: Turn the "Flip Side's" will to the Lord (by using the law and grace).

#17 Command the demons to depart again

Tell the demons (again) to "Depart and go to the pit." Now ask the Holy Spirit to bring healing and truth to all the lies.

#18 Check with the "Finger of God" till all is quiet

Search with the <u>Finger of God</u>. If a demon comes up, break the curse (all the way back to Adam and Eve) and ask "Do you have a legal right in a wounded part?" Heal the part and cast out the demon. Search until nothing else comes up.

Ask the Holy Spirit to fill (client) where all the darkness was.

("MASTERING INNER HEALING AND DELIVERANCE" STEPS, CONTINUED)

Step 9: Tell the person to get into the "presence of the Lord." Within a minute to three minutes, they're going to get a name that will flash before their mind. It will be a name or the function of the **head** demon. Just ask them to tell you whatever flashes before their mind. You then command **that** demon to place the name of the demon that is **second highest** in authority before their mind. Have the person tell you that name also. Now you know the Number 1 and Number 2 demons of highest authority

SPECIAL NOTE: Steps 10 through 12 are just gathering information. Follow the script, asking the questions just as they're written out, and taking notes of the demons' responses. When you've gathered the information from all the questions, command all demons to go to the pit in Jesus' name. All the demons that have no legal right in a wound will leave instantly and go to the pit.

NOTE: Steps 13 through 18 give you instructions to work with that information.

Step 13. Go back to the notes you took in Step 10 and verbally break the curses to the demons' responses, starting with what has he done Spiritually.

Step 14. Continue to what he has done physically, heal those wounds, and cast out demons. Once the wounds that allowed the demons of infirmity to enter are healed, anoint them with oil, and lay hands upon them for physical healing.

Step 15. Heal the rest of the wounds the demon told you about, either one at a time or in groups. Command every demon that was on each of those wounds to be bound to the head demon and go when he goes.

Step 16. Ask for the part of the person that lets the darkest stay. Tell it that you need it to turn its full Will against the darkness.

Step 17. Now anoint the person with oil and command every demon to go to the pit once more. At this point, all the demons attached to all those wounds that were just healed instantly go to the pit.

Step 18. I then ask God to make my fingers, the fingers of God. I search them from their toes to the top of their head for anything else that is not of God. I ask that the demon be commanded to say his name in the person's mind. I want the person to tell me whatever they hear. I then verbally break the curse all the way back to Adam and Eve, and ask the demon if it has any legal right to stay in a wound. If it says yes, I command the demon to tell me the age and emotion held in that wound. I then get the wound healed, and command the demons to go to the pit.

At some point, everything is silent in the person's mind. The silence does not mean that the person is completely healed and free of demons. It

normally means that the Holy Spirit is letting us know that they've had enough for today.

Step 19. I anoint them with oil one more time and ask for the infilling of the Holy Spirit from their toes to the top of their head.

Step 20. I let the person know that most likely they are not completely finished. So the last thing I teach the person is how to do this themselves. I let them know that they most likely have some wounds that are still not healed, and if there is a wound, then there are demons on that wound. So I show them the two ways that God will expose those remaining wounds.

God will either allow them to be triggered by someone, or He will bring old memories to their mind. So I told them to carefully watch for emotional overreactions, and also watch for old traumatic memories to pop into their mind.

Step 21. Before they leave me, I want them to heal an old wound themselves, and cast out the demons. So I have them close their eyes, and I ask the Holy Spirit to bring an old, painful incident to their mind. I tell them not to tell me the details, to just tell me when they have the memory of a past, painful incident.

I have them then declare, "I divide soul and spirit", and then go to the worst moment of that memory. Once they're at the worst moment, I have them say, "Jesus, come now." When he speaks or takes the pain, I then

Chapter 17

Self Inner Healing and Deliverance

- 1. Pay careful attention to your emotions.
- 2. When you have an elevated emotion, take notice of events that are triggering the emotion.
- 3. Afterwards, determine if the event (on a scale of 1 to 10) warrants this high of an emotion, or if you are over-reacting.
- 4. If you determine that you're over-reacting, it's telling you that there is a wound that still needs to be healed.
- 5. Remember as many details of the event as possible...place, people, words, and sensory details.
- 6. When you get home or to a quiet, peaceful place, say "I divide soul and spirit," then take yourself (in your mind) back to the event that triggered the over-reaction. Use the event details in your memory to trigger that adverse emotion. REALLY GO THERE in your mind, and let the emotion come up again.

- 7. At this point, out-loud ask, "Jesus, please come and heal this part of me."
- 8. Jesus will come and either: take the emotion, or heal the wound by speaking to you. When you feel the emotion lift or hear His Words, the wound is healed.
- 9. After the wound is healed, tell all the demons on that wound to go to the pit, "in Jesus name."

The most helpful thing you can do for hurting people is to empower them. They've been victims and suffered hopelessly for their whole lives. When they now have control, they're given a whole new lease on life.

With the Self Inner Healing and Deliverance instructions, they can get 100% healed and free, and they can do it all on their own.

Chapter 18

Evangelism Overview

In Isaiah 61, the Lord told us that He came to preach the good news, to heal the brokenhearted, and to set the captives free. We've learned about healing a broken heart at the deepest point. We've learned how to cast out demons. Now, we're going to talk about preaching the Good News.

We're going to talk about **Biblical Evangelism**, a simple and yet effective way to lead people to Christ. When you master this, you'll use it more than inner healing and deliverance. Many of the people who come to you for healing are unsaved, and many are false converts.

EXAMPLE:

A young man came to me for deliverance. I asked if he was a Christian. He told me that he used to be, but "Christianity doesn't work." So I asked him what he meant by "Christianity doesn't work?"

He told me that he'd only been to church one time in his life. He couldn't remember what the sermon was about, but at the end of the service, the pastor asked the 3000 people in the sanctuary a question: "How many of

you would like to go to heaven?" and of course, the entire place raised their hands. Then the pastor said, "If you want to go to heaven, all you have to do is say, <u>Jesus come into my heart</u>, and if you do, you'll have peace, love, joy, prosperity, and everlasting happiness." The young man said those five words.

He told me that the next day he found out his live-in girlfriend was cheating on him. Two days later, he got fired from his job. One more day later, his dog ran away, and 30 days later his truck got repossessed. He told me that proves Christianity doesn't work!

This young man is a typical example of a false convert and a false gospel that is bring preached. Many pastors are preaching a Gospel that just isn't so. This young man had no idea why he said those words. Upon further questioning, he had no idea that sin, Jesus death, burial, and resurrection had anything to do with the words that he'd uttered.

If you remember in the "Demons" teaching, we never cast demons out of non-Christians. So if you're going to set them free, then you're going to have to lead many of them to Christ **before** the deliverance.

Have you, yourself, ever led someone to Christ? If you haven't, you are among "well over 90%" of all Christians. Here is a short list of why most never lead anyone to Christ:

... They don't know how to start the conversation.

... They're afraid the person will ask a question they can't answer.

...They're afraid the person will think you're judging or accusing them.

...They've already tried unsuccessfully, got rejected, and never try again.

Have you ever seen a great Gospel presentation and nothing happens, not even one person receives the Lord? Have you ever seen a every poor presentation of the Gospel where there were many salvations, people on their knees in tears, lives changed, and wonder why? Well the Bible tells us why!

Did you know the Bible tells us there's a time **not** to give the gospel, <u>and why</u>?

I'm going to address these issues, but I'd like to start with the Bible and work backwards.

Actually, I was a terrible evangelist. I was already a pastor and had led only two people to Christ. One was my mother and the other was my wife. I got horribly rejected every time I attempted to evangelize...I was so bad it was embarrassing.

Chapter 19

Our Goal

Our goal is to LEAD PEOPLE TO CHRIST. Do the words 'lead people to Christ' or 'lead us to Christ' appear anywhere in the Bible? Well the answer is Yes. They appear only once in the whole Bible. Gal 3:24 tells us that, "The law is a tutor to lead us to Christ, that we may be justified by faith."

When I saw this scripture, I knew that the **LAW** must be very important, especially if it's the only place in the Bible that speaks of leading people to Christ.

I was determined to find an evangelism method that used the law. By the way, what is the **Law of God**? Most people (even Christians) don't know that it's the 10 Commandments. So I found an evangelism method that uses the 10 Commandments, and it changed my success rate instantly and dramatically. It also reduced the embarrassing rejection rate to almost zero. You will want to memorize the 10 Commandments.

I stumbled into the **Way Of The Master**. It's an evangelism method done very publicly by Ray Comfort and Kirk Cameron. The method is just five main questions:

- 1) Would you say you're a good person?
- 2) <u>Do</u> you think you've kept the 10 Commandments?
- 3) If God <u>judges</u> you buy those Ten Commandments would you be innocent or guilty?
 - 4) What do you think your destiny is heaven or hell?
 - 5) Does that concern you?

If you can get through these **five** questions (with some other questions interspersed), you will lead a **tremendous** number of people to Christ. Before you get into these five questions, you're going to have to start the conversation. We're going to start with a purpose.

Now it's important to know that even secular people who study the brain know that the brain is always on the **conscience** or the **intellect**. And **nobody ever get saved on their intellect**.

So we are going to start a conversation with the goal of getting the person onto their Conscience, keep them on their Conscience, and if they get off, we'll spot it, and swing them back.

How do we start the conversation and how do we get people onto their conscience? We talk about the **Things of God**. What are the things of God? They are **Absolutes...**Life and Death, Black and White, Right and Wrong. When you talk about absolutes, a person's mind goes instantly to their conscience.

I've provided a short list of several conversation starters:

- 1) What do you think happens after you die?
- 2) Do you have a Christian background?
- 3) I'm taking a class on how easy it is to talk to people about God. Would you be my example for this week?

The easiest for me is to bring up some life and death incident that's been in the news.

After mentioning it, I may say, "What do you think happens after you die?"

You're going to get many answers, ranging from "I don't know", to "we just turn to dust", to "I'm going to be reincarnated."

I then ask them if they hope there's a heaven. By the way, I've done this thousands of times and only one person said, "No I hope there isn't a heaven!"

I asked the guy why he hoped there wasn't a heaven, and he told me, "If there's a heaven, then there's a hell...and I'm probably headed to hell!"

Moments later I led that person to Christ. So, almost everyone says "Yes, I hope there's a heaven."

Now I'm angling the conversation down to the first of those five questions. So I ask, "Who do you think goes to heaven? Would you say good people go to heaven and bad people go to hell?"

You're going to get many people who say "Yes", and you'll get many others that say, "No, I don't believe in hell!". (I really don't care what their answer is.)

Now I'm ready to ask the first of the five questions: "Would you say you're good person?" 99% of the people do say they're good person. (Even Hitler would tell you he's a good person.) So now I'm already one fifth of the way through these five questions.

I now ask, "Do you think you've kept the 10 Commandments?" Again, you're going to get one of several answers, "Yes, No, Probably some of them, or I don't know what they are."

So I tell them, "Let's check, shall we? I'll take you through a few of them, and I'll take myself through them as well."

"The ninth Commandment says that, **Thou shalt not lie.** "Have you ever told a lie?" Virtually everyone says yes, and I say, "Me too...I've told tons of lies." What are you and I called if we tell lies, and he says "a liar."

I then tell him the eighth Commandment says, "Thou shall not steal", and ask, "Have you ever stolen anything — a pencil, a paperclip, even something very small?" Most say Yes, and I say, "Me too. I've stolen tons of things. What are you and I called if we take things that don't belong to us? And most reply, "A thief." Now I'm keeping track of his answers, and so far he's told me he's a liar and a thief.

I tell him that the seventh Commandment says, "Thou shall not commit adultery", but God says, that even if you've looked with lust, you've committed adultery in your heart. So have you ever had a sexual thought about somebody, in your whole life? And he says, "Yes, many times." I tell him, "Me too."

I tell him, "Let's just do one more. The third Commandment says, '**Thou** shalt not use God's name in vain'. Have you ever used God and damn together, or Jesus Christ in anger, or even 'Oh my God' (just using God's name it irreverently)?" Everyone says Yes.

Now I'm about to give this guy a quick summary of what we've talked about. But first as I take him through the Commandments, I'd like to show you what's been happening biblically.

Rom 2:15 says, "In that they show the work of the **Law** written in their hearts, they're **Conscience** bearing witness, and their thoughts alternately **Accusing** or **Justifying**."

Isn't that interesting how God has the word <u>law</u> and <u>conscience</u> in the same sentence. It's also interesting that you don't have to accuse these people of their sin... their own heart <u>accuses</u> them or <u>justifies their sin</u>.

Look what else is happening. In Rom 3:20 "Because by the works of the law, no flesh will be justified, for through the law comes **knowledge** of sin.

This is also extremely important because people have become very unchurched. Many have no idea what sin is, or have even heard the 10 Commandments. So when you take them through the Commandments, they now have **knowledge** of their sin.

Now you've gotten the person on their **conscience**, you've introduced the **law**, their own heart has been **accusing** themselves, and they have **knowledge** of their sin.

I give the guy a short summation, because he's broken four of the Commandments. I ask this guy what his name is. And he tells me "Bob". I say, "Bob, you've just told me that you (just like me) are a liar, a thief, a blasphemer, and an adulterer at heart. So Bob, if God judges you by those commandments would you be innocent or guilty?"

I'm now 3/5 of the way through the five questions, and this is one of the two places where people may push back at you with an objection. Let's say he comes back with the comment that, "Nobody knows for sure if there's a god. No one can prove there's a god."

Let's take a look at his objection. He's now trying to make me intellectually prove that there's a god. So what's really happening here is that he has slipped off of his <u>Conscience</u> and is now on his <u>Intellect</u>. You're going to have to get him back onto his conscience. You have to address his objection, and then you need to segue back to his conscience. Here's how I do it.

I tell him, "I can prove there's a God in 30 seconds. You see a painting, you don't see the painter, but you know there's a painter. You see a building, you don't see the builder, but you know there's a builder. You see this creation outside, you don't see the creator, but you know there's a creator...and He created a conscience in you to know right from wrong.

So let's get back to those Commandments. Would you be innocent or guilty?" The guy momentarily looks at me incredulously and says, "Well I guess if there IS a God, I'd be guilty."

I'm now I'm down to the fourth of the five questions.

I lead into it by explaining that God says, no adulterer, or thief, or idolater shall inherit the kingdom of heaven. "So, what do you think your destiny is, Heaven or Hell?"

Note: This is the other place where you may get an objection. The typical objection is, "I don't believe in Hell" or "My God is a loving God. My God is a forgiving God. My God wouldn't throw anybody in hell."

What's happening with this objection? You've gotten the man on his conscience, you've introduced the <u>law</u>, he was <u>accusing</u> himself, he has <u>knowledge</u> of his sin, but now the guy is somehow saying that his sin is alright. What is he doing here? He's saying his sin is okay...he's **justifying** his sin!

Remember, peoples' hearts either <u>accuse</u> or <u>justify</u>, and people can justify forever. They will take you down many rabbit trails, and you'll never get back to the Gospel. So, what we have to do here is <u>shut his mouth!</u>

So I went to the Bible to learn how to shut someone's mouth. I found in Rom 3:19 that God says, "Now we know that whatever the law says, it speaks to **those who are** under the law, that **every mouth may be closed,** and all the world may become accountable to God."

Who's under the law in this situation? The unsaved person. So, I'm going to hit this person with more law (another commandment), and it will "shut his mouth".

I tell him, "That's exactly what I said! Do you know what you've just done?" and they say "No."

I tell him, "You've just broken the 2nd Commandment - <u>Thou shalt not</u> <u>create any graven image</u>. Creating a god to suit yourself, one that will let you lie, steal, blaspheme and be an adulterer. So now you're 0 for 5, and you're probably not going to do real well in the last 5 Commandments. I have broken them all! So now, what do you think your destiny is...heaven or hell?"

Bob says,"I think it would probably be hell." Now comes the 5th and most important question —

Does That Concern You?

Now let me tell you biblically what is happening when you ask that question. The Holy Spirit is **Convicting** their heart...and when He convicts, they are <u>Sorry</u>. But the Bible speaks of two kinds of sorrow: there's <u>Godly</u> sorrow, and there's <u>Worldly</u> sorrow.

2 Cor 7:10 For sorrow that is according to the will of God produces repentance without regret, leading to salvation, but the sorrow of the world produces death.

Now, lets say Bob's answer to my question, "Does that concern you?" is "**No**". Remember what we talked about at the beginning. The Bible tells us there is a time **NOT** to give the gospel. This is the time!

Matt 7:6 Do not give that which is holy to dogs, and don't cast your pearls before swine.

You've gotten this guy on his <u>conscience</u>, used the <u>law</u>, he's <u>accused</u> himself, he has <u>knowledge</u> of his sin, and the Holy Spirit has <u>convicted</u> his heart. The guy is sorry, but what kind of sorrow does he have? **Worldly sorrow**!

So **don't** give the Gospel! He will not receive it, and you're wasting the good news on someone who's not ready for it. Let the Holy Spirit continue to work on his heart. At some point down the road, his stiff neck will be softened, and he will be able to except the Gospel.

Here is a quick story to show you how well this works.

A young Christian woman in her mid 20s from Tucson came to Phoenix for deliverance. She brought her best friend with her.

She sat down, and I took her through inner healing and deliverance. The alters came right up crying, and of course, Jesus healed them. The

demons came up snarling and very animated. We cast them out, and when we were finished, she hopped up and went to the bathroom.

I was left alone in the room with her young friend. I asked her if she'd ever seen anything like this before, and wide-eyed, she said "No!" I asked her if she had a Christian background, and she said, "No, I've never darkened the doors of a church." I asked her what she thought happens after someone dies.

Then I took her through this method all the way down to "<u>Does that</u> concern you," and she said "No." So, I gave her my card and told her that if it ever started to concern her, she could call me, and we'd discuss it. (She didn't make that call.)

Two weeks later, the first girl came back for more deliverance, and brought her unsaved friend again. Many alters were healed, and many demons were cast out. She left the room again for the bathroom.

I asked her friend if she had a chance to think about our conversation. She said, "Yes!! Every night for the last two weeks I kept waking up at night, hearing your question, 'Does that concern you?' and my answer 'No!' I heard it over and over every single night!!

So you know what I asked her: "Does that concern you?" And she said, "YFS!!!"

I led her to the Lord right then. She was sobbing while saying a simple sinners' prayer. It was very touching to see how the Holy Spirit had worked on her heart. Anyone who would have come along with the Good News would have led her to Christ.

So if the person is NOT concerned and has **Worldly Sorrow**, do NOT give the Gospel! It's the hardest thing to do, but discipline yourself and give the Holy Spirit some time to work. You are planting **very good seed!**

Let's back up to the story about Bob. Let's assume that when I ask, "Does that concern you?" he says Yes.

Okay, this is the time you should give the Gospel! But let me warn you, this is the time that many Christians suddenly turn into <u>preachers!</u> They start telling the person all about their church, the Bible, repentance, and **you lose them!**

When someone answers the question "Yes," I simply ask them, "Do you know what God did so that you wouldn't have to go to hell?" I get one of two answers: No, or (with a slight delay) Oh, he died for me?

At this point, you need to come up with the simplest and shortest explanation of the Gospel possible. I say, "God sent His perfect, sinless son, Jesus, to take the punishment that you and I deserve. He then raised

Him from the dead, and He did it all as a gift. Do you know what He expects from you for that gift?" They always answer, No.

I tell them that He expects you to accept the gift! And here's how He says to accept it: If you'll confess with your mouth that Jesus is Lord, and trust in your heart that God raised him from the dead, you shall be saved! (And I repeat this again - very quickly, quoting Romans 10:9.)

At this point in the process, I have one word screaming through my mind, and that word is **Urgency**!!

So I tell Bob, "You and I could shake hands and go our separate ways. You could have an aneurysm and die in the night. You are suddenly standing before God, and you remember, "Oh yeah, that Scott guy said that if I confess with my mouth, and trust my heart that You raised Him from the dead, I would be saved...so God I'm doing that right now!!"

I tell him "Bob, we are only promised today. So if you died at this moment, what do you think your destiny is?" (And of course he says, I think it would be hell.) I ask, "So what are you going to do?"

He says, "I think I'm going to pray that prayer." I ask him, "When are you going to do it?" and he says "I think I'll do it as soon as I get in the car." I ask him, "How about we do it together, right now?" (I've never had someone say, No.)

I pray with them right there, and have them repeat after me, "Father, I'm a sinner. I've broken your laws, and I want to be forgiven. I understand that your son Jesus died for my sins, and if I trust that you raised him from the dead, I will be saved. So God, I'm doing that right now. Thank you Jesus for what you did for me. Amen."

I've done this method thousands of times, and I can't tell you how many people burst out crying as we are praying this prayer. **They get it**, they understand exactly why Jesus died. They understand their own sin, and the **magnitude** of this moment.

The first time ever did this method was when I'd just learned about the 5 questions. Remember, I was already a Pastor and had only led two people to Christ. Many times, I'd suffered embarrassing, humiliating rejection while attempting to evangelize.

My wife, Sue (who is recently retired) was an administrative assistant for 50 years. We didn't have much money, and her only splurge was to have some maids clean our home once every two weeks. I decided to try this method on one of the maids.

I cornered the twenty-something year old girl who was cleaning the kitchen. I didn't know anything about getting her on her conscience yet. I asked her how she liked her job. And she said, "It's okay, but I'd rather be studying law."

So I asked her if she'd studied God's law, and she didn't know what I was talking about. So I explained that it's the 10 Commandments. I asked her, "Do you think you've kept the 10 Commandments?" Her face dropped, and she shook her head no.

I asked her, "If God judges you by the commandments, would you be innocent or guilty?" She quickly said Guilty. I asked her what she thought her destiny was, heaven or hell? And she burst out sobbing. She had a total meltdown right there in the kitchen. I quickly asked her if she knew what God did for her so she wouldn't have to go to hell. She shook her head No.

I told her what Jesus did, and the prayer she could pray. She prayed that prayer without my even offering to pray with her. She looked up, and her face was beaming. I could't believe how simple it was, and was determined to become excellent at this method!

Two weeks later the maids returned, but this girl was not in the crew. When they had finished with our home, one of the ladies came up to me and said, "Did you notice the girl who cleaned your kitchen is not in the crew anymore?" I thought, "Oh no, I'm in trouble!"

The lady told me, "That was my daughter. She quit cleaning homes, and she's gone back to school to study law. Three times in the last two weeks she has been going to church. She keeps telling us that we must go too! I don't know what you did to her, but she's a different person!"

Combine Evangelism and Inner Healing

I want to give you one more strategy for when someone tells you they are **not concerned**.

I shake their hand and thank them for talking with me. I hand them my card and tell them that if it ever starts to concern them to feel free to give me a call.

Just a note here: I can't tell you how many people grab my hand again and tell me, "Thank you, no one has ever talked to me like this before." As they turn away, I gently touch their shoulder and say, "If this God that we were just talking about would reach down from heaven and take away the pain from some old hurt in your life, would you let him have it?" At this point they look at me (like I'm crazy) and say, "I suppose". I then ask them, "What's the worst thing that ever happened to you, especially as a kid?"

I tell them I'm going to have them close their eyes and go to the worst moment of the trauma in their mind. When they're at the worst moment of the incident, I tell them to just just nod, and I'll ask this God come and take away the pain. Again, they look at me like I'm crazy, but most say Okay.

I ask them to close their eyes and go to the worst moment of the trauma and nod. They do it, and I ask Jesus to come. You wouldn't believe how many times their eyes pop open, and they say, "Oh my gosh. It's gone... it's really gone! I've been carrying that for 25 years!"

I tell them this is the God that you will stand before. I ask them again, "Does that concern you?" Many are very concerned at that moment, and Jesus is very easy to sell.

By the end of the night, I saw small pockets of people ministering to others.. using their authority for the first time.. speaking to parts, getting them healed, and casting out demons! This was the best part of the night for me.. to see the body

Through a series of circumstances, I did a short healing and deliverance session with a friend of mine. It was amazing to see her healing, and also of her arm that was accidently stabbed by a large knife with a main tendon being cut nearly 2 wks earlier!

We healed the soul wound that was caused by the Trauma of that accident and by the next morning, the pain she had been asking God to take away was 100% gone!! The Lord lead me to a wounded part that was formed by the trauma—she didn't really believe it, but when she agreed to doing the inner healing process right then at my place, it was amazing what came out and then the demons that came up also!! PRAISE GOD for this strategy!!!!!

Then on Saturday, my ex-husband was struggling more with his "stuff". I suggested that there may be more "stuff" because he hadn't kept up with his own self-deliverance process, and he felt that it was true! I told him that we could go through the process again (like you did with him), even though I thought it is not something that should normally take place—ex-husband and broken soul-ties wife. He wanted to go for it! It was amazing all the stuff that came up for healing and deliverance!!! I felt





The little boy even took the rejection on the weekends from his ex-wife. I asked The Lord to speak to this little boy about the rejection. The Lord told him, "I've been rejected too."

The five year old boy was instantly healed, and exclaimed, "Jesus is singing to me!" and began singing with Jesus. Witnessing this, Phil's pastor was moved to tears. I asked Phil how he felt. His face beamed and said, "Look at my face!"

When I was working with the five year old, a demon of Rejection sprang up and growled, "You don't know who you're messing with!" The demon had multiple legal rights to stay, one in the wound and one back in Phil's generations, and I eliminated it. Just before being cast to the pit, the demon asked, "What are you, an attorney or something?" He left quietly, without incident. Phil's pastor said, "I've Never seen anything like this! It's just like in the Book of Acts!"

A month later, I spoke with Phil. His depression was gone, he was back to work, and joked, "I even feel good when my ex-wife berates me during visitation!"

Inner healing and deliverance can remove the pain of rejection.

Inner healing deliverance is for regular people.



People that need deliverance are just regular people, the Hostess at your favorite restaurant, your next door neighbor, the person working two cubicles down, your boss, your bosses boss. I've ministered to Governors of states, famous TV and Radio stars, owners of multi-billion dollar corporations (that fly to meet me in their private jets.) I've ministered to everyone from, billionaires to bums, housewives to hookers, and every race under the sun. We're all the same. Almost everyone has been hurt in their life, and If you've been hurt badly enough, then you have demons. And the demons aren't leaving till the wounds are completely healed. That's what I do. . . I heal the wounds.

I was attending a very large, non-denominational, Christian church, and wanted to start a deliverance team at the church. The head pastor was impossible to meet with, so I invited the top associate pastor (George) to observe at my next deliverance session, and he accepted. George was 68 years old and had been a pastor for forty-seven years. As we drove to the appointment together, George told me that he didn't believe a Christian could have a demon.

Our appointment was with Jeffery. Jeffery flew in for ministry, in his private jet. Tall, handsome, 48 year old Jeffery, was an extremely successful litigation attorney, and had just lost a reelection bid for Governor of his state. Jeffery wanted ministry for the torment of rejection that he'd secretly carried his whole life. It was especially tough on him at this moment because, he was going through his fifth divorce. I asked why he was getting divorced, and he said, "For the same reason all the others divorced me. . .They all say, I won't let them get close to me."

I asked when the first rejection happened in his life. Jeffery's mother was unmarried and had been used by men her whole life. She got pregnant and had twins, a boy (Jeffery) and a girl. Finances got a little tough, and when Jeffery was three, his mother dropped him at this grandmothers and never returned. She told the grandmother, "I just hate men so much, if Jeffery was girl I'd keep him!" The grandmother was also very verbally and physically abusive, and after mom left, told Jeffery, "I don't like boys either!"

I began to minister to Jeffery, to the little boy, multiple personality, that got rejected and left at this grandmothers house. It came up sobbing and angrily said, "I'm not Jeffery, I'm

Kelly, and I'm not a boy!" The pain from the rejection and abandonment created a little dissociative girl part that believed that, "If I was a girl, Mom would keep me, and Gramma would like me." The grandmothers abuse continued, and this Kelly personality vowed, "I'll never let another woman get close, because women hurt you, and leave you!"

I asked Kelly if Jesus could come talk to her about rejection and being a boy. . .she said, "Yes." The Lord sat her on his knee and told her, "I love little boys, and I'll never leave you or forsake you." Jesus asked her if He could change her name to Jeffery, and she said, "Yes." Kelly was instantly healed, and The Lord took that little part away.

A demon of "Hatred of Women", violently manifested, and snarled, "I've had him since he was three, I'm not leaving!" The wound was healed, "Hatred of Women" had no legal right to be there anymore, so we cast it to the pit. A bloodcurdling scream came out as he left. Jeffery collapsed in the chair, exhausted, but happy.

One minute later Pastor George hopped out of his chair, ran outside, and began throwing up. I followed and asked him what happened, and what was wrong. He wiped his mouth and said, "Scott we have 5000 people in our church just like Jeffery. They're never going to get help. . . Our pastor doesn't think a Christian can have a demon. George told the head pastor what he saw that day. The head pastor told him, "No deliverance team, it might hurt the giving!"
