NHRC DUES NOTICES

Important Information:

A friendly reminder that club dues must be paid before 1/1/2025. Reminder: there is no Gun Show for 2025 if you routinely paid at the show. Members who have not renewed by 1/1/2025 will not be able to gain access to the range. Dues for 2025 are as follows: \$85 for one year or extend your membership three (3) years for \$225.00, saving you \$30.00.

Whether paying your dues or extending your membership, payment options include Venmo or personal check. When opting to pay via Venmo, the Club's Venmo account name is 'Nesopeck Hunting-Rifle Club NHRC'. When renewing via Venmo (we love Venmo), **please do not activate the option to, 'Turn on for purchases.'** *You are not purchasing or paying for Goods or Services when paying your dues.*

Membership Cards. All members are **required** to display their membership card and sign in while using the range facilities.

Non-members. Non-members may only use the club facilities under the following conditions:

- 1) they are with a current NHRC club member and
- 2) they have completed a Liability form. Liability forms are located in the club house and on the outdoor range. Place completed (signed and dated) forms back in the bin. A form must be completed yearly.

Targets. Only paper targets and various steel targets provided by NHRC are approved for use. All other non-approved targets are not permitted and in violation of club rules.

Trap Shoots. Trap shoots are held on Tuesday evenings starting at 5:00 PM from April to October. The shoots are open to NHRC members and the public.

ARA Shoots. American Rimfire Association (ARA) run the 2nd Saturday from April through November at NHRC. ARA Tournaments are held on Saturdays throughout the season. Please see the NHRC website for dates and further details. ARA is open to the public.

2024 AMERICAN RIMFIRE ASSOCIATION CLUB CHAMPIONS

Harry Berger (right) is named the top ARA NHRC shooter for 2024 Factory Class. Harry's average score for the season was 2378.7 out of a possible 2500. Over the past year he has competed in 7 matches shooting 34 targets - 25 of which were perfect 2500s. At the Tamaqua Rifle and Pistol Club (TRPC) Match held on July 20th; he shot a clean sweep of 3 of 3 perfect targets.

Tamaqua Rifle and Pistol Club member Gary Sterner (left) is named the top ARA NHRC shooter for 2024 Unlimited Class. Gary's average score for the season was 1929.8 out of a possible 2500. Over the past year he completed in 4 Matches shooting 18 targets. His high score this season was 2400-9X shot at the Consolidated Sportsman of Lycoming County range on August 3rd.



The ARA is a sanctioning body for .22lr bench rest competitions. Both the Unlimited and Factory class have 20 minutes to shoot a 25-bullet target for a maximum score of 2500. Matches were first held in PA at TRPC on April 24, 2022. NHRC followed with the first Match being held here on July 2, 2022. CSLC joined in with its first Match on May 4th, 2024.

PENNSYLVANIA FEDERATION OF SPORTSMEN CLUBS

The Luzerne County Federation of Sportsmen Clubs mission is to advocate for hunting, fishing, trapping, conservation and second amendment issues. The federation of Luzerne County is made up of six clubs with approximately 900 club and individual members. The federation works with our state organization Pennsylvania Federation of Sportsmen and Conservationist www.pfsc.org in Harrisburg PA.

NHRC is a supporting club of the Luzerne Co. federation. By being a member of the county federation you are considered a member of the state federation. This means you can register with www.pfsc.org as an affiliate member and have direct access to information including monthly e-news updates on all issues for sportsmen/women in Pennsylvania. On critical issues, PFSC will ask Co. federation members to engage directly with our county legislators to defeat or enact critical legislation. To get involved or become informed on legislative issues, become active in the federation.

The Luzerne Co. PFSA has nine public meetings per year. Meetings are held the second Monday of the month except during December, July and August. Any NHRC member is invited to attend the meetings at the Lee Park American Legion in Wilkes-Barre. The meetings start at 7:30 PM with the next meeting set for January 13th. 
As a reminder, rifle matches are held at the club (the indoor range is closed) beginning at 3:30PM. Below is the schedule for upcoming Matches held at NHRC:
