In 2024 we provided services to more than 2090 foster kids. Provided more than 1250 foster kids with birthday parties and gifts! Sent out more than 1600 duffle bags and backpacks, giving kids in care a dignified way to carry their belongings! Sent 43 high school graduates a gift bag recognizing their accomplishment! Sent seasonal care packages to 316 kids desperately needing social connection and an emotional boost! Sent Easter baskets to 47 kids! Sent Next Step Baskets of household goods to 14 young adults transitioning to independent living! Provided 3 Baby Blessings Baskets to foster teens who became new moms. Provided Adoption Celebrations to 67 kids and bedding to 345 kids.
