2023 Racing Transponder Agreement Theft by Conversion

By signing this agreement, you are agreeing under the State of Florida Statute 812.155 to rent the racing transponder on a weekly basis and will return the transponder prior to leaving the property located at 3600 S Florida Avenue Inverness Fl. 34452 (Citrus County Speedway & Track LLC)

This agreement will remain in effect for the 2023 season and will not be required to sign additional Theft by Conversion paperwork on a weekly basis.

Failure to return the racing transponder with a value of \$300.00 or more is punishable as a third-degree felony as provided in S.775.082 or S.775.084.

Citrus County Speedway & Track LLC will follow Statute 812.155(4) Evidence in all attempts to encourage return of said property in good and working condition as required by the laws and notices provided.

Third party procession will not relieve driver of said responsibility in returning the racing transponder as required. I agree to pay all cost accrued with recovery of said property and the \$300 replacement fee if all attempts to recover the racing transponder fails.
