I further release any/all of the aforementioned person(s) for any harm, injury or damage that may befall myself or my property in connection with the C.B.B.R.C. event(s) whether foreseen held from any claims by myself or my family, estate, heirs or assigns arising out of my participation in event(s) held at said arena or any other facility rented and/or used by the C.B.B.R.C. In the event that I am responsible for the injury or harm to other persons or property due to my negligence, I agree to indemnify and hold harmless the C.B.B.R.C. and/or its officers and/or its members and said arena and/or its management from any claims that may result from my actions.
