- Doorbell cameras can only be installed using the existing peephole.
- □ A picture of the device must be submitted with this application.
- □ The camera **WILL NOT** record **ANY AUDIO**.
- □ Recorded images may only be accessed for **legitimate legal and/or bylaw reasons**.
 - No images will be shared with anyone other than the Board or Condominium Manager, the Police, or other authorized governmental authority.
 - The Board may request access to a recording to assist in a bylaw infraction investigation.
- □ Stored information **MUST BE** erased after 90 days from the recording.
- □ The camera **CANNOT** be used to violate another person's privacy.
- □ The Corporation and the Board are indemnified from any claims that result from a breach or misuse of the recordings by the Applicant (or residents of the unit).
- □ The trigger and the recording range of motion for the camera must be set to the absolute minimum. Notes:
- ✓ Failure to obtain approval for a camera will result in sanctions as outlined in the bylaws.
- ✓ All current and new cameras must be approved by submitting this application.
- ✓ Applicants must acknowledge, sign, and adhere to these terms and conditions.
- ✓ Approval can be revoked at any time at the Board's sole discretion if any of these agreed to terms and conditions have been violated and/or do not comply with privacy laws.
- ✓ Cameras **CANNOT** be used to harass and/or monitor normal activities of residents and visitors.
