Joining the Millennium TBI Network

Thank you for your interest in learning more about the Millennium-TBI Network and the Millennium-Warrior Angels Foundation-TBI Project. These entities are interrelated and are at the foundation of the Millennium-TBI Network; a group of facilities throughout the United States dedicated to providing science-based care to improve the lives of veterans, active service personnel, and civilians with symptomatic traumatic brain injury (STBI) and hormone deficiencies.

It is the goal of both the Millennium Health Centers, Inc, and the Warrior Angels Foundation (WAF a 5013c) to recruit and train healthcare providers in the application of the sciences to remediate the effects of all forms of neuroinflammation. This might entail all forms of minor TBI, strokes, autoimmune diseases, chemical and radiation exposure, post-surgical traumas, and environmental exposures. Nonetheless, our foundational assessment and care revolves around the restoration of neurosteroids and neuroactive steroids which addressing the neuroinflammation precipitated by trauma.

The Millennium Health Centers, Inc has been providing leading edge assessment and care for traumatic brain injury since 2004. Since then, we have identified and standardized a 28-point bio-marker panel using standard laboratory tests that are readily available from a clinical laboratory, although we have licensed the panel to only one clinical laboratory in the USA, due to the need for consistency of results on a high-tech platform. Interpretation of these biomarkers has standardly been performed manually, but in January 2021, we released Version 1 of a cloud-based program called – ***The Millennium-TBI Office Assistant (MOA)***. It provides for a multi-tiered, cross-correlational analysis of the patient’s medical history, present medication, and current laboratory results providing suggested diagnoses, educational comments, and result relationships followed by a suggested treatment protocol. This is an educational tool for all healthcare providers, either beginning their journey into the functional medicine arena or those wanting to standardize their interpretations and treatment protocols dealing with hormone replacement therapy (HRT). As of September 2021, an updated version of the MOA was released expanding our use of results from three laboratories including Access Medical Laboratories, Quest Labs, and LabCorp.

Getting Educated

The Millennium Health Centers, Inc. presents an introductory 8-hour lecture program twice a year in conjunction with the Age Management Medical Group’s biannual conferences. Their meetings are in March/April and October/November with the exact schedule being found at www.agemed.org . We are usually a Pre-Conference full day on the Thursday prior to the full program with a 2-hour introduction to the Millennium-TBI Office Assistant on Friday.

Steps to becoming a provider in the Millennium-TBI Network:

1. Purchase a copy of the TBI book - *TBI: A Clinical Approach to Diagnosis and Treatment* and the **2015 TBI Lecture series** on a thumb drive or DVD at:
 - a. www.millenniumhealthstore.com
 - b. Discount code: **TBIBFD**
2. Attend a One-day TBI Introductory Training Program.
 - a. AMMG, announced at www.agemed.org usually March/April and October/November.
3. Take the TBI Examination on-line; a 250-question open book exam.
 - a. When you are ready to take the exam contact Dr. Gordon (for now) and you will be sent an order form. Upon return of the form, you will be sent a link to the automated exam site.
 - b. Upon passing the exam with a 70% or more, you will gain access to our proprietary laboratory panels at Access Medical Laboratories, discounts to our proprietary liposomal products.
 - c. You will receive a preferred discount on the Millennium-TBI Office Assistant (MOA), the cloud based Expert AI APP.
 - d. You will have access to a listing on our primary website, www.TBIHelpNow.org

Setting Up Your Office to emulate the Millennium Health Centers, Inc.

The Enrollment process: from labs to consult

1. We have a primary website that all our traffic is directed to. At the site, a candidate fills out a simple Request for Enrollment which is sent to our office staff. These requests are entered into a program and then an Enrollment Application (EA) is sent out. When the EA is returned it is received by a pre-enrollment reviewer who checks for completeness. When complete the EA is sent for medical review for appropriateness of the case. If accepted, it is sent to Enrollment.
2. Enrollment calls the candidate, explains the fees and how we obtain the laboratory testing remotely. They are offered a walk-in clinic, or a phlebotomist can come to them for an additional fee. When all is agreed and they authorize charging their credit card, the labs are ordered.
3. The on-line portal with Access Medical Laboratories (AML) allows us to order a remote blood draw. Once they receive the requisition, they will send a kit directly to the client with instructions on how to get their blood drawn at a walk-in clinic or by a phlebotomist. Once the blood is drawn it is pre-processed (spun) and then sent to AML in a pre-paid return biological package.
4. Once AML receives the sample it can take 4-7 days for your portal to receive the complete results. These lab results are entered into the Millennium-TBI Office Assistant (MOA) Expert AI APP and a 4-page report is generated and sent to the patient. The patient is instructed to review the report and then arrange with the office for a 60min consult which is included in their initial **program fees***.

*The Millennium has a fee range for the initial assessment, inclusive of all labs, reports, and consultation between \$1,500.00 and \$2,500.00. Med-legal cases (PI) are higher.

The Consult process: from consult to treatment

1. Using Skype, Ring Central, Zoom or whatever, we review the lab results with the client explaining the relevancy of their lab levels to the research and their symptoms. In conclusion, we review their proposed treatment protocol explaining each component and the benefits we are looking to achieve. A Q&A follows. (We are developing a series of short videos to provide an example of how we do this.)
2. The client is referred to our website www.millenniumhealthstore.com to purchase all their products except any prescriptive medications. These are provided by any number of pharmacies in our network or by their PCP if the client is in a state, where I am not licensed.

The Millennium TBI Office Assistant: The Expert AI APP

It is an educational program to help healthcare providers from every level of training to provide services for cases of TBI, wellness, PTSD, age management, anti-aging, hormone replacement and testosterone replacement.

Obtaining Referrals from the Millennium Health Centers, Inc.

Once you have taken and passed your certifying examination, you will be given an opportunity to be listed on our primary website: www.TBIHelpNow.org under the section “The TBI Team”. In 2021, we referred out over 1200 individuals to our active, certified, network members. After each Podcasts (JRE) or interview, we receive thousands of requests from individuals interested in our Millennium Program.

Your listing will have your city and state, your name, facility name, and your logo along with a hyperlink directed to your site. This hyperlink will land on a specific TBI page that has all our required elements consisting of The Millennium TBI Network logo, a statement of the relationship of our clinics and optionally some of our informative documents that we share with our patients and Network participants. We do not charge a network fee, or licensing fee, and we are Not a franchise. However, to obtain a listing:

1. Take out an annual subscription for your website listing for \$5,000.00 (Pro-rated) or,
2. When you license the MOA for 12 months you will get the listing for free.

The bigger picture is to have an associative network of clinics well versed in handling traumatic and non-traumatic brain injuries. This then becomes a unique network that will be sought after by clients who have not received benefits under a traditional medical model.
