Meeting Minutes

- **1. Call To Order:** Co-Chairman Harry Montoya (meeting held on Zoom due to schools taking over of initial Board Meeting Room at the last minute.)
- 2. Recognition of Quorum: Gabriel recognized 4 of 5 board members present—Harry Montoya, Mike Lujan, Carlos Ortiz, and Gabriel Ortiz. Chairman Dave Neal had internet difficulty and could not attend the meeting. Also in attendance were Ralph Manzanares, District Manager and Rob Heineman, Advisor to the District.

- 5. Chairman's Report Ralph recommended to defer items (a,b,and c for next meeting)

The main topic of discussion was item #4, a, b and c and d. of the PVID Policy for Adoption for the Collection of Outstanding Receivables 2024 below.

- a. Payment in full within 15 days of receipt of this communication:
 - i. Deduct 25% of the total statement amount when remitting by cash or check.
 - ii. Deduct 22% if paying by credit card.
- b. Payment in full within 30 days of receipt of this communication:
 - i. Deduct 15% of the total statement amount when remitting by cash or check.
 - ii. Deduct 12% if paying by credit card.
- c. Payment in full within 60 days of receipt of this communication:
 - i. Deduct 10% of the total statement amount when remitting by cash or check.
 - ii. Deduct 7% if paying by credit card.

- d. Delinquent Statements greater than \$500.00:
 - i. The District may set up a payment plan with the delinquent account as follows:
 - 1. Owing \$500-\$1200: Twelve equal monthly payments.
 - 2. Owing \$1201-\$2400: Twenty-Four equal monthly payments.
 - 3. Owing more than \$2401: Thirty-Six equal monthly payments.

The discount policy was setup by the board as a **onetime incentive** to retire delinquent amounts due, a way to motivate those that are in arears to pay their outstanding PVID bill. The discount part of the policy was a perk to try to get people to pay but created a short fall for the PVID budget which affects the operation of PVID.

All board members in attendance for this meeting are in agreement of removing the discount policy payment, removing discount incentives items #4 a,b,c and keeping item #4 (d) Payment Plan for delinquent\overdue statements.

PVID Policy for Adoption for the Collection of Outstanding Receivables will be reviewed at a later time by the Board.

PVID Office\PVID District Manager should be able to collect monies without any delays, snags or interruptions. Only if a matter regarding the collection is in question by the PVID Office\PVID District Manager, they can bring it to the board for review but should not cause any delays in collecting.

Mike Lujan made a motion to remove/rescind Section #4 a,b and c, discount policy but keep payment plan. Second: Gabriel Ortiz, Motion carried 4-0 Approved.

- **e.** Update on rules and regs re-write: Grace Beckly gave an update of the status of Rules and Regs, working with Dave, making amendment A more condense and making it readable, eliminating certain parts, going well, still in the works, working document.
- **f.** Discussion about the limit of allowable past due receivables: It was an audit, not sure where the 800 dollar amount came from, thinking it is a non issue.
- g. Continued discussion regarding SF County obligation to PVID regarding the registry of properties within the district. Ralph: Dave should give us an update. Carlos: Table this until we have a chance to talk to the chairman. Rob: this is going to be a multi-year project, there should be no reason County can't take this on, however data is lacking regards to water rights attached to physical addresses.
- **h.** Update on current SJCP allocation and depletion. See what happens, snow pack is low, hoping we get precipitation, lean into a 2 week schedule for now but will need to reduce to a 3 week depending on the weather. This is going to be a tough year. Play it by ear and see what happens.

- **6. Treasurer's Report** commend Ralph and Cathy and the previous board for succeeding in making very large collections and really coming very close to where we need to be.
 - a. Current Status of Budget Budgets are a yearly thing rather than a quarterly thing, these are 3rd quarter budget numbers. BIA came in with a check which is a positive, Pueblo and non-Pueblo is essentially up-to-date with their bills or close to it, by the end of the year we should be at a higher state. Fish and Wildlife will be reconciled in June. If you look at total revenue is 19% higher, 56,000 dollars higher/over revenue expected. Cost of goods sold, over budget for O&M and are on track. Actively managing the dam for use. Under for expenses and over for revenues. It is a long term responsibility of managing the dam, follow BOR recommendations on having a contingency budget and putting money into savings. Over all we are up 56,000 in revenue, 76,000 in the black the difference is 20,000 dollars under expended, we are in pretty good shape to move into savings. PERA has been corrected. These are third quarter budget numbers, need to be conservative with high ticket items that might come up. Kudos to Mikes work with the Pueblo and the dam and for his lobbying work with the federal side of things.
