

Terms of Use for Pedro Scorekeeper

Effective Date: 4/10/26

These Terms of Use (“Terms”) govern your use of the Pedro Scorekeeper mobile application (the “App”) provided by Pedro Scorekeeper (“we,” “our,” or “us”). By downloading, accessing, or using the App, you agree to be bound by these Terms.

1. Use of the App

Pedro Scorekeeper is a card game scoring application intended for personal, non-commercial use. You agree to use the App only for lawful purposes and in accordance with these Terms.

You agree not to:

- Use the App in any way that violates applicable laws or regulations
- Attempt to interfere with or disrupt the App’s functionality
- Reverse engineer, decompile, or attempt to extract the source code of the App

2. No Account Required

The App does not require account registration. All functionality is available without submitting personal information.

3. Subscriptions and Payments

- Certain features of the App may require a paid subscription.
- All subscriptions are processed and managed through the Apple App Store.
- Payment will be charged to your Apple ID account at confirmation of purchase.
- Subscriptions automatically renew unless canceled at least 24 hours before the end of the current billing period.
- You can manage or cancel subscriptions through your Apple App Store account settings.
- After the 3 day free trial - the annual subscription of \$4.99 will be charged.
- The annual subscription will auto renew each 365 days.

We do not have access to your payment information or billing details.

4. Data and Storage

- All data entered into the App is stored locally on your device.
- We do not store, transmit, or have access to your data.
- You are responsible for maintaining any backups of your data.

5. Intellectual Property

All rights, title, and interest in and to the App, including its design, features, and content, are owned by Pedro Scorekeeper and are protected by applicable intellectual property laws.

You are granted a limited, non-exclusive, non-transferable, revocable license to use the App for personal use only.

6. Disclaimer of Warranties

The App is provided “as is” and “as available” without warranties of any kind, either express or implied.

We do not guarantee that:

- The App will be error-free or uninterrupted
- The App will meet your specific requirements
- Any defects will be corrected

7. Limitation of Liability
