The following are Host Requirements:

- The hosting Club must contact and work with the BKCP Representative in order to go over the details of the show to ensure a well ran and promoted show.
- Judge's and Representative's travel arrangements and accommodations must be secured with BKCP no less than 14 (calendar days) before the event.
- Hosting Club will provide adequate staffing to assist BKCP Representatives to conduct a smooth flowing show.
- Host Club must provide the Judges and Representatives with the proper tools to perform their duties. This covers anything from show numbers, pens, water in the ring, wet wipes, towels, etc.
- Provide food, table and chairs for the BKCP Judge(s) and Representatives.
- Require participants to register to AKCUPI and BBCR in order to join the show and earn points.
- For Exotic Bully show, banners/ads must clearly indicate that "BBCR does not sanction Exotic Bully".
- Place large and visible logos of BKCP, AKCUPI & BBCR anywhere in all banners, ads, posters, etc.
- No ads are to be released until this application is complete and fees are fully paid.
- Not adhering to these Terms and Conditions would be cause for a fine and ONE year Club hosting suspension and could result in permanent loss of hosting abilities.
