# Assignment experience

# August 2021 to June 2022 - Skandia

#### Project Manager within the Next Program

Next is a large transformation program within the insurance part of Skandia where one of the targets is to move all (?) insurances to a new system, Lumera. A Program organization was established containing both administrative roles and so called cross functional streams. The latter's objective was to coordinate the vast number of parallel Epics in areas like Test, Requirements, Supporting processes, Maintenance handover, etcetera.

#### Individual Contribution:

Mats was the project manager for the cross functional stream "Infrastructure&Environments", which objective was to establish and maintain the necessary Lumera development and test environments that the different Epics required. Given that there were three to four different versions of Lumera in use in parallel, running in more than 20 different Lumera instances, and that updated versions were received monthly, the assignment transformed over time into a Configuration Manager role. Mats had ongoing dialogues with Epic Owners and their test teams, with the Tech teams managing installations, and with Lumera.

# September 2020 to June 2021 - Klarna

#### Project Manager for the technical stream of establishing Klarna in a new country

Klarna has decided to expand part of the business into a new country, which has a higher risk level than normal. Mats led the so-called Tech Stream with the responsibility of providing the technical prerequisites for a productivity solution in the new country. The approach was to first provide a short-term solution enabling Business Travelers going there and start working with short notice, and in parallel build a long-term solution for when the legal entity had been established. Many risk workshops were performed where not only technical risks were evaluated but also business, information security, legal and privacy related risks.

#### Individual Contribution:

Mats was the project manager coordinating all the different involved stakeholders throughout the process. This included working towards the business, Information Security and Privacy Legal to align the different requirements, and then work with the different tech teams to build a matching solution. The latter resulted in technical solutions related to the clients (computers/smartphones), applications, monitoring, IAM, Network etcetera. Mats worked closely with Information Security in evaluating the country's specific cyber security laws and with Privacy Legal to evaluate necessary measures when transferring personal data to and from the country in question.

# June 2018 to October 2020 - Swedavia

#### Program and Project Manager for the IT Workplace 2.0 Program

Overall responsible for the IT Workplace 2.0 program. The program originally consisted of four projects. One was called the Client Upgrade Project and included upgrading the IT workplace platform from Windows 7 and Office 2010 to Windows 10 and Office 365 ProPlus. The other three projects were aiming to implement different Office 365 services. The services and projects in question were; Skype Online, OneDrive/SharePoint Online, and Exchange Online. The last one was however postponed top further notice due to the Corona situation. Instead a new project was started with the target to replace the existing Mobile Management solution, based on Citrix, to Microsoft Intune. Mats was appointed Swedavia's project manager also for this project.

#### Individual Contribution:

Mats was Swedavia's Project Manager for all the projects within the program, and thereby the counterparty to the different project managers from the outsourcing partner delivering the projects. Mats was also deeply involved many technical/architectural questions as well as the legal and compliance related assessment that was required to get the approval from Swedavia's top management to start using these cloud services.

Intense communication every day with the other sub project managers and the developers, as well as with the software vendor (Murex). Highly involved in the choice and implementation of the scheduler tool, which still is in use for the running the End of Days in both test and production.
