### 2. Hazards Identification

*Emergency overview: Warning. Can cause irritation to eyes, skin and throat.*

### 4. First Aid Measures

**EYES:** Immediately flush eyes with a directed stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Washing eyes within several seconds is essential to achieve maximum effectiveness. Get medical attention immediately.

Wear alkaline-resistant suit and complete protective equipment; rubber gloves, rubber boots, and chemical goggles. Use a non-combustible material like vermiculite, sand, or earth to soak up the product and place material in sealable waste containers for disposal.
