# AGENCY GUIDELINES

To ensure the smooth running of the Agency, we would like to explain how the ST Management Ltd operation is run, as well as some actions we require from you.

## **Representation:**

ST Management Ltd (us, we, our) will represent you for all areas of performance work sourced by us unless previously agreed. We, as an agency, take a commission on all paid work sourced by us. If you don't have a voice-over agent, we will happily submit you for any voice work that may come in, so please ensure you have your voice clips available on Spotlight.

#### Paid Work:

All castings for paid work sourced by us must be referred to and dealt with by us.

Unpaid work may be undertaken at your discretion but in consultation with us and your time must be fully booked out with us.

#### Availability and Booking Out Procedure:

We need all our actors always to ensure they book out all dates they are unavailable for work in advance. Anything that may potentially stop you attending a casting/filming/rehearsal etc. must always be booked out in advance. We ask you to do this via e-mail with the dates for which you would like to be booked out.

If we repeatedly cancel any castings, rehearsals or filming etc. due to you not booking out with us, we cannot guarantee we shall continue to represent you as it damages the Agency's reputation for everyone. So please ensure you always book out with us.



#### **Attending Castings:**

When an audition or casting is booked for you, you will be sent the necessary information, including the current dates of filming/rehearsals/recalls etc. It is your responsibility to ensure you are still 100% free for all these dates and if you are not, you must inform us BEFORE you attend the casting - not during or after. We can then inform the casting director immediately and not waste their time.

Our agency contact details must be added as your point of contact to all forms filled in at castings.

#### **Photos and Showreels:**

All clients, as a condition of representation by us, must have up-to-date professional acting headshots and a current showreel available on Spotlight. Showreels are now an essential part of the marketing tools we use to get you seen by casting directors, so they are a standard requirement for all our clients. Please ensure you have these, and if you need any guidance on photographers or showreel providers, we would be happy to advise you. Without a showreel, your job submissions may be limited to stage work only.

#### **Client Information Forms:**

We will be sending you a client information form to fill in shortly. Please fully complete the form and send it back to us as soon as possible.

#### **Termination**

You can terminate this contract at any time, giving 30 days' notice of your intention to leave. However, you can be released from your contract earlier by mutual agreement with the management. If at any time you do not adhere to these terms and conditions, we reserve the right to terminate your contract by giving you 30 days' notice, unless you request to be released sooner. If/when you leave, we will provide a full submissions tracker, in case there is a job in the pipeline which needs to be invoiced after you have left us.

#### <u>General</u>

You can contact the Agency on the mobile number during normal working hours, or via e-mail at any time.

We encourage all clients to be proactive in promoting themselves as Actors; this includes maintaining your Spotlight page, keeping showreels current, investing in good photos, attending classes and actively seeking work and opportunities.
