

Virginia Taxidermist Association Rules for Competition

- 1. The VTA, its officers and/or Board of Directors shall not be responsible for damage, theft, accidents, etc to any mounts entered in the competition, under any circumstances, or for the bodily injury or accident of any person involved in or viewing the competition. Anyone feeling the need for insurance on their entries shall purchase such through their local insurance agent.
- 2. All members entering mounts in competition will be required to fill in the mount declaration and sign this form stating that they have read, understand and obeyed all competition rules.
- Entrant must be a member in good standing of the VTA, or a reciprocal association of the VTA before entering VTA competition. Each entrant must also be registered for the convention.
- 4. Protected species will not be allowed in the VTA competition without proper permits and/or documents with specimen.
- 5. The Competition Committee reserves the right to restrict viewing of any entry deemed inappropriate or detrimental to the image of fishing, hunting, and/or taxidermy. All such entries will be judged privately.
- 6. The judges will make the FINAL decision on how mounts place in competition. If the entrant wishes to challenge a judges decision, the challenger/entrant must pay a \$25.00 challenge fee to the VTA. At this time, the next most qualified person in attendance, as picked by the VTA officers, will re-judge the mount in private, with no knowledge of the previous score. The second judging will be final.
- Only the competition Committee can be in the competition room with the judges while judging is in progress.
- 8. Soliciting by suppliers or members in the competition area will be prohibited.

- 9. Members in the competition area during public viewing are encouraged to wear VTA apparel and their name badge.
- 10. Entries may be entered by individuals, shop employees or as a collective group. If assistance is given by shop employees or the mount was a collective effort by more than one person, the mount must be entered under the name of the studio or everyone's name that assisted. Individual entries must be mounted entirely by the person entering it, with no assistance from anyone in any way. If reasonable proof is established that this rule has been violate, the person is question may be required to mount the same type of specimen entered in competition for a panel of the Board of Directors and Officers.
- 11. No mount or part of any mount can be entered in competition that has been judged in a previous Virginia competition.
- 12. Entries in cases must have a removable top and sides. Cases must be removed by the entrant before judging.
- 13. If a combination mount is presented at registration and multiple pieces are paid for and entered separately, they will be scored and awarded accordingly.
- 14. Any member found violating competition rule will be subject to the lose of any and all awards. No refunds of any kind will be made.
- 15. To be eligible for Judges Choice Best in Category or any of the other major awards (Wasco, Breakthrough, etc) a mount must score 90 points or better.
- 16. If a mount has received a blue ribbon at any other state competition or higher, the person receiving the award must move up to the next higher division in that category at the VTA competition.
- 17. To be eligible for the Best All Around Taxidermist of the VTA, you must enter a total of four mounts, all in different categories (Gamehead, mammal, bird, fish or reptile), either all 4 in professional for best all around professional or all four in masters for best all around masters. There is a minimum combined score of 320 before award will be given out.
- 18. An entrant may enter a piece solely for People's Choice competition. It will not be judged by the judges, nor will it be eligible for any of the judge's awards.
- 19. An entrant may remain at the Amateur level of competition until he/she receives a blue ribbon in that category. He may choose to move up to the Professional level prior to that, but once moved up, he/she may not move back to the Amateur level. An entrant may remain at the Professional level of competition until he/she has received two blue ribbon in that category of competition. He/she may choose to move up to the Master level prior to that, but once moved up he/she may not move back to the Professional level.
- 20. Any infraction of any VTA rules will result in disqualification of the entry and forfeiture of any awards and/or monies won by that entry. Registration and entry fees will not be refunded.

AWARDS

Please note that all awards and criteria are subject to change.

- **Breakthrough Award** Plaque and a \$100.00 merchandise gift certificate for Breakthrough. The judge's Choice Best of Show Award should be selected by all judges, by mutual agreement, from any of the first place entries in the competition. Any entry not earning a first place is not eligible.
- Wasco Award Award and a \$100.00 of merchandise gift certificate for WASCO. The most artistic entry chosen by all judges.
- **Polytranspar Award** Engraved plaque and a \$50.00 merchandise gift certificate for WASCO. Best use of Polytranspar paint.
- **Competitor's Challenge Award** Cash based on entries in Professional and Masters Divisions you may enter any three mounts in any category (they can be the same category) There is a Professional and Masters division. The judges will choose the winner. It is not based on scores.
- The McKenzie Taxidermy Supply Distinguished Service Award A plaque of recognition and a \$100.00 merchandise gift certificate from McKenzie. Any member, in good standing with their state association, who has done the most during the past year to promote professionalism in his/her business, advance the art of taxidermy, depict taxidermy and hunting in a positive image, share knowledge of taxidermy techniques, improve the quality of his/her taxidermy work, promote the goals of the state association. Chosen by the board members of the association.
- **People's Choice Best of Category** Deer head, Game heads, Small game life size, Big Game life size, Birds, Fish, Reptiles, Habitat, Wildlife Art. Voted by the people through special ballot.
- Judges Choice Best of Category Master and Professional Division Deer head, Game Heads, Small game life size, Big game life size, Birds, Fish, Reptiles, Habitat. The judges will choose the winner. It is not based on score.
- Chris Barhnardt Memorial Award Masters Division. Highest scoring small mammal.
- Al Holmes Award Best habitat mount in the competition. The Habitat judge will choose the winner. It is not based on score.
- **Calloway Custom Woodworks** Most artistic mount award and \$50.00 merchandise gift certificate. Judge will choose the winner that is on a Calloway base.
- **Virginia Department of Game and Inland Fisheries** Best native species. The judge will choose the winner. It is not based on score.
- **Les Harper Award** Best bear mount in the competition. The judge will choose the winner. It is not based on score.
- **The Virginia Deer Hunter Association** Best deer mount in the competition. The judge will choose the winner. It is not based on score.
- **Research Mannikins** Amateur Division. The judge will choose the winner. It is not based on score.

- **Best Commercial** Best commercial mount in the competition.
- Best All Around Professional Best Professional mount in the competition. Based on score.
- Best All Around Masters Best Masters mount in the competition. Based on score.
- People's Choice Best of Show Highest votes from the people's choice voting.
- Judges Choice Best of Show The judges choose the winner. It is not based on score.
- Service to Virginia Taxidermists Association Award Voted on by the board.
- **Kenneth Denzler Memorial Award** Sponsored by Rick Denzler and awarded to the best amateur mount at the competition. Rick Denzler chooses the winner. Not based on score.
- The National Wild Turkey Federation Award Awarded to the best turkey mount in the competition.
- **Starfish Award** Awarded to the best reproduction fish at the competition.
- Jason Jenkins Award Best Professional small mammal based on score.
- **Kip Hughes Award** Best large mammal in Masters Division. Based on score.
- Pro-1 Use of Pro-1 chemicals. Awarded by Paul Cales.
- **Ducks Unlimited** Awarded to the best duck.
- Second to Nature Mounted on Second to Nature form.
- Van Dyke Most original entry.
- Hog Wild Best hog in the show.
- Artisan Award Voted on by the people.
- Mounted in Alaska Award Best entry that tells a story. Judges decide.
- Horizon Award Awarded to the best youth mount in the competition. It is based on score.
- President's Award Chosen by the president, not based on score.
- **Golden Example Award** Artist must be at least age 60 on date of competition and competition must have been completely developed not more than one year before date of judging. The judge will choose the winner. It is not based on score.

Virginia Department of Game and Inland Fisheries News

As many of you know, the DGIF recently sent out a form for recordkeeping that they would like all taxidermists to use. As you also know, this did not find favor with many taxidermists in our organization. The VTA organization felt that the DGIF overlooked a valuable resource in designing this form and that we, as an organization, should have had input during the design. The VTA then requested a meeting with DGIF to clarify some issues and try to improve the relationship between our organizations.

The following page is a copy of what was presented to DGIF at the meeting that took place on October 7, 2017. It was prepared by Rick Denzler.

We will keep the membership informed of what, if anything, results from this meeting.

"On behalf of the VTA membership we hope to start a positive relationship with the DGIF and thank you for your time today! It is some issues and questions, cares and concerns we would like a better understanding on. Of course we do not expect you to have the answers to all our questions. Ken and I alone have over 50 years in the taxidermy business. Our goal is to offer some suggestions to help direct our newer taxidermists and offer our advice, opinions, and experiences to the DGIF.

Permit Conditions:

Selling of unclaimed mounts:

Bears and Turkeys: suggestion, is it possible for taxidermists to get an exception to this by specific documentation provided on case by case approval from DGIF?

Fur-bearers: Is Fur Dealers Permit necessary for replacement hides or gifts?

Records: Requires must maintain records for 3 years, often display mounts, unclaimed antlers, specimens, and personal mounts are older than this.

Log Book:

While the new suggested log book/invoice was an attempt at uniformity, this is an area where the VTA could have been of assistance to DGIF.

- * It seems conformation numbers are the wave of the future with phone check ins.
- * The taxidermists charges and such are not relevant to the log book.
- * Some taxidermists use their invoice as Log Book.
- * From bagging, tagging, numbering, marking hides sent to tanneries, it is no stand fast rules.
- * We would like to help develop a handbook of rules for the Taxidermist.
- * If possible we would like to help the DGIF by hands on instruction taxidermists with questions. Please refer any New applicants or 'confused taxidermist' to the VTA website or officer. We will try to assist in following regulations.

Problem Resolutions:

- * Some taxidermists feel insulted by the approach of some DGIF officers. I know I speak for most in saying I would not jeopardize my livelihood and reputation by messing with illegal stuff. We also understand the DGIF have a job to do.
- * Hopefully we can better train our people and clarify some of these issues and topics."
